MAY 17: THE HEADS OF MINISTRIES FOR EMERGENCY SITUATIONS OF THE REPUBLIC OF KAZAKHSTAN AND THE KYRGYZ REPUBLIC SIGNED AN AGREEMENT BETWEEN THE GOVERNMENT OF THE REPUBLIC OF KAZAKHSTAN AND THE GOVERNMENT OF THE KYRGYZ REPUBLIC ON THE ESTABLISHMENT OF THE CENTER.

JANUARY 16: THE FIRST MEETING OF THE COUNCIL OF THE CENTER WAS HELD IN ALMATY. THE COUNCIL OF THE CENTER MADE THE FOLLOWING MAJOR DECISIONS:

- APPROVED THE STRUCTURE OF THE CENTER.
- APPROVED CANDIDATES FOR APPOINTMENT TO THE POSITION OF DIRECTOR OF THE CENTER AND DEPUTY DIRECTOR OF THE CENTER.



MARCH 3: The second meeting of the Council of the Center was held in Bishkek.

The Council of the Center made the following major decisions:

- Petrov V.V. was appointed to the position of the Director of the Center.
- Ukashev D.I. was appointed to the position of the Deputy Director of the Center.
- The staff list of the Center was approved.



2016 year

JULY 11-14: The Center's delegation took part in the meeting of the Regional Platform for Central Asia and the South Caucasus on DRR for the implementation of the Sendai Framework for Disaster Risk Reduction 2015-2030, held in Dushanbe, Tajikistan.

During the event, working meetings were held with the Special Representative of the UN Secretary-General for Disaster Risk Reduction, Mr. Robert Glasser, and the Chairman of the CoES under the Government of the Republic of Tajikistan, Mr. Rustam Nazarzoda.

The parties reached an agreement on interaction and cooperation in the framework of the implementation of programs and projects in the field of DRR and emergency situations.



AUGUST: Mr. Armen Grigoryan, Head of the Cluster on Emergency Situations and Climate Change of the UNDP Regional Office for Europe and the CIS in Istanbul, Turkey, visited the Center.

The parties reached an agreement on interaction and cooperation in the framework of the implementation of programs and projects in the field of DRR and emergency situations.

SEPTEMBER 14: The third meeting of the Council of the Center was held in Almaty. The Council of the Center made the following major decisions:

- The Islamic Republic of Afghanistan has been granted observer status at the Centre.
- Approved the symbols of the Center.



2016 year

14 SEPTEMBER: The official opening ceremony of the Center took place.



This solemn event was held with the participation of more than 70 heads and representatives of authorized bodies in the field of emergency situations of the Republic of Kazakhstan and the Kyrgyz Republic, the Almaty city administration, heads and representatives of diplomatic missions, UN agencies, international and non-governmental organizations, scientific institutions.



20-22 SEPTEMBER: The Center, together with ESCAP, conducted:

- Regional Workshop on “Sustainable Information and Communication Technology (ICT) Connectivity for Building a Knowledge-Based Economy and Achieving the Sustainable Development Goals and the Goals of the World Summit on the Information Society”, and held
- Eighth session of the thematic working group of the UN Special Program for the Economies of Central Asia on Economic Development, organized by the Subregional Office for North and Central Asia of the UN Economic and Social Commission for Asia and the Pacific.

This event was attended by representatives of Kazakhstan, Kyrgyzstan, Russia, Azerbaijan, Armenia, Belarus, Pakistan, as well as regional offices of UN agencies, the Asian Disaster Preparedness Center (Bangkok), universities and scientific organizations.



OCTOBER 15: The Center held a working meeting with deputies of the Committee on International Relations, Defense and Security of the Senate of the Parliament of the Republic of Kazakhstan, headed by the Chairman of the Committee, Ms. Nazarbayeva D.N.

OCTOBER 24: The Center, together with the UNDRR Regional Office, held an expanded wide-format meeting dedicated to the International Day for Disaster Risk Reduction on the theme “Live to Tell”.



This large-format Meeting, held with the participation of more than 60 representatives of state bodies and scientific institutions of Kazakhstan, international and non-governmental organizations, was aimed at:

- Sharing best practices, current initiatives and perspectives on disaster mortality reduction, with a particular focus on the Central Asia and South Caucasus region.
- Consolidation of efforts of all stakeholders in the field of disaster risk reduction through the implementation of effective measures to increase the awareness of all segments of the population about the danger of the existing risk of disasters, in all its dimensions.
- solution of problematic issues in the implementation of the transition from the practice of response to the practice of disaster risk reduction, early warning and strengthening of resilience up to the prevention of some part of emergencies.

2016 year

NOVEMBER 2-5: in New Delhi, India, a delegation of the Center took part in the Asian Ministerial Conference on DRR.

During this conference, the delegation of the Center held official and working meetings with:

NOVEMBER 22: The Centre, jointly by the Regional Office for the Coordination of Humanitarian Affairs (OCHA) for the Caucasus, Central Asia and Ukraine, the Sub-Regional Office for Central Asia of the United Nations Environment Program (UNEP) organized and conducted a Regional Workshop on Environmental and Technological Risks .



NOVEMBER 23: Center, in order to improve an integrated approach to the prevention, mitigation of risk factors for emergencies, identification, assessment and monitoring of the danger of emergencies, their forecasting, assistance in the implementation in the states of the Parties of international monitoring systems and networks for natural, man-made, environmental, climatic and other types of threats and potential emergencies, jointly with the Regional Center of the Regional Bureau for Europe and the CIS of UNDP in Istanbul, organized and conducted a Regional Training on Disaster Risk Assessment.

NOVEMBER 24: The Centre, jointly with the UNDP Regional Office for Europe and the CIS Regional Center in Istanbul, organized and conducted a Regional Training on Gender Equality in DRR and their relationship with disaster management activities.



DECEMBER 8: The Center, together with UNDP in the Republic of Kazakhstan, the Akimat of the Almaty region, the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan, held an expanded meeting on the joint implementation of the project "Strengthening the resilience of communities to negative external impacts and improving the efficiency of flood risk management in the Almaty region."



2016 YEAR – MAIN RESULTS OF THE CENTER

The Center reached agreements on interaction and cooperation in the field of DRR and emergency situations ESCAP, UNICEF, UNISDR, UNDP, IOM, UN OCHA, UNEP, UN Women, the Asian Center for Disaster Reduction in Kobe, Japan, the Asian Center for Disaster Preparedness in Bangkok, Thailand, Humanitarian Aid and Civil Protection Department of the European Commission, IFRC and KP.

- The Center, by attracting investments in the form of grant funds from donor agencies and international organizations, as an executing agency, has implemented or is currently implementing the following projects in the field of strengthening regional cooperation, disaster risk reduction and emergency prevention:

- 1) UNDP project in the Kyrgyz Republic “Strengthening the capacity of integrated risk management in the Kyrgyz Republic and regional cooperation in Central Asia”. Implementation period: 2016-2020;

- 2) Component of the project of the UN OCHA regional office on the collection, compilation and analysis of data on Kazakhstan and Kyrgyzstan related to climate change, radioactive contamination of territories, production and radioactive waste. Implementation period: 2016.

- The Center, together with the Ministry of Internal Affairs of the Republic of Kazakhstan and the Ministry of Emergency Situations of the Kyrgyz Republic, has given a number of organizational and practical measures, as a result of which, based on the official statement of the competent authorities of the Islamic Republic of Afghanistan, this state, by the Decision of the third meeting of the Council of the Center dated September 14, 2016, was granted observer status at the Centre.

- The Center, together with international and non-governmental organizations, scientific institutions, with their technical and financial support, prepared and held 8 international events (conferences, forums, seminars, trainings, meetings, meetings ...) in the field of disaster risk reduction and emergency situations.

259 people took part in these events, exchanged experience, gained new knowledge, improved their skills in the field of disaster risk reduction and emergency situations, including:

- o 89 representatives of state bodies of the Republic of Kazakhstan.

- o 36 representatives of state bodies of the Kyrgyz Republic.

- o 23 representatives of state bodies of the Central Asian countries and other states.

- o 34 representatives of scientific institutions and independent experts.

- o 77 representatives of international and non-governmental organizations.

- 3 meetings of the Council of the Center were held.

- Implemented measures to ensure the gradual institutional development and capacity building of the Center.



2017 year

JANUARY 17: The Center, together with the IFRC and the RK RCSC, held a regional seminar: "Legal Aspects of Disaster Management and Disaster Risk Reduction in Central Asia" Meeting of National Societies on Supporting Role and Promotion of Legislative Initiatives.

JANUARY 18: The Center, together with the International Federation of Red Cross and Red Crescent Societies (IFRC and RC), organized and held an international Conference on improving the legal environment in the field of disaster management and response, as well as developing legal regulation of combat in the region disaster management and disaster risk reduction.



JANUARY 27: The fourth meeting of the Council of the Center was held at the Center.

The Council of the Center made the following major decisions:

- Approved the Center's proposals to expand the membership of the Centre's member states.
- Approved the Strategic Directions for the Centre's activities.



FEBRUARY 15: The Center, together with the International Federation of the Red Cross and Red Crescent, the Red Crescent Society of Kazakhstan, the Ministry of Foreign Affairs of the Republic of Kazakhstan, the Health Department of Almaty, the Emergency Department of Almaty, scientific institutions held a meeting of the working group to discuss the Law "On the Red Crescent Society of the Republic Kazakhstan".

2017 year

MARCH 2: The Center and the United Nations Children's Fund (UNICEF) signed a Memorandum of Understanding and Cooperation in the field of DRR and disasters, taking into account the interests of children.



MARCH 6-7: The Center, together with CADRI in Europe and the CIS countries, conducted a workshop on capacity building for DRR in the Central Asian region.

MARCH 13-15: The Center, together with the UN Population Fund in Kazakhstan, organized and conducted a technical workshop on the development of a minimum set of initial reproductive health measures in a humanitarian crisis.



2017 year

MARCH 15: The Center and the Asian Disaster Preparedness Center in Bangkok, Thailand signed a Memorandum of Understanding and Cooperation in the field of DRR and Emergencies.



MARCH 23: The Center in Bishkek held a working meeting with representatives of scientific institutions and higher educational institutions of Kyrgyzstan to discuss the main areas of interaction and cooperation in the field of DRR, prevention and elimination of emergency situations.

MARCH 23-24: The Center participated in the Istanbul Development Dialogue Forum in Istanbul, Turkey, where he made a presentation on the impact of disasters, their consequences and the general situation in the countries of Central Asia.

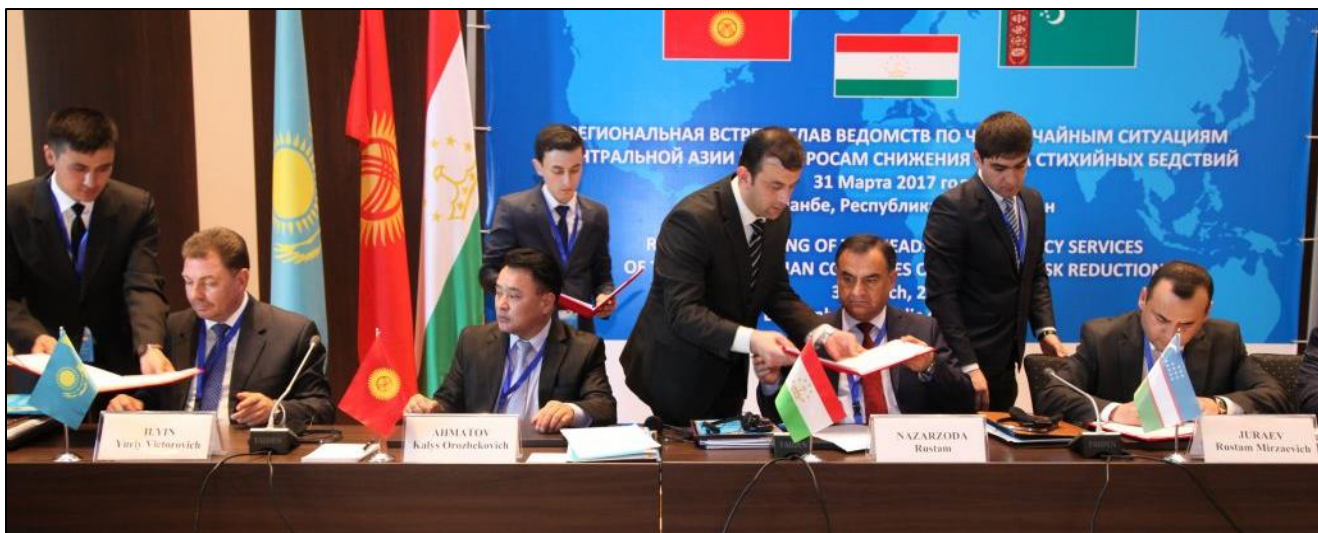

2017 year

MARCH 31: Center in Dushanbe, Tajikistan, took part in the work of the Regional meeting of the Heads of Emergency Authorities of Central Asia countries (Republic of Kazakhstan, Kyrgyz Republic, Republic of Uzbekistan, Republic of Tajikistan) on strengthening regional cooperation in the field of DRR and emergency situations.



APRIL 20: The Center and the United Nations Children's Fund organized and hosted a national conference on disaster risk reduction for children.

MAY 2 - 6: Center officials attended the UNISDR/GETI Global Training and Development Institute training course in DRR Office in Incheon, South Korea.

MAY 2: The Center and the UNISDR/GETI Global Institute for Training and Development in Incheon, South Korea signed a Memorandum of Understanding and Cooperation in the field of DRR and agreed to jointly develop the capacity of national and local governments to implement the Sendai Framework for Disaster Risk Reduction for 2015-2030.



2017 year

MAY 15-16: Regional training seminar on the protection of migrants in emergency situations was held by the Center and the IOM Regional Office in Central Asia.

The workshop was aimed at raising the awareness of staff on emergency preparedness, providing specific information and practical recommendations on reducing the vulnerability of migrants through various measures and learning lessons.

Seminar participants from Afghanistan, Tajikistan, Uzbekistan, Turkey, Russia, Hungary, Kyrgyzstan, Kazakhstan, Germany are representatives of state bodies and international organizations.



23-26 MAY: The Center, together with the International Federation of the Red Cross and Red Crescent and the Spanish Red Cross, conducted a regional course on planning livelihood programs for the Red Cross and Red Crescent Societies in Central Asia.



2017 year

MAY 16-18: The Center, together with the All-Russian Center for Disaster Medicine "Protection" of the Ministry of Health of the Russian Federation, within the framework of the VIII General Assembly of the National Medical Association, hosted an international conference on the theme "Healthy children - a healthy future!".

MAY 18: The Center and the All-Russian Center for Disaster Medicine Zashchita of the Ministry of Health of the Russian Federation signed a Memorandum of Understanding and Cooperation in the field of DRR and Emergencies and reached an agreement on the implementation of measures to improve the professional level of medical workers, paramedics and volunteers.

MAY 22-26: The Center participated in the Global Platform for Disaster Risk Reduction organized by the Government of the United Mexican States and the United Nations Office for Disaster Risk Reduction



JUNE 16: Center and Kazakh National University. Al-Farabi signed a Memorandum of Understanding and Cooperation in the field of DRR and emergency situations.

JUNE 21: The Center presented a report on the activities of the Center at the Parliamentary Hearings organized by the Committee on Foreign Relations, Defense and Security of the Senate of the Parliament.



2017 year

JULY 10-12: The Center, together with OCHA, with the participation of representatives of state bodies of the countries of Central Asia, the South Caucasus, Russia, international and non-governmental organizations, conducted a Regional training: "Training of UN country coordinators, actions to ensure coordination between UN structures and government structures".

JULY 12-14: The Center in Dushanbe took part in the work of the Regional DRR Platform for the implementation of the Sendai Framework for Disaster Risk Reduction 2015-2030 in the Central Asia and South Caucasus region.

On the basis of the final document of the Regional Platform for DRR - Dushanbe Declaration on DRR to build disaster resilience capacity, the Center was delegated the status of a resource center for the implementation of priority areas of activity of the Sendai Framework for DRR for 2015-2030 in the region of Central Asia and the South Caucasus.

AUGUST 2: The Center together with the Ministry of Foreign Affairs of the Republic of Kazakhstan, the Ministry of Foreign Affairs of the Kyrgyz Republic, the Ministry of Emergency Situations of the Kyrgyz Republic and the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan held a meeting of the Working Group to develop a draft Protocol on amendments and additions to the Agreement on the establishment of the Center dated May 17, 2013.

AUGUST 3-4: A meeting of the Working Group of the Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries was held within the framework of the Dialogue "Central Asia plus Japan", which resulted in the adoption of the final document - the Protocol.



22-25 AUGUST: The Center, together with the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan, the Institute of Geography of the Republic of Kazakhstan, the Akimat of Almaty, KazNU named after Al-Farabi, - RSE "Kazhydromet", LLP "Kazinzhennergoproekt", Moscow State University named after M.V. Lomonosov, GU "Kazselezashchita", UNESCO, an international conference was held: "Mudflow safety: assessment, forecast, protection".

SEPTEMBER 18-22: The Center, together with the Ministry of Internal Affairs of the Republic of Kazakhstan, the Deutsche Post DHL Group and the United Nations Development Program (UNDP) held a five-day training in the Academy of Civil Aviation in Almaty for training and assessing emergency preparedness for Almaty International Airport.

SEPTEMBER 25: The Center, together with ESCAP, with the participation of representatives of state bodies of the countries of Central Asia, the South Caucasus, Russia, international and non-governmental organizations, held a Regional seminar on the topic: "Presentation of the report on disasters in the Asia-Pacific region in 2017".

SEPTEMBER 26: The Center, together with the FAO, "NCPC "Orleu", the Republican Institute for Advanced Training of Managers and Scientific and Pedagogical Personnel of the Education System of the Republic of Kazakhstan, held a training seminar on the topic "Disaster Risk Reduction in Secondary Education Organizations".

SEPTEMBER 27-29: The Center, together with UNISDR, held a final knowledge management workshop "Effective implementation of the Sendai Framework for Disaster Risk Reduction in the CASC region within the framework of the DIPECHO IX Program project.

OCTOBER 03: The Center, together with the Ministry of Internal Affairs of the Republic of Kazakhstan and UNDP of Kazakhstan, within the framework of the project: "Strengthening the resilience of communities to negative external impacts and improving the efficiency of flood risk management in the Almaty region", held a Republican seminar-training "Exchange of experience and best practices in risk management floods for a catalytic effect and increase the potential of regional departments of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan".

OCTOBER 6: The Center, together with UNISDR, celebrated the International Day for Disaster Risk Reduction.

OCTOBER 11: During a working visit to the Asian Center for Disaster Preparedness, Bangkok, Thailand, the Center signed a Memorandum of Understanding and Cooperation and Understanding in the field of DRR and Disaster with the Economic and Social Commission for Asia and the Pacific (ESCAP).

OCTOBER 19: The Center, together with the Red Cross and Red Crescent Society of Europe and Central Asia, held the Regional Forum on Disaster Risk Reduction - 2017 "Climate: responding to a global challenge."

OCTOBER 23-26: The Center, together with the United Nations Environment Program (UNEP) and the Regional Office for the Coordination of Humanitarian Affairs for the Caucasus, Central Asia and Ukraine (OCHA ROKCA), conducted two regional trainings:

2017 YEAR – MAIN RESULTS OF THE CENTER

- At the initiative of the Center, in March 2017 in Dushanbe, under the chairmanship of the Tajik side, with the technical and financial support of UNDP in the Kyrgyz Republic, a Regional Meeting of the Heads of Emergency Situations Agencies of the Central Asian countries on disaster risk reduction was organized and held as part of the Dialogue "Central Asia plus Japan".
- On July 14, 2017, on the basis of the final document of the Regional Platform for DRR-Dushanbe Declaration on DRR, the Center was delegated the status of a resource center for the implementation of priority areas of activity of the Sendai Framework for DRR for 2015-2030 in the region of Central Asia and the South Caucasus.
- At the initiative of the Center, in August 2017 in Almaty, under the chairmanship of the Kazakh side with the technical and financial support of international organizations, a meeting of the Working

Group (experts) of the Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries was organized and held.

- The Center has developed and is implementing the Strategic Directions for the Center's activities until 2030, approved by the Decision of the Council of the Center.

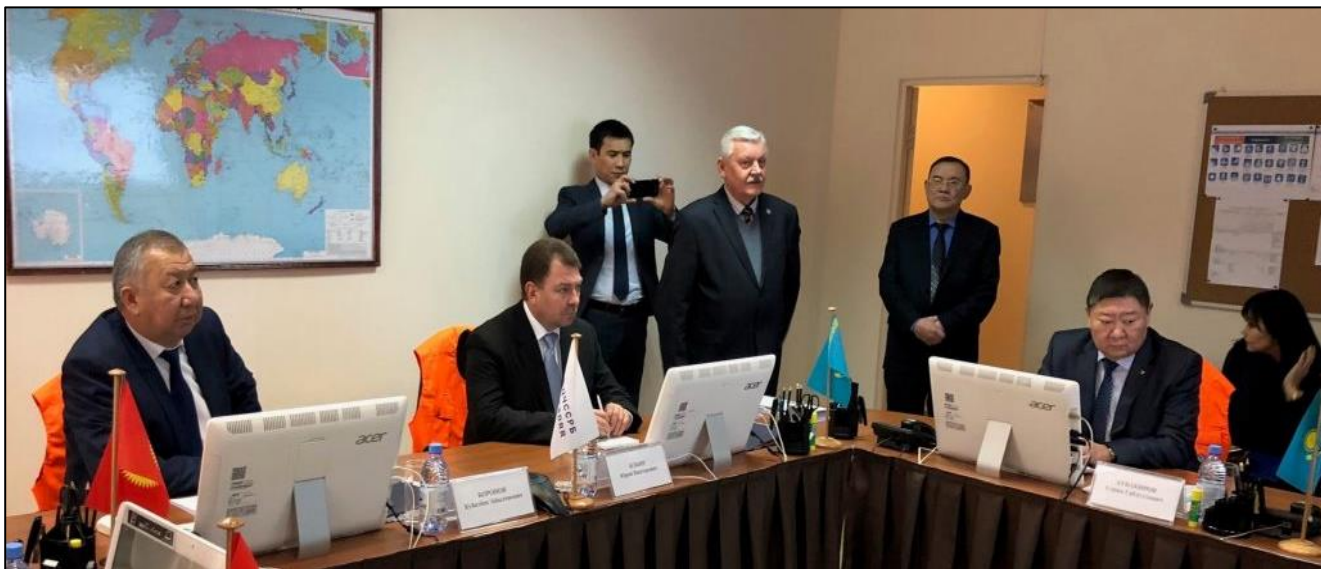

APRIL 17 - 19: Within the framework of the Finnish-Kyrgyz project FINKMET, the Center held a seminar with the participation of the hydrometeorological services of the countries of Central Asia on the topic: "Creating a joint approach to support the professional development of specialists in hydrometeorological services and the distance learning system in Central Asia."



APRIL 26: A meeting of the working group (experts) of the Regional Forum - Meeting of the heads of emergency departments of Central Asian countries was held as part of the dialogue "Central Asia plus Japan".



APRIL 27: The Center, with the technical support of the UNDP Istanbul Office, organized and held a Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries.

The heads of delegations and representatives of the emergency departments of the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan, Turkmenistan, the Republic of Uzbekistan - participants of the Regional Forum - Meeting of the heads of emergency departments of the countries of Central Asia, based on the signing of the Protocol, adopted the following main decisions:

In order to carry out further actions to develop and strengthen regional and international cooperation in the field of disaster risk reduction, prevention and elimination of emergency situations, especially large-scale and transboundary ones,

Approved:

1. Regulations on the Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries.
2. Framework for strengthening regional cooperation between the Central Asian countries in the field of disaster risk reduction, prevention and elimination of emergency situations.
3. Action plan for the implementation of the Framework for strengthening regional cooperation in the field of DRR, prevention and elimination of emergencies in the Central Asian countries for 2018-2020.
4. The concept of creating a "Regional Register of national and international specialists - experts in the field of seismic, environmental, fire, radiation, industrial, hydrogeological and other areas of safety."
5. The concept of creating a "Regional Scientific and Technical Council for Emergency Situations";
6. The concept of creating a "Regional Register of Forces and Means of the Central Asian Countries for the Purpose of Carrying Out Rescue Operations on Their Territory in the Event of Large-Scale and Cross-Border Emergencies."
7. Proposal to hold the next Regional Forum - the Meeting of the Emergency Departments of the Central Asian countries within the framework of the Dialogue "Central Asia plus Japan" in 2019 in the Kyrgyz Republic.

Agreed to further consider and inform the secretariat of the Regional Forum on the decision taken on:

JUNE 12 - 15: The Center held a round table with students of KazNU. Al-Farabi on the topic: "Central Asia: Modern threats and challenges of natural and man-made nature. Measures to reduce the risk of disasters, protect the population and territories from emergencies".



JUNE 19-20: at the Center, under the chairmanship of the Kazakh side, a staff training was held in preparation for the special tactical exercises "Rock - 2018" with units of the emergency departments of the CSTO member states allocated to the formations of the special forces of the Collective Rapid Reaction Forces (FSSN CRRF) CSTO. During the workshop, the participants explored the possibilities of using drones to prevent and reduce the risks of natural disasters. Companies supplying unmanned aerial vehicles spoke in detail about the cases in which drones could significantly facilitate the work of emergency response specialists.

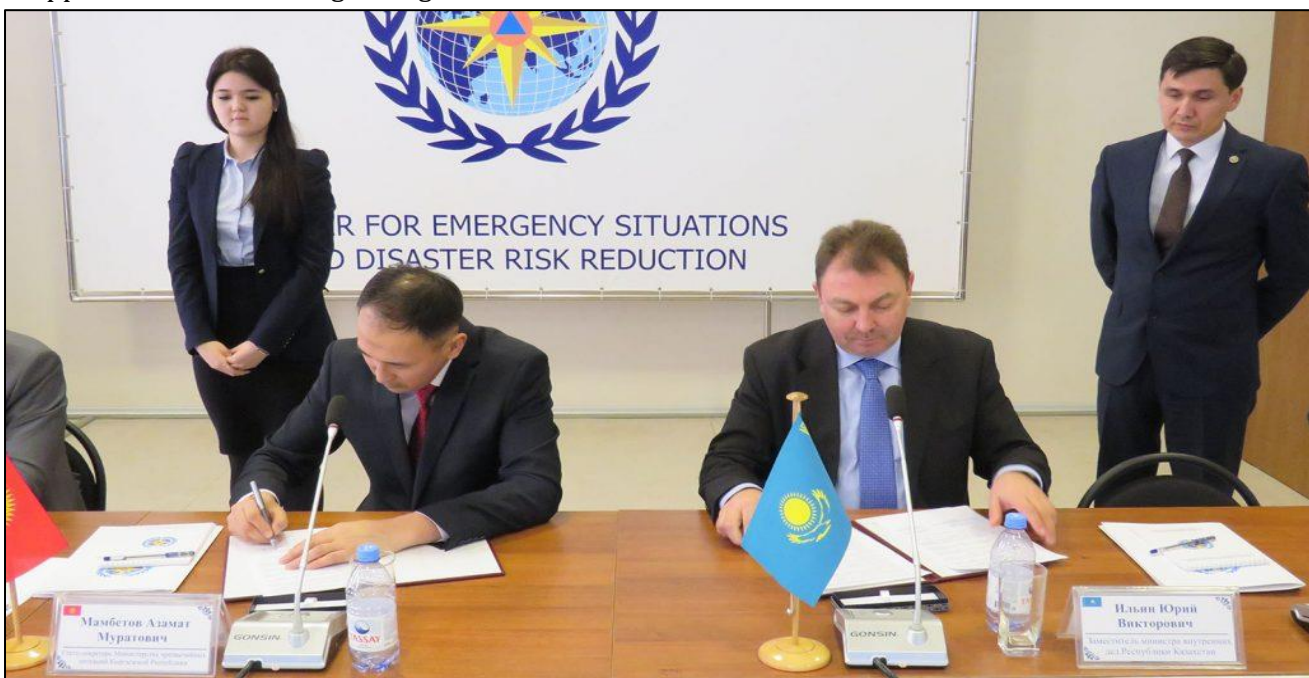

MARCH 5: The Center hosted the seventh meeting of the Council of the Center.

The Council of the Center adopted the following decisions:

- Approved documents regulating the activities of the Center.



2019 year

MARCH 13-14: The Center, together with the UNESCO Cluster Office, organized and conducted a Regional Seminar on mobilizing youth and young professionals in the field of science on disaster risk reduction in Central Asia.

The objectives of the seminar were to strengthen the scientific potential of young specialists in the field of DRR and to popularize the application of scientific achievements in matters of population protection among young people. The seminar was attended by university students, young specialists from scientific institutions of Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan.



APRIL 3: The Director of the Center held Skype talks with the Secretary General of the International Civil Defense Organization (Geneva), Mr. Belkas Elketrousi.

During the negotiations, the Center and ICDO summed up the results of cooperation for 2018 and reached agreements on the implementation of a number of joint projects in 2019.



APRIL 8-12: The Center, together with the ICRC, organized and conducted a national training for the training of instructors in first aid for the population affected by natural and man-made emergencies.

APRIL 15: in Bishkek, the Center organized and conducted a kick-off workshop to launch a joint project of FAO in the Kyrgyz Republic, the Ministry of Emergency Situations of the Kyrgyz Republic and the Center

“Capacity Building for Disaster Risk Reduction and Disaster Preparedness in the Agricultural Sector of the Kyrgyz Republic”.

APRIL 16: The Center concluded a Memorandum of Understanding and Cooperation with the Joint Stock Company "Research Institute of Fire Safety and Civil Defense" of the Committee for Emergency Situations of the Ministry of Internal Affairs of the Republic of Kazakhstan.



APRIL 18: The Center held a working meeting with students of the Kazakh-German University and representatives of the UNESCO Chair on Water Resources Management in Central Asia at the KGU. The meeting was held within the framework of cooperation between the Center and higher educational institutions of Kazakhstan and Kyrgyzstan.



MAY 13-17: The Center and MapAction conducted a cluster specialized training on geographic information systems and mapping for employees of the Department of Emergency Situations of Kostanay, Akmola, North Kazakhstan regions and the Kokshetau Technical Institute of the Committee for Emergency Situations of the Ministry of Internal Affairs of the Republic of Kazakhstan.

MAY 15: in the Yereymentau district of the Akmola region, the Center, together with the UN Children's Fund, conducted another test of UAVs to reduce the risks of natural disasters in order to timely detect forest and steppe fires, as well as monitor the situation and organize planned work to prevent floods. Testing of unmanned aerial vehicles was held with the participation of representatives of UNICEF, the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan, the Department of Emergency Situations of the city of Nur-Sultan, the Department of Emergency Situations of the Akmola region, the Kokshetau Technical Institute of the CoES, the State Enterprise "Kazavialesokhrana", the Committee for Forestry and Wildlife of the Ministry of Agriculture of the Republic of Kazakhstan, the Akimat of the Yereymentau region, the KSU "Ereymentau forestry institution", the national natural park "Buirata" at".



MAY 13-17: in Geneva, Switzerland, the Center's delegation took part in the Sixth Session of the Global Platform for Disaster Risk Reduction. The Global Platform has become an important milestone in the implementation of the Sendai Framework for Disaster Risk Reduction 2030.

MAY 21: in Nur-Sultan, the Center, together with the United Nations Children's Fund (UNICEF), held a round table on the use of unmanned aircraft in the interests of children in the field of emergency prevention and response. The round table was held with the participation of representatives of the emergency departments of Kazakhstan, Kyrgyzstan, Tajikistan, Uzbekistan, the Embassy of the Russian Federation in the Republic of Kazakhstan, as well as international organizations - the European Union, the UN Development Program and the International Civil Defense Organization.



MAY 20-24: The Center and MapAction conducted a cluster training on geoinformation systems and mapping for employees of the Committee for Emergency Situations of the Ministry of Internal Affairs of the Republic of Kazakhstan, the Department for Emergency Situations of the city of Nur-Sultan, and the

Department for Emergency Situations of the Karaganda region at the site of the Central Control Center of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan.

MAY 24: The Center and UNICEF held a partnership meeting on the results of the capacity review and the development of recommendations for developing the Center's capacity.

JUNE 6-7: The Center, together with the UNICEF Regional Office for Europe and Central Asia and the IFRC and KP, conducted a Regional training on providing cash assistance in the event of a major earthquake in Central Asia, including the use of social safety nets.

JUNE 10-14: The Center and the ICDO conducted a five-day training for 45 psychologists of the territorial divisions of the Committee for Emergency Situations of the Ministry of Internal Affairs of the Republic of Kazakhstan on the topics: "Psychological assistance to children and people with disabilities affected by emergency situations" and "Innovative methods of providing emergency psychological assistance, mental regulation and self-regulation".».



JUNE 18-20: The Center, together with FAO, held a three-day training workshop. "How to correctly calculate the damage and losses in the agricultural sectors caused by natural disasters of various types and scales, what methodology should be used to collect information so that data collected in countries and regions of the world can be analyzed, aggregated and compared, and what data will be required for this" - these and other critical issues were considered during the training seminar.

11-13 JUNE: In Kokshetau, the Secretariat of the United Nations Economic Commission for Europe (UNECE) Industrial Accidents Convention held an introductory international workshop on assessment within the framework of the UNECE project to strengthen the safety of mining operations, in particular tailings in Central Asia.

The event was attended by representatives of the State authorities for industrial development and industrial safety of the countries of Central Asia, the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan, experts in ecology and the environment, Dnipro State Technical University (Ukraine), project participants, the UNECE Convention on Industrial Accidents, as well as an employee of the Center.



JUNE 21: Employees of the Center took part as observers in the meeting-seminar on ensuring water safety "Balkhash-2019" held in Priozersk, Karaganda region.

During the gathering-seminar, the improvement of methods and ways of outreach and education of the population on water safety measures was discussed. In the practical part of the gathering, rescuers demonstrated various methods of search and rescue on the water. Also, the visit to the base was part of the preparation for the international training to improve the skills of divers of the emergency departments of the Central Asian countries.



JUNE 24-28: The Center and MapAction conducted another cluster training on geoinformation systems, data and mapping for employees of the Department of Emergency Situations of the city of Almaty, the Department of Emergency Situations of the East Kazakhstan region, the Department of Emergency Situations of Pavlodar and the Department of Emergency Situations of Almaty region of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan.



JULY 11: in the city of Bishkek, the Center, together with the Ministry of Emergency Situations of the Kyrgyz Republic, held a meeting of the working group (experts) of the Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries as part of the dialogue "Central Asia plus Japan".

JULY 12: in the city of Bishkek, the Center, under the chairmanship of the Ministry of Emergency Situations of the Kyrgyz Republic, organized and held the next Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries as part of the dialogue "Central Asia plus Japan".

The work of the Regional Forum, held with the technical and financial support of the Government of Japan, the UN Development Program, the World Bank, was attended by more than 60 people - leaders and representatives of the countries of Central Asia, Afghanistan, UN agencies, donor, international and non-governmental organizations.



Heads of delegations of emergency departments of the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan, Turkmenistan, the Republic of Uzbekistan - participants of the Regional Forum - Meeting of the heads of emergency departments of the countries of Central Asia, on the basis of the signing of the protocol:

Approved:

1. Regulations on the Regional Scientific and Technical Council for Emergency Situations.
2. Regulations on the Regional Register of Experts in the field of Civil Protection / Defense, disaster risk reduction, prevention and liquidation of emergencies.
3. Regulations on the Regional register of forces and means of the countries of Central Asia for conducting rescue operations on their territory in case of emergency.
4. Action Plan (Roadmap) for the implementation of the Framework for Strengthening Regional Cooperation among the Central Asian Countries in the Field of Disaster Risk Reduction, Prevention and Elimination of Emergencies for 2019-2021.

Decided:

1. Form the Regional Scientific and Technical Council for Emergency Situations as a public expert and advisory body of the Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries, and instruct the Secretariat of the Regional Forum to organize its activities in accordance with the approved Regulations.
2. To form a Regional Register of experts in the field of Civil Protection/Defence, disaster risk reduction, prevention and liquidation of emergency situations.
3. To form a Regional Register of forces and means of the countries of Central Asia for conducting emergency rescue operations on their territory in the event of an emergency.
4. The Secretariat of the Regional Forum to develop a draft concept for the use (sharing of flight data) by the emergency departments of the countries of Central Asia of unmanned aerial vehicles.
5. Approve the Action Plan (Roadmap) for the implementation of the Framework for Strengthening Regional Cooperation among the Central Asian Countries in the Field of Disaster Risk Reduction, Prevention and Elimination of Emergencies for 2019-2021.
6. Work out the issue of holding the next Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries in 2020 (or 2021) in the Republic of Uzbekistan.
7. Provide support and assistance to the emergency departments of the countries of Central Asia in the implementation of Regional programs and projects on disaster risk management in Central Asia, funded by donor agencies and international organizations.

19-23 AUGUST: The Center and MapAction in Shymkent held a cluster training on geoinformation data and mapping for employees of the Department of Emergency Situations of the city of Shymkent, the Department of Emergency Situations of the Turkestan Region, the Department of Emergency Situations of the Kyzylorda Region and the Department of Emergency Situations of the Zhambyl Region of the CoES Ministry of Internal Affairs of the Republic of Kazakhstan.

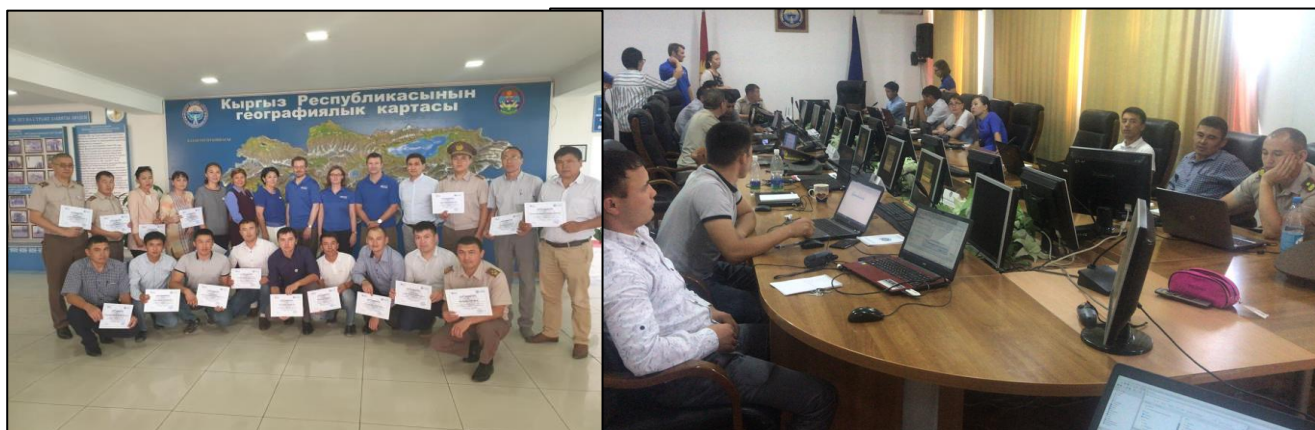

NOVEMBER 21-22: in Ulaanbaatar, Mongolia, a representative of the Center took part in national consultations within the framework of the project “Resolving the cross-border aspects of the 2030 Agenda through regional economic cooperation and integration in the Asia-Pacific region”.

DECEMBER 3: Representatives of the Center took part in the Coordination Meeting of the Youth Network for Disaster Risk Reduction, held by the UNESCO Office in Almaty, where a representative of the Center made a presentation on the role of the Center in science in the field of disaster risk reduction.



DECEMBER 5: The Center, with the financial support of the World Bank, held the first organizational meeting of the Regional Scientific and Technical Council for Emergency Situations within the framework of the program “Strengthening financial stability and accelerating disaster risk reduction in Central Asia”.

The meeting, in addition to employees of emergency departments and scientific institutions of the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan and the Republic of Uzbekistan, was attended by representatives of the European Union, the World Bank, UNESCO and UNISDR.

Mr. Moldobekov B.D., Co-Director of the Central Asian Institute of Applied Geosciences, was elected Chairman of the Regional Scientific and Technical Council for Emergency Situations by the decision of the meeting.

DECEMBER 6: The Center, together with the World Bank, within the framework of the program "Strengthening financial resilience and accelerating disaster risk reduction in Central Asia" held a Regional meeting with experts from Central Asian countries on disaster risk assessment of a large-scale and transboundary nature.



IN DECEMBER: The Center signed an Agreement with the United Nations Office for DRR (UNDRR) for the implementation of a three-year Regional Project (2020-2022) "Strengthening regional cooperation and facilitation of the implementation of the Sendai Program in Central Asia" as an implementing partner.

 - At the initiative of the Center, in July 2019 in Bishkek, under the chairmanship of the Kyrgyz side with the technical and financial support of international organizations, a meeting of the Working Group (experts) of the Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries was organized and held.
 - At the initiative of the Center, in July 2019 in Bishkek, under the chairmanship of the Kyrgyz side with the technical and financial support of UNDP in the Kyrgyz Republic, a Regional Forum - Meetings of the Heads of Emergency Departments of the Central Asian countries was organized and held.

During the high-level forum meeting, the heads of delegations of the emergency departments of Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan discussed and adopted protocol decisions on strengthening and developing regional cooperation in the field of disaster risk reduction, prevention and elimination of emergency situations in the Central Asian region.

- At the initiative of the Center, by the decisions of the Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries:
 - *Established, and with the organizational and technical support of the Center, launched the activities of the Regional Scientific and Technical Council for Emergency Situations;*

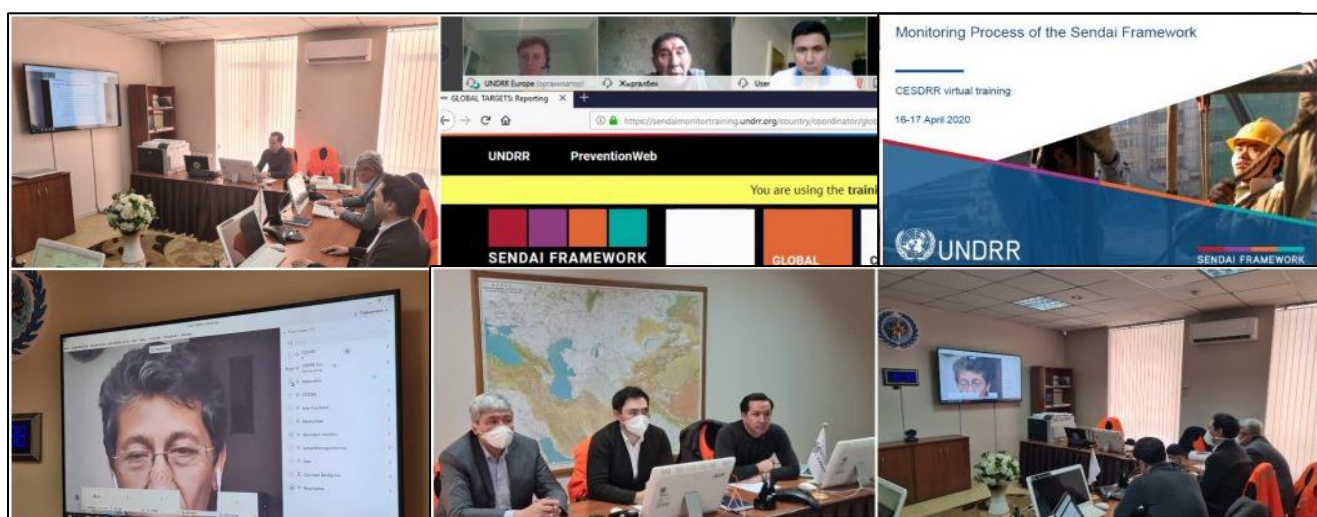
- ◆ The Center, together with international and non-governmental organizations, scientific institutions, with their technical and financial support, prepared and held 21 international events (conferences, forums, seminars, trainings, meetings, meetings ...) in the field of disaster risk reduction and emergency situations.
750 people took part in these events, exchanged experience, gained new knowledge, improved their skills in the field of disaster risk reduction and emergency situations, including:
 - o 296 representatives of state bodies of the Republic of Kazakhstan.
 - o 65 representatives of state bodies of the Kyrgyz Republic.
 - o 83 representatives of state bodies of the Central Asian countries and other states.
 - o 33 representatives of scientific institutions and independent experts.
 - o 273 representatives of international and non-governmental organizations.
- 2 meetings of the Council of the Center were held.
- For further development, with the support of UNICEF and the UNDP Regional Office in Istanbul, the Center's Capacity Development Strategy for 2019-2021 was developed, agreed with international and non-governmental organizations, approved by the decision of the Council of the Center in 2019 and is currently being implemented.

MARCH 3: Deputy Director of the Center Mr. Khasenov M.M. a working Skype meeting was held with the Deputy Secretary General of the International Civil Defense Organization, Mr. A. Kudinov, to discuss promising areas for the development of bilateral cooperation for 2020.



APRIL 16-17: The Center and the United Nations Office for Disaster Risk Reduction (UNISDR), jointly organized and conducted a training workshop for ESDR staff on the monitoring system of the Sendai Framework for Disaster Risk Reduction 2015-2030 via videoconference.



APRIL 22: The Center, via videoconference, organized and held a Regional Consultative Meeting with representatives of regional and subregional offices: the UN Office for the Coordination of Humanitarian Affairs (Almaty, Bishkek, Dushanbe), the UN Development Program (Istanbul), the UN Office for Disaster Risk Reduction (Almaty), the UN Children's Fund (Almaty), the UN International Organization for Migration (Nur-Sultan), the World Bank (Almaty), the Red Society Crescent of the Republic of Kazakhstan (Almaty).

The participants of the Regional Consultative Meeting exchanged information on the situation with the COVID-19 coronavirus pandemic in the countries of Central Asia and the emergency measures taken by the international community to provide technical support and humanitarian assistance to governments in protecting the life and health of citizens, preventing the penetration and further spread of coronavirus infection.

MAY 21: The Center, via videoconference, held the first meeting of the joint working group of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan, the Ministry of Emergency Situations of the Kyrgyz Republic and the Center.

This working group was created in order to implement measures to integrate early warning systems of the Republic of Kazakhstan and the Kyrgyz Republic, by determining the technical capabilities of national early warning systems..

2020 year

MAY 18 - 21: The Center carried out a trip to the disaster zone in the Makhtaaral district of the Turkestan region of the Republic of Kazakhstan, caused by the breakthrough of the dam of the Sardoba reservoir on the territory of the Republic of Uzbekistan.

Representatives of the Center, together with the response team of the Red Crescent of Kazakhstan, in order to conduct a detailed assessment of the situation and determine the amount of necessary assistance to the affected population, made a detour to the settlements of Nurlyzhol, Zhanaturmys, Ferdowsi, Orgebas, Dostyk and Zhenis, the most affected by the disaster.

As a result of the work carried out, measures were taken to ensure the constant exchange and updating of information about the affected population between the emergency response headquarters, the Center and the Red Crescent of Kazakhstan, which made it possible to deliver the necessary goods to the emergency zone as soon as possible for social support and life support for the population affected by the disaster.

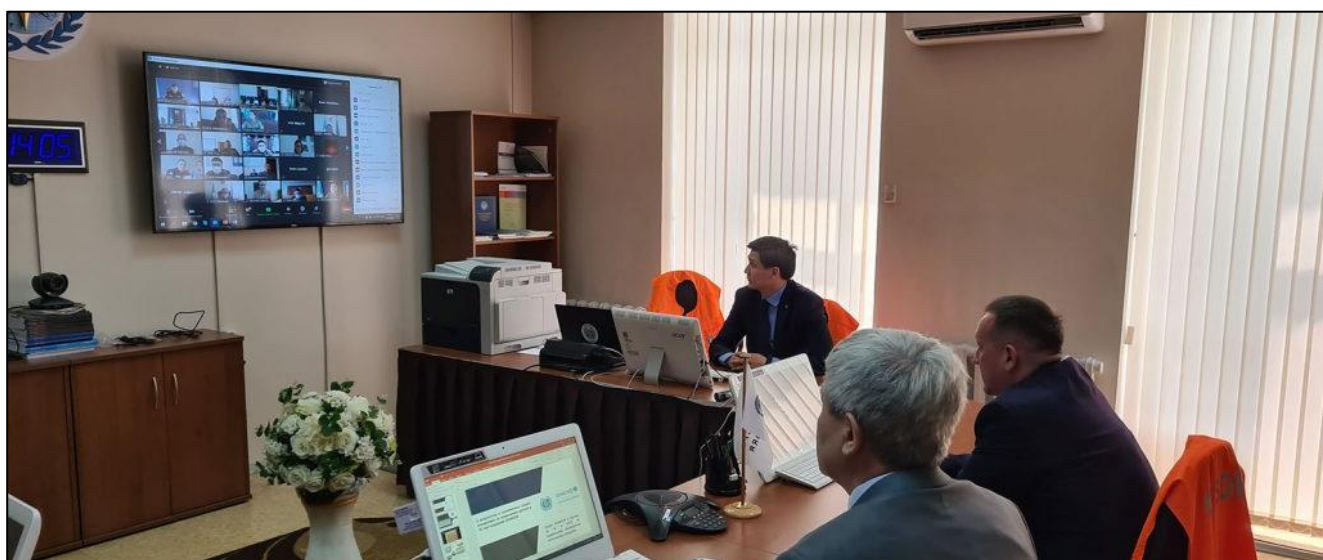
MAY 21: The first meeting of the joint working group of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan, the Ministry of Emergency Situations of the Kyrgyz Republic and the Center was held via videoconference. During the meeting, issues were discussed to determine the technical capabilities of the early warning system of the city of Almaty for integration with seismic sensors located on the territory of the Kyrgyz Republic.

Members of the joint working group noted that the implementation of the planned measures will allow the emergency departments of the Republic of Kazakhstan and the Kyrgyz Republic to increase the effectiveness of early warning systems.

JUNE 12: The Center and UNICEF organized and held a Virtual Session on the topic “Emergency Management and Disaster Risk Reduction in the Best Interests of Children: Sharing Knowledge and Good Practices between China and Kazakhstan”.

The target audience of the session was employees of the central office and territorial divisions of the Committee for Emergency Situations of the Ministry of Internal Affairs of the Republic of Kazakhstan, representatives of the National Center for Disaster Risk Reduction of the Ministry of Emergency Situations of China (NCDRS MES), representatives of the regional and country, Kazakhstani and Chinese offices of UNICEF and the Center.

During the session, the participants got acquainted with the latest trends in the development of preparedness and emergency response, disaster risk reduction in Kazakhstan, as well as the disaster management system in China and the use of UAVs in disaster risk management. The Center made a presentation on the results of the implemented joint project with UNICEF and the lessons learned from the initiative on the use of drones in emergencies, with a focus on vulnerable segments of the population.



JULY 10: The Center, via videoconference, organized and held the second Regional Consultative and Advisory Meeting with representatives of regional and subregional offices.

Having discussed in detail the current situation with the spread of the COVID-19 pandemic in the countries of Central Asia, the participants reached an agreement: to hold Regional Consultative and Advisory Meetings at least once a month; provide the Center with updated project implementation plans for further distribution to partners, taking into account the current situation in the region in connection with the spread of the COVID-19 pandemic.

AUGUST 7: Center participated in the first UNISDR Regional Online Workshop “Implementation of National Disaster Loss Databases – Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan”.

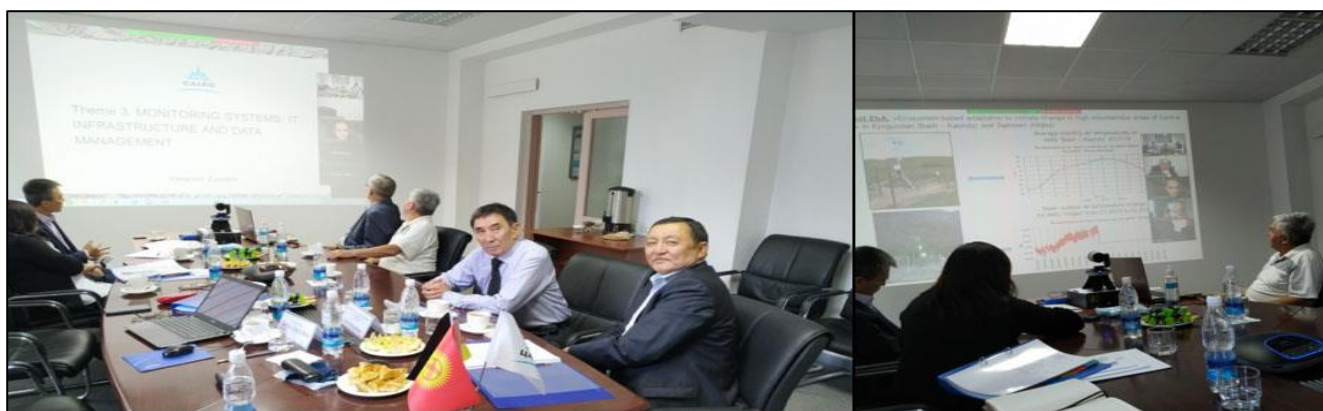
The seminar was held within the framework of the project on “Increasing disaster resilience and accelerating the implementation of the Sendai Framework for Disaster Risk Reduction in Central Asia”, implemented by the United Nations Office for Disaster Risk Reduction in cooperation with the CIMA Research Foundation and the Asian Center for Disaster Preparedness.

SEPTEMBER 15: The UN Office for Disaster Risk Reduction, together with the Center, within the framework of the project “Strengthening regional cooperation and facilitation of the implementation of the Sendai Program for Disaster Risk Reduction in Central Asia” conducted trainings on monitoring the Sendai Framework Program for Disaster Risk Reduction for 2015-2030 for representatives of state structures of Uzbekistan and Kazakhstan in the format of a videoconference.



SEPTEMBER 25: The Center took part in the regular meeting of the Consultative Commission of the Central Asian Institute for Applied Geosciences (CAIAG). During the meeting, the leaders and specialists of CAIAG presented the results of research and activities for 2019/2020 to the members of the Consultative Commission. in the following areas:

- hazardous geological processes and their manifestations in the region of Central Asia;
- temporal and spatial hydrological regimes of rivers and glaciers and their dynamics;
- geomonitoring and scientific services for operation, maintenance, data processing and data management of monitoring networks;
- capacity building, training courses, education and public relations.



2020 year

OCTOBER 5 - 8: The Center, within the framework of the project of the Center and the United Nations Children's Fund (UNICEF) "Development of unmanned aircraft in order to ensure the safety of territories and the population, including vulnerable groups from emergencies and disasters for 2020", held a training

in Nur-Sultan for specialists from the Ministry of Emergency Situations of the Republic of Kazakhstan on the use of unmanned aerial vehicles in the interests of preventing and eliminating natural and man-made emergencies. The training consisted of theoretical and practical parts, as well as exercises on post-flight processing of data obtained using UAVs using special software that allows processing the results of aerial photography of the area both in the visible spectrum and made with a multispectral camera.

The training resulted in the training of specialists from the Ministry of Emergency Situations of the Republic of Kazakhstan from 7 regions to manage unmanned aerial vehicles, create high-quality orthophotos, 3D building models, digital terrain and relief models, and elevation maps..

OCTOBER 13: The Center, together with the UN Office for Disaster Risk Reduction, held a consultative meeting on October 13, 2020, dedicated to the International Day for Disaster Risk Reduction. This meeting was attended by representatives of regional and national offices of UN missions, the World Bank, the International Federation of Red Cross and Red Crescent Societies, CAIAG, the secretariat of the National Platform for Disaster Risk Reduction of the Kyrgyz Republic.



OCTOBER 20-23: The Center, within the framework of the project of the Center and the United Nations Children's Fund (UNICEF) "Development of unmanned aircraft in order to ensure the safety of territories and the population, including vulnerable groups from emergencies and disasters for 2020", held another training in the city of Taraz for specialists from the Ministry of Emergency Situations of the Republic of Kazakhstan of the southern region of the country on the use of unmanned aerial vehicles in the interests of preventing and eliminating natural and man-made emergencies.



2020 year

NOVEMBER 13: The ninth meeting of the Council of the Center chaired by the Kazakh side was held at the Center for Emergency Situations and Disaster Risk Reduction.

The ninth meeting was attended by the Minister for Emergency Situations of the Republic of Kazakhstan Ilyin Yu.V. and the Minister of Emergency Situations of the Kyrgyz Republic Azhikeev B.E., as well as the representative of Afghanistan, an observer state at the Center, Chargé d'Affaires of the Embassy of the Islamic Republic of Afghanistan in the Republic of Kazakhstan Azizullah Omar.

At the meeting, the Council members were presented with the results of the Center's work in 2020 and priority areas of activity for 2021, as well as information on the implementation of the Center's Capacity Development Strategy for 2019-2021.



NOVEMBER 20: The second meeting of the Regional Scientific and Technical Council for Emergency Situations was held via video conference.

The meeting, in addition to the members of the RNTS, was attended by representatives of the World Bank, UNESCO and UNSDRO.

Members of the RSTC discussed proposals for the introduction of innovative information and communication technologies in disaster risk management in Central Asia and the use of UAVs to ensure the safety of territories and the population, and also got acquainted with the experience of CAIAG, the Institute of Geology, Seismic Engineering and Seismology of the Academy of Sciences of Tajikistan, the Institute of Geomechanics and Subsoil Development of the National Academy of Sciences of Kyrgyzstan in the study of hazardous natural processes and phenomena.

NOVEMBER 24-27: Within the framework of the United Nations Children's Fund in Kazakhstan (UNICEF) project "Development of unmanned aircraft to ensure the safety of territories and population, including vulnerable groups from emergencies and disasters for 2020", the Center conducted a regional training in Kyrgyzstan, the city of Bishkek (with online backup) on the use of unmanned aerial vehicles in the interests of preventing and eliminating natural and man-made emergencies for specialists from the countries' emergency departments Central Asia, China and international organizations.



DECEMBER 10: The Center held a meeting of the Working Group on preparations for the Regional Consultative Meeting on strengthening regional cooperation in the field of disaster risk reduction and the implementation of the Sendai Program for DRR in Central Asia, consisting of employees of the emergency departments of the Central Asian countries.

DECEMBER 11: Within the framework of the United Nations Office for Disaster Risk Reduction Initiative "Increasing Resilience to Disasters and Accelerating the Implementation of the Sendai Framework for Disaster Risk Reduction in Central Asia", funded by the European Union, a Regional Consultative Meeting was held in Bishkek to strengthen regional cooperation in disaster risk reduction and the implementation of the Sendai Program for DRR in Central Asia.

The delegations of the countries discussed the implementation of the Action Plan (Roadmap) for the implementation of the Framework for strengthening regional cooperation between the countries of Central Asia in the field of DRR and emergencies for 2019-2021, adopted in 2019 by the Regional Forum - a meeting of the heads of emergency departments of the countries of Central Asia.

The participants of the Regional Meeting were presented with the draft of the Regional DRR Strategy developed by the CESRR within the framework of the Initiative funded by the European Union. This strategy, aimed at reducing the risk of large-scale transboundary disasters, provides for the issues of improving information exchange, joint risk assessment, training programs for emergency departments of the region, and increasing awareness of existing and possible new threats.



2020 - MAIN RESULTS OF THE CENTER

По инициативе At the Center's initiative, organizational support was created for the work of the Working Group of Experts of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan and the Ministry of Emergency Situations of the Kyrgyz Republic to implement joint coordinated measures to integrate early warning systems for earthquakes in the Republic of Kazakhstan and the Kyrgyz Republic. On May 21, 2020, the first meeting of the joint working group of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan, the Ministry of Emergency Situations of the Kyrgyz Republic and the Center was held via videoconference.

- Since March 2020, the Center has been organizing and conducting work to collect, summarize, analyze and exchange information about the situation, problems, needs and requests of the countries of Central Asia to respond to and eliminate the consequences of the spread of the coronavirus COVID-19 at the national and regional levels, including through:
 - Development and dissemination to stakeholders of the daily "Up-to-date information on the situation with the spread of the COVID-19 pandemic in the countries of Central Asia";
 - Holding Regional Consultative and Advisory Meetings with representatives of regional and subregional offices of international and non-governmental organizations to discuss issues of disaster risk reduction, emergencies and the COVID-19 pandemic in the countries of Central Asia.
- On an ongoing basis, the Center organizes and conducts work on the collection, generalization, analysis and exchange of operational information in the field of emergency situations through the development and communication to stakeholders of the daily "Operational information on emergency situations in the Republic of Kazakhstan and the Kyrgyz Republic".
- At the initiative of the Center, in April 2020, a Regional consultative and advisory meeting was organized and held via videoconference with representatives of regional and subregional offices: the UN Office for the Coordination of Humanitarian Affairs (Almaty, Bishkek, Dushanbe), the UN Development Program (Istanbul), the UN Office for Disaster Risk Reduction (Almaty), the UN Children's Fund (Almaty), Международной организации по миграции ООН (Нур-Султан), Всемирного банка (Алматы), The Red Crescent Society of the Republic of Kazakhstan (Almaty). The participants of the Regional Consultative Meeting exchanged information on the situation with the COVID-19 coronavirus pandemic in the countries of Central Asia and the emergency measures taken by the international community to

provide technical support and humanitarian assistance to governments in protecting the life and health of citizens, preventing the penetration and further spread of coronavirus infection.

- ◆ At the initiative of the Center and ICDO, since 2018, organizational support has been provided to establish cooperation and interaction between the diving services of Kazakhstan and Kyrgyzstan. In 2021, with the direct support of the Center and ICDO, it is planned to conduct trainings for the diving service of the Ministry of Emergency Situations of the Kyrgyz Republic to improve the skills of diving services of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan on the basis of a water rescue station in the city of Priozersk, Kazakhstan.
- ◆ The Center, in May-June 2020, coordinated with the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan and assisted the Red Crescent of Kazakhstan in providing humanitarian assistance to the population of the Turkestan region of the Republic of Kazakhstan, affected by the flood that occurred as a result of the breakthrough of the dam of the Sardoba reservoir of the Republic of Uzbekistan.
- ◆ The Center, together with the UN Office for Disaster Risk Reduction, in order to contribute to the achievement of the Global Targets identified by the Sendai Program for Disaster Risk Reduction for 2015-2030 and within the framework of the project "Strengthening regional cooperation and facilitation of the implementation of the Sendai Program for Disaster Risk Reduction in Central Asia" in September 2020 conducted instructional and methodological sessions on monitoring the implementation of the Sendai Framework Program for Disaster Risk Reduction for 2015-2030 years for representatives of state structures of Central Asian countries.
- ◆ The Center, together with UNICEF in the Republic of Kazakhstan, carried out a number of activities to develop unmanned aircraft in order to ensure the safety of territories and the population, taking into account the interests of vulnerable groups.
- ◆ Within the framework of the United Nations Office for Disaster Risk Reduction Initiative "Increasing resilience to disasters and accelerating the implementation of the Sendai Framework for Disaster Risk Reduction in Central Asia", funded by the European Union, on December 11 in Bishkek, a Regional Consultative Meeting was held to strengthen regional cooperation in the field of disaster risk reduction and the implementation of the Sendai Program for DRR in Central Asia..
- ◆ The Center, by attracting investments in the form of grant funds from donor agencies and international organizations, as an executing agency, has implemented or is currently implementing the following projects in the field of strengthening regional cooperation, disaster risk reduction and emergency prevention:
 - 1) UNICEF project "Development of unmanned aircraft in order to ensure the safety of territories and the population, including vulnerable groups from emergencies and disasters for 2020". Implementation period: 2018-2021;
 - 2) UNISDR Project "Strengthening Regional Cooperation and Facilitating the Implementation of the Sendai Program in Central Asia". Implementation period: 2019-2022;
 - 3) FAO project in the Kyrgyz Republic "Strengthening the capacity for disaster risk reduction and preparedness in the agricultural sector". Implementation period: 2019-2021;
 - 4) UNDP project in the Kyrgyz Republic "Strengthening the capacity of integrated risk management in the Kyrgyz Republic and regional cooperation in Central Asia". Implementation period: 2016-2020;
 - 5) MapAction project for mapping. Implementation period: 2018-2021;
 - 6) World Bank Program "Strengthening Financial Resilience and Accelerating Disaster Risk Reduction in Central Asia". Implementation period: 2019-2022;

7) ESCAP project “Studies on drought assessment and drought monitoring models in Central Asia”. Implementation period: 2019-2020;

8) UNSDDR Project - Component on Strengthening the Center's Expertise in Strengthening Regional Cooperation (by providing the Center with three DRR experts to strengthen regional coordination with the emergency departments of Tajikistan, Turkmenistan and Uzbekistan) Implementation period: 2020.

The Center, together with international and non-governmental organizations, scientific institutions, with their technical and financial support, prepared and held 17 international events (conferences, forums, seminars, trainings, meetings, meetings) in the field of disaster risk reduction and emergency situations.

422 people took part in these events, exchanged experience, gained new knowledge, improved their skills in the field of disaster risk reduction and emergency situations, including:

- o 88 representatives of state bodies of the Republic of Kazakhstan.
 - o 30 representatives of state bodies of the Kyrgyz Republic.
 - o 59 representatives of state bodies of the Central Asian countries and other states.
 - o 5 representatives of scientific institutions and independent experts.
 - o 240 representatives of international and non-governmental organizations.

- 1 meeting of the Council of the Center was held.
 - 1 meeting of the Regional Scientific and Technical Council was held.

2021 year

JANUARY 11: The World Bank, together with the Center, held the second online meeting, which was attended by members of the Regional Scientific and Technical Council, national coordinators of the Sendai Framework for DRR, representatives of the European Union, experts from scientific institutions of Central Asian countries and international organizations.

The meeting participants listened to and discussed the revised preliminary report of the Consortium headed by RED Risk Engineering + Development, and also presented their comments, recommendations and proposals that need to be taken into account when conducting a regional disaster risk assessment of earthquakes, river and rain floods, and individual landslides.

As a result of this event, an agreed decision was made to hold such meetings and workshops to discuss the implementation of the Program "Strengthening Financial Resilience and Accelerating Disaster Risk Reduction in Central Asia" on a regular basis, as well as the need to submit materials and documents and expand constructive dialogue in electronic format.



2021 year

FEBRUARY 2-5: The Center, within the framework of the project of the Center and the United Nations Children's Fund (UNICEF) "Development of unmanned aircraft in order to ensure the safety of territories and the population, including vulnerable groups from emergencies and disasters for 2020", conducted another training in the city of Kokshetau for the teaching staff and cadets of the Kokshetau Technical Institute of the Ministry of Emergency Situations of the Republic of Kazakhstan on the use of unmanned aerial vehicles in the interests of preventing and eliminating emergency situations of natural and man-made nature.

The result of the training was the improvement of the qualifications of the teaching staff of the Kokshetau Technical Institute and the training of future employees of the emergency departments of the three countries in the management of unmanned aerial vehicles, the creation of high-quality orthophotos, three-dimensional building models, digital terrain and relief models, and height maps.

FEBRUARY 09: At the initiative of the Center for Emergency Situations and Disaster Risk Reduction (hereinafter referred to as the Center), on the basis of the DES of Almaty, a regular meeting of a joint working group was held from among the representatives of the DES of Almaty of the Ministry of Emergency Situations of the Republic of Kazakhstan, the Ministry of Emergency Situations of the Kyrgyz Republic, the Institute of Seismology, the Central Asian Institute of Applied Geosciences, the developers of the Darmen system and the Center. As a result of the meeting, a visit to the Central Asian Institute of Applied Geosciences is planned for a detailed study of the mechanisms of integration with the warning system of the Kyrgyz Republic.



2021 year

FEBRUARY 09: At the initiative of the Center for Emergency Situations and Disaster Risk Reduction (hereinafter referred to as the Center), on the basis of the DES of Almaty, a regular meeting of a joint working group was held from among the representatives of the DES of Almaty of the Ministry of Emergency Situations of the Republic of Kazakhstan, the Ministry of Emergency Situations of the Kyrgyz Republic, the Institute of Seismology, the Central Asian Institute of Applied Geosciences, the developers of the Darden system and the Center. As a result of the meeting, a visit to the Central Asian Institute of Applied Geosciences is planned for a detailed study of the mechanisms of integration with the warning system of the Kyrgyz Republic



2021 year

FEBRUARY 16: The Center took part in the meeting of the Emergency Response Coordination Group and the Coordination Meeting of the Ministry of Emergency Situations of the Kyrgyz Republic. During the Coordination Meeting of the Ministry of Emergency Situations of the Kyrgyz Republic, the Center presented to all participants the main results of the Center's activities from 2016 to 2020 on strengthening regional and international cooperation in the field of disaster risk reduction and adaptation to climate change. During his speech, the Director of the Center presented to the heads and representatives of donor agencies, international and non-governmental organizations the priority areas of the Center for 2021-2023 and submitted for consideration more than 10 new project proposals in the field of DRR and emergency situations.



2021 year

MARCH 17: The Center held a regional training with the participation of an expert of the Asian Disaster Preparedness Center (ADPC) Mr. Bill Ho and the Head of the Secretariat of the National Platform of the Kyrgyz Republic for DRR Mr. Almabek Aydaakev.

They shared useful experiences and practices in the preparation of Sendai reporting. The training was held in an interactive and trusting atmosphere.

The Center, as a Regional Resource Center for monitoring the Sendai Framework Program in the region of Central Asia and the South Caucasus, together with UNISDR, in order to contribute to the achievement of the Global Targets identified by the Sendai Program for DRR for 2015-2030 and within the framework of the project "Strengthening regional cooperation and facilitation of the implementation of the Sendai Program for DRR in Central Asia" conducted instructive and methodological exercises on monitoring the implementation of the Sendai Framework Program for representatives of government agencies of Central Asia :

- March 9, 2021 for representatives of the Republic of Kazakhstan.
- March 10, 2021 for representatives of the Republic of Uzbekistan.
- March 11, 2021 for representatives of Tajikistan.

- March 12, 2021 for representatives of the Republic of Turkmenistan.
- March 13, 2021 for the representative of the Kyrgyz Republic..



2021 year

APRIL 2: The UNDP Regional Office for Europe and the CIS with the support of the Center, within the framework of the global GARD program "Airport Disaster Preparedness", held an online webinar on airport preparedness for emergencies with the participation of representatives of the Ministry of Emergency Situations of Kyrgyzstan, the Ministry of Emergency Situations of Kazakhstan, the personnel of Manas and Almaty international airports. During the webinar, the GARD program developed by Deutsche Post DHL and UNDP was presented, and familiarization training was conducted on the airport disaster assessment mission.

In accordance with the agenda of the webinar, the experience of Armenia and Kazakhstan in assessing the readiness of international airports was presented.

The participants shared their useful experience and noted the importance of this event for the countries of Central Asia and the need for further continuation of this work. Thus, representatives of the Manas airport showed interest in such an assessment, in turn, the Center expressed its readiness to provide, with the support of the Ministry of Emergency Situations of Kyrgyzstan, assistance in promoting the above program in the Central Asian region.

As a result of the discussion, all interested parties agreed on the need to take coordinated and coordinated measures to strengthen the readiness of international airports in Kazakhstan and Kyrgyzstan to work in emergency situations based on the use of advanced international experience and practice.



2021 year

APRIL 20: As part of the implementation of the technical cooperation project “Strengthening the capacity for disaster risk reduction and disaster preparedness in the agricultural sector of the Kyrgyz Republic”, representatives of FAO, the Ministry of Emergency Situations of the Kyrgyz Republic, the Ministry of Agriculture, Water Resources and Regional Development, the Center for Emergency Situations and Disaster Risk Reduction in Bishkek held a joint meeting of technical working groups to discuss and agree on draft plans for DRR and adaptation to climate change at the local level and a standard report on emergencies and natural disasters disasters at the district level.

During the joint meeting of the TWG, the experts discussed and tentatively agreed on:

- Structure and content of Plans for Disaster Risk Reduction and Adaptation to Climate Change at the local level (at the level of Aiyl aimags);
- Structure and content of a typical regular report on the impact of emergencies and natural hazards on the agricultural sectors of the region (agriculture, hunting and forestry, fisheries);
- Recommendations to improve the existing policy and methodology for reporting on the impact of emergencies and natural hazards on agricultural sectors at the district level (agriculture, hunting and forestry, fisheries);
- Other documents and materials aimed at strengthening the capacity for disaster risk reduction and disaster preparedness in the agricultural sector of the Kyrgyz Republic.

The participants of the joint meeting of the TWG made an agreed decision that the experts of the interested ministries and departments of the Kyrgyz Republic and international organizations will

additionally consider and within two weeks present their comments and proposals on each of the submitted documents, and the experts of the Center will finalize their final versions and submit them for consideration to the participants of the final national seminar in June 2021.



2021 year

MAY 17-18: A meeting of a joint working group on the implementation of measures to integrate early warning systems of the Republic of Kazakhstan and the Kyrgyz Republic was held in Bishkek, the Kyrgyz Republic.

On May 17, 2021, representatives of the Department of Emergency Situations of Almaty, the Institute of Seismology, Seismological Experimental and Methodological Expedition LLP, the developers of the Darmen system and the Center visited the Crisis Management Center under the Ministry of Emergency Situations of the Kyrgyz Republic. During the visit, the guests from Kazakhstan got acquainted with the activities of the CUC, including the National Integrated System for Informing and Alerting the Population (OKSION), the 112 Kyrgyzstan mobile application.

On May 18, 2021, a regular meeting of the joint working group was held on the basis of the Central Asian Institute of Applied Geosciences (CAIAG).

During the meeting of the joint working group, the following issues were discussed:

- data exchange: stations, protocols, software and others;
- the possibility of using the DARMEN system in Kyrgyzstan;
- multilateral cooperation agreement.

At the end of the meeting, the meeting participants got acquainted with the activities of CAIAG, the results achieved in the field of studying the processes of global and regional changes and their impact on the environment, monitoring hazardous natural processes and phenomena, assessing multidisciplinary risks, reducing vulnerability to disasters, applied research in the areas of geodynamics and geocatastrophes, geoecology, technical infrastructures and data management.

As a result of the next meeting of the joint working group, a decision was reached on the implementation of organizational and technical measures for the mutual transfer of data from the servers of the SOME (Almaty) and the Central Control Center under the Ministry of Emergency Situations of the Kyrgyz Republic (Bishkek).



2021 year

MAY 24: in the city of Priozersk, Karaganda region, the grand opening of the Training Center for the training of rescuers of the Ministry of Emergency Situations of the Republic of Kazakhstan took place with the participation of Akim of the Karaganda region Kassymbek Zh.M., First Vice-Minister for Emergency Situations of the Republic of Kazakhstan Kulshimbaev I.D. and Deputy Director of the Center Aubakirov S.G.

In addition, the leadership of the Ministry of Emergency Situations of the Republic of Kazakhstan and the Center launched a two-week master training for rescue divers of the Ministry of Emergency Situations of the Republic of Kazakhstan, organized by the Center with the technical and financial support of the International Civil Defense Organization (ICDO)

Experienced master trainers of the Academy of Civil Protection of the Ministry of Emergency Situations of Russia and the Ministry of Emergency Situations of the Kyrgyz Republic were invited as trainers on the basis of the Republican Rescuer Training Center in Priozersk, Karaganda region, on the waters of Lake Balkhash.

As a result of the training course, rescue divers of the Republic of Kazakhstan will receive certificates and qualification documents for divers of groups 1-2, some of which will later be able to train their colleagues, rescue divers, as master trainers.

In addition, within the framework of the joint project of the Center and the ICDO, it is planned to revise and improve the training programs for rescue divers, develop and implement for practical use uniform standards for the training of rescue divers in the countries of Central Asia.



2021 year

JULY 01 - 04: The Center took an active part in the events dedicated to the 30th anniversary of the Ministry of Emergency Situations of the Kyrgyz Republic, in Bishkek.

As part of the celebration, the work of the International Scientific and Practical Conference on the topic: "NATIONAL INITIATIVES IN THE FIELD OF DISASTER RISK REDUCTION AND ADAPTATION IN CONDITIONS OF CLIMATE CHANGE" dedicated to the 30th anniversary of the Ministry of Emergency Situations of the Kyrgyz Republic was held. The conference discussed general thematic areas for disaster risk reduction and adaptation to climate change, as well as global directions for the sustainable development of countries.

On July 2, 2021, representatives of the Center took part in the meeting of the Joint Scientific and Technical Council and the XXXIII meeting of the Interstate Council for Natural and Technogenic Emergencies.

During all the events and framework meetings, the leadership and representatives of international organizations and emergency departments - participants, have repeatedly noted the increasing role and potential of the Center in strengthening cooperation in the field of ensuring security and reducing disaster risks in the Central Asian region.



2021 year

JULY 28-29: In the city of Tashkent, under the chairmanship of the Uzbek side, a meeting of the Working Group (experts) of the Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries was held.

The experts of the Central Asian countries discussed and agreed on the following draft documents proposed for discussion at the upcoming Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries in November 2021:

1. Draft "Strategy for the development of cooperation between the countries of Central Asia in the field of disaster risk reduction for 2022-2030".
2. Draft "Regional Disaster Risk Profile of Central Asian Countries".
3. Draft Regulations "On the Regional Coordination Mechanism for Response to Emergency Situations of a Transboundary Nature".
4. Draft Action Plan (Roadmap) for 2022-2023 for the implementation of the Strategy for the Development of Cooperation between the Countries of Central Asia in Disaster Risk Reduction for 2022-2030.
5. The project "Concepts for the use of unmanned aerial aircraft in order to reduce the risk of disasters, prevent and eliminate emergencies in the countries of Central Asia."

These documents are aimed at implementing practical measures to develop and deepen regional cooperation in the field of disaster risk reduction and strengthening preparedness to respond to emergencies, especially of a transboundary nature, and also provide for issues of improving information exchange, joint assessment of disaster risk factors, implementing programs and projects in the field of disaster risk reduction and adaptation to climate change, improving awareness of existing and newly emerging risks, further development, transition to a new, higher quality level of regional cooperation between the Central Asian countries in the field of DRR and emergencies.

4-7 AUGUST, 10-13 AUGUST: Within the framework of the National Disaster Risk Management Project, experts from the Center for Emergency Restoration of the Republic of Tajikistan conducted trainings with specialists from state institutions of the Republic of Tajikistan. These events are the second part of a series of trainings for specialists in the field of disaster risk reduction in government agencies of the country.

The main objectives of the training:

- learning of the concepts and key aspects of disaster risk management by the participants of the training;
- increased knowledge of the concepts of integrating CI and DRM into sectoral policies, plans, programs and actions of national institutions
- development of operational skills to establish/strengthen interagency/intersectoral partnerships to integrate CI and DRM into their sectoral programs, plans and actions.
- increasing the capacity of participants to conduct advocacy and raise awareness of the GoT on the inclusion of CI and DRM in its national institutions, programs, projects, plans and actions.

37 people took part in the trainings: representatives of the CoES and Civil Defense under the Government of the Republic of Tajikistan, as well as specialists from emergency departments of a number of other ministries and departments. The course on updating Disaster Risk Management and Adaptation to Climate Change in government institutions was conducted in six modules.

These trainings will allow specialists of emergency departments of ministries and departments to actively apply the acquired knowledge and skills in their work on the inclusion of DRM and AEC in sectoral policies, plans, programs and actions of national institutions and for outreach.

AUGUST 31 - SEPTEMBER 06: The Center provided technical and organizational support during the XVI World Championship among men and the VII World Championship among women in fire and rescue (fire-applied) sports, which was held in Karaganda. At the same time, the specialists of the Center prepared photo and video materials using UAVs, which were transferred to the NGO "Sports Federation of Firefighters and Rescuers".

The championship was attended by 14 teams from nine countries, firefighters-rescuers competed in climbing the assault ladder, overcoming a 100-meter obstacle course, combat deployment and a 4x100-meter fire relay race.



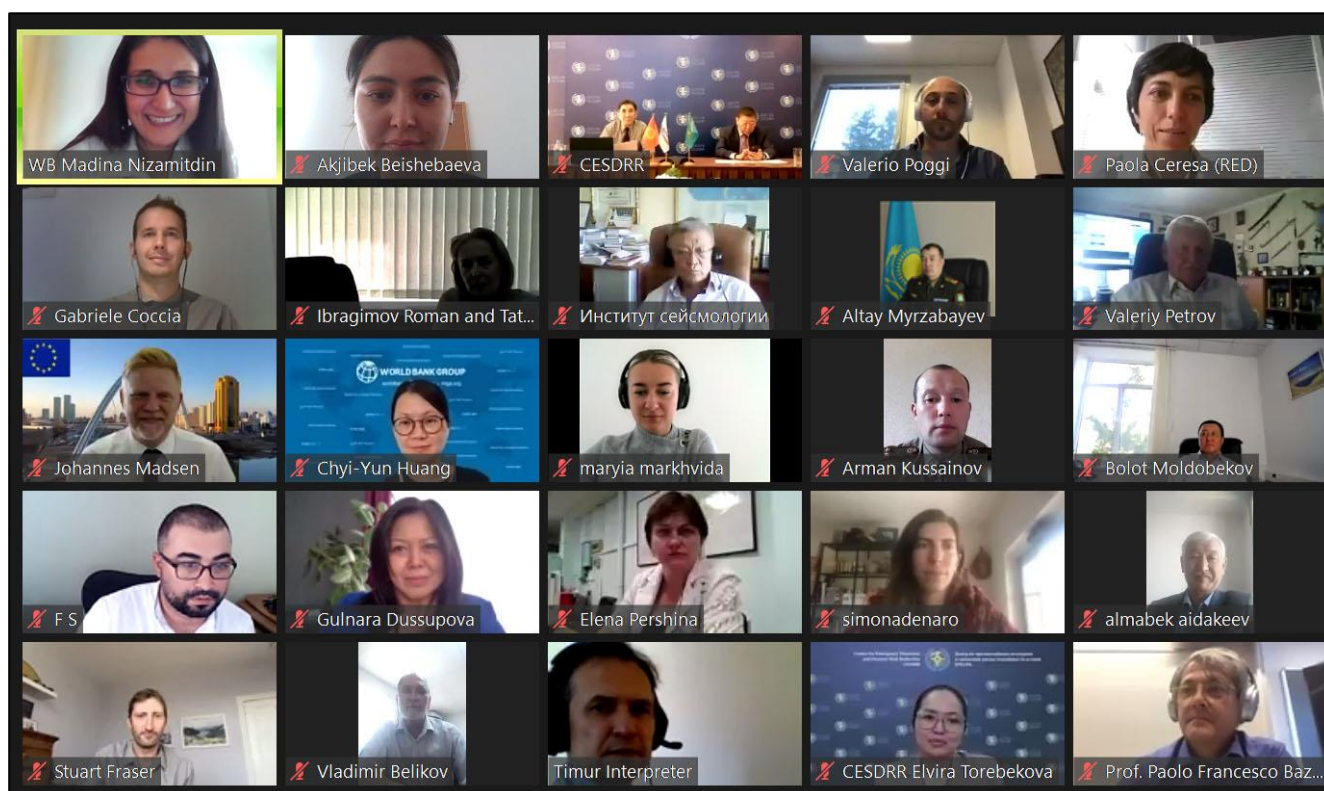

SEPTEMBER 16: The World Bank, together with the Center, held the third online meeting on the topic: “Presentation of the Seismic Hazard Assessment Report”, organized as part of the activities of the World Bank Program under the management of the Global Fund for Disaster Reduction and Recovery “Strengthening Financial Resilience and Accelerating Disaster Risk Reduction in Central Asia” (FSDDR Program), funded by the European Union.

This event was attended by members of the Regional Scientific and Technical Council, national coordinators of the Sendai Framework for DRR, representatives of the European Union, representatives of emergency departments of Central Asian countries.

The participants of the meeting heard and discussed the reports of the Consortium headed by RED Risk Engineering + Development on the main aspects of the study, components, content and final results, the goals and timing of the seismic hazard assessment, as well as the structure of the report and its chapters, on the introduction of a new model for the probabilistic assessment of seismic hazard as part of the implementation of the UFUSDRR Program, and also presented their comments, recommendations and proposals that need to be taken into account when conducting a regional earthquake disaster risk assessment.



2021 year

08 OCTOBER: The tenth meeting of the Council of the Center chaired by the Kazakh side was held at the Center for Emergency Situations and Disaster Risk Reduction. The tenth meeting was attended by the Minister for Emergency Situations of the Republic of Kazakhstan Ilyin Yu.V. and Minister of Emergency Situations of the Kyrgyz Republic Azhikeev B.E.

More than 20 international organizations involved in disaster risk reduction in the countries of Central Asia, together with the Center, were connected online, such as UNISDR, UNICEF, UNESCO, OSCE, World Bank, UNDP, ICDO and many others.

At the meeting, the results of the work of the Center for 2021 and priority areas of activity for 2022 were presented to the members of the Council.

During the meeting, international organizations provided information on the implementation of joint projects with the Center in the field of civil protection, adaptation to climate change and emergency situations in the countries of Central Asia. In their speeches, all partners highly appreciated the ongoing joint work with the Center, and expressed their firm intention on the advisability of further work in Central Asia through the Center's platform.

Of great interest to the participants of the meeting was the pilot project on the integration of early warning systems for earthquakes in the Republic of Kazakhstan and the Kyrgyz Republic, initiated by the Center this year.

In turn, the heads of emergency departments noted this area as one of the priorities and instructed to intensify the efforts of the parties to integrate early warning systems for earthquakes and other possible emergencies, as well as to more effectively use the Center's potential in the practical implementation of international programs and projects in the field of disaster risk reduction, strengthening preparedness to respond to emergencies and provide humanitarian assistance.



2021 year

OCTOBER 11 - 14: The Center for Emergency Situations and Disaster Risk Reduction, within the framework of the UN Children's Fund in Kazakhstan (UNICEF) project "Development of unmanned aircraft to ensure the safety of territories and the population, including vulnerable groups from emergencies and disasters for 2021", conducted a training in Kokshetau on the use of unmanned aerial vehicles in the interests of preventing and eliminating natural and man-made emergencies. The training was held for cadets of the 2nd and 3rd courses of the Academy of Civil Protection named after M. Gabdullin of the Ministry of Emergency Situations of the Republic of Kazakhstan, in which, along with citizens of Kazakhstan, cadets from Kyrgyzstan are trained. The training consisted of theoretical and practical parts, as well as exercises on post-flight processing of UAV data using special software that allows processing the results of aerial photography of the area both in the visible spectrum and made with a multispectral camera. The result of the training was the training of 74 cadets of the Civil Aviation Department of the Ministry of Emergency Situations of the Republic of Kazakhstan in the management of UAVs, the creation of high-quality orthophotomaps, three-dimensional models of buildings, digital terrain and relief models.



2021 year

NOVEMBER 05: The next Regional Forum - Meeting of the Heads of Emergency Departments of the Central Asian countries was held in Tashkent.

This high-level event took place on November 4-5, 2021 as part of the UNSDDR initiative “Building resilience to disasters and accelerating the implementation of the Sendai Framework for DRR in Central Asia”, funded by the European Union.

More than 50 people took part in the work of the Regional Forum - delegations headed by the heads of emergency departments of the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan and the Republic of Uzbekistan, representatives of UN agencies, donor, international and non-governmental organizations.

During the Regional Forum, the following documents were discussed and approved:

- Strategy for the development of cooperation between the countries of Central Asia in the field of disaster risk reduction for 2022-2030.

- Regional characteristic (profile) of disaster risk in Central Asian countries.
- Regulations “On the Regional Coordination Mechanism for Response to Emergencies”.
- A plan of practical measures (roadmap) for the implementation of the Strategy for the Development of Cooperation between the Countries of Central Asia in the field of disaster risk reduction for 2022-2023.
- The concept of the use of unmanned aerial aircraft in order to reduce the risk of disasters, prevent and eliminate emergency situations in the countries of Central Asia.

The heads of emergency departments of the Central Asian countries noted the relevance of the issues submitted for consideration by the Regional Forum, the need to use innovative information and communication technologies in the field of disaster risk reduction.

In his speech, the Minister of Emergency Situations of the Republic of Kazakhstan, Major General Ilyin Yury Viktorovich, drew the attention of the Regional Forum participants to the need to develop an early warning system in case of an earthquake, which would ultimately allow to combine the scientific potential and practical actions to develop a network of seismic sensors for early warning of the population in Central Asia.





2021 year

NOVEMBER 24-26: The European Forum on Disaster Risk Reduction was held in Matosinhos, Portugal, which was attended by delegations of emergency departments from Europe, Central Asia and the South Caucasus, as well as representatives of many international organizations.

The Director of the Center as a speaker took an active part in the work of the sessions "Disaster risk management", "INFORM subnational risk index in Europe and Central Asia" as well as in the panel discussion on the adoption of the EFDR Roadmap for 2021-2030. "Acceleration of the implementation of the Sendai Framework Program", during which the results of the Regional Forum-Meeting of the Heads of Emergency Situations of the Central Asian countries (November 4-5 this year in Tashkent) were announced, namely the approval of the Strategy for the development of cooperation between the Central Asian countries in DRR for 2022-2030, the Plan of practical measures for the implementation of the Strategy and other documents.

As a result of the Forum, a Declaration (Communique) of stakeholders at a high level was signed.

Within the framework of the Forum, the Director of the Center held a meeting with the Special Representative of the UN Secretary General for DRR, Ms. Mami Mizutori, during which they discussed the development and strengthening of regional cooperation in the DRR of the Central Asian countries in order to assist in achieving the Sendai Framework Program, and received support in attracting investments to increase the resilience of the region to disasters.



2021 - MAIN RESULTS OF THE CENTER

- ◆ Organizational support continues for the work of the Working Group of Experts of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan and the Ministry of Emergency Situations of the Kyrgyz Republic on the implementation of joint coordinated measures to integrate early warning systems for earthquakes in the Republic of Kazakhstan and the Kyrgyz Republic. This year, two meetings of the joint working group of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan, the Ministry of Emergency Situations of the Kyrgyz Republic and the Center were held on February 09, 2021 on the basis of the Department of Emergency Situations in Almaty and on May 18, 2021 in Bishkek on the basis of the Central Asian Institute of Applied Geosciences.
- ◆ Work continues on the collection, compilation, analysis and exchange of information on the situation, problems, needs and requests of the countries of Central Asia to respond to and eliminate the consequences of the spread of the coronavirus COVID-19 at the national and regional levels, including through:
 - Development and dissemination to stakeholders of the daily "Up-to-date information on the situation with the spread of the COVID-19 pandemic in the countries of Central Asia";
 - Holding Regional Consultative and Advisory Meetings with representatives of regional and subregional offices of international and non-governmental organizations to discuss issues of disaster risk reduction, emergencies and the COVID-19 pandemic in the countries of Central Asia.
- ◆ On an ongoing basis, the Center organizes and conducts work on the collection, generalization, analysis and exchange of operational information in the field of emergency situations through the development and communication to stakeholders of the daily "Operational information on emergency situations in the Republic of Kazakhstan and the Kyrgyz Republic".
- ◆ At the initiative of the Center and ICDO, since 2018, organizational support has been provided to establish cooperation and interaction between the diving services of Kazakhstan and Kyrgyzstan. In 2021, with the direct support of the Center and the ICDO, the diving service of the Ministry of

Emergency Situations of the Kyrgyz Republic and the Russian Federation conducted training to improve the skills of diving services specialists of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan on the basis of a water rescue station in the city of Priozersk, Kazakhstan. Based on the results of the training, 25 rescue divers were awarded international certificates of the IGO and qualification documents of divers of groups 1-2, 10 divers were awarded international certificates "Master Trainer", who in the future will be able to train their colleagues as trainers. In addition, the Republican Rescuer Training Center in Priozersk is certified by the ICDO and received the status of an international Rescuer Training Center.

- ◆ The Center, together with the UN Office for Disaster Risk Reduction in order to contribute to the achievement of the Global Targets identified by the Sendai Program for Disaster Risk Reduction for 2015-2030 and within the framework of the project "Strengthening regional cooperation and facilitation of the implementation of the Sendai Program for Disaster Risk Reduction in Central Asia" conducted 8 instructive and methodological sessions this year to monitor the implementation of the Sendai Framework Program for Disaster Risk Reduction for 2015-2030 to representatives of state structures of the countries of Central Asia.
- ◆ The Center, together with UNICEF in the Republic of Kazakhstan, carried out a number of activities to develop unmanned aircraft in order to ensure the safety of territories and the population, taking into account the interests of vulnerable groups. Established zonal emergency response teams using UAV capabilities.
- ◆ Within the framework of the UNSDRR Initiative "Increasing resilience to disasters and accelerating the implementation of the Sendai Framework for Disaster Risk Reduction in Central Asia", funded by the European Union, on November 05 in Tashkent, under the chairmanship of the Uzbek side, a high-level event was held - the Regional Forum-Meeting of the heads of emergency departments of the countries of Central Asia.
- ◆ At the initiative of the Center, with the technical and financial support of international organizations, three meetings of the Working Group (experts) of the Regional Forum - Meeting of the Heads of Emergency Departments of the Central Asian countries were organized and held:
 - In July 2021 in the city of Tashkent, under the chairmanship of the Uzbek side.
 - In September 2021 online, chaired by the Uzbek side.
 - In October 2021 online, chaired by the Uzbek side.
- ◆ The Center, by attracting investments in the form of grant funds from donor agencies and international organizations, as an executing agency, has implemented the following projects this year in the field of strengthening regional cooperation, disaster risk reduction and emergency prevention:
 - 1) UNICEF project in the Republic of Kazakhstan - "Development of unmanned aircraft in order to ensure the safety of territories and the population, including vulnerable groups from emergencies and disasters":
 - the first phase of the implementation period 2018-2019,
 - the second phase, the implementation period is 2020,
 - the third phase, the implementation period is 2021;
 - 2) Project with IOGO "Advanced training of rescue divers of the Ministry of Emergency Situations of the Republic of Kazakhstan" - Implementation period: May-June 2021.
 - 3) MEPACTION Project "Geoinformation Systems, Mapping and Working with Data". Implementation period: 2019-2021;

4) FAO project in the Kyrgyz Republic "Strengthening the capacity for disaster risk reduction and preparedness in the agricultural sector, implementation period 2019-2021;

5) UNISDR Project "Strengthening Regional Cooperation and Facilitating the Implementation of the Sendai Program in Central Asia". Implementation period: 2019-2022;

6) ADB project "Training and Capacity Building. Actualization of disaster risk management in public institutions of the Republic of Tajikistan". Implementation period: 2021.

7) UNDP project "Strengthening the capacity of integrated risk management in the Kyrgyz Republic and regional cooperation in Central Asia". Implementation period: 2021.

- ◆ The Center, together with international and non-governmental organizations, scientific institutions, with their technical and financial support, prepared and held 35 international events (conferences, forums, seminars, trainings, meetings, meetings) in the field of disaster risk reduction and emergency situations.
 - ◆ 1226 people took part in these events, exchanged experience, gained new knowledge, improved their skills in the field of disaster risk reduction and emergency situations, including:
 - o 200 representatives of state bodies of the Republic of Kazakhstan.
 - o 183 representatives of state bodies of the Kyrgyz Republic.
 - o 133 representatives of state bodies of the Central Asian countries and other states.
 - o 31 representatives of scientific institutions and independent experts.
 - o 679 representatives of international and non-governmental organizations.
- 1 meeting of the Council of the Center was held.
 - 6 meetings of the Regional Scientific and Technical Council were held.

FEBRUARY 18-28: The Center for Emergency Situations and Disaster Risk Reduction, together with the UN Office for Disaster Risk Reduction, in order to contribute to the achievement of the Global Targets identified by the Sendai Program for Disaster Risk Reduction for 2015-2030 and within the framework of the project "Strengthening Regional Cooperation and Facilitating the Implementation of the Sendai Program for Disaster Risk Reduction in Central Asia" conducted instructional and methodological sessions on monitoring the implementation of the Sendai Framework Disaster risk reduction programs for 2015-2030 for representatives of government agencies of Central Asian countries:

- February 18, 2022 - training for representatives of Turkmenistan. Employees of the Ministry of Defense and the National Statistical Committee of Turkmenistan took part.
- February 22, 2022 - training for representatives of the Republic of Uzbekistan. Employees of the Department for the Prevention of Emergency Situations of the Ministry of Emergency Situations, the National Statistical Committee of the Republic of Uzbekistan took part.
- February 26, 2022 - training for representatives of the Republic of Kazakhstan. Employees of the Emergency Prevention Department of the Ministry of Emergency Situations of the Republic of Kazakhstan took part.
- February 28, 2022 - training for representatives of the Kyrgyz Republic. Employees of the Ministry of Emergency Situations of the Kyrgyz Republic took part.

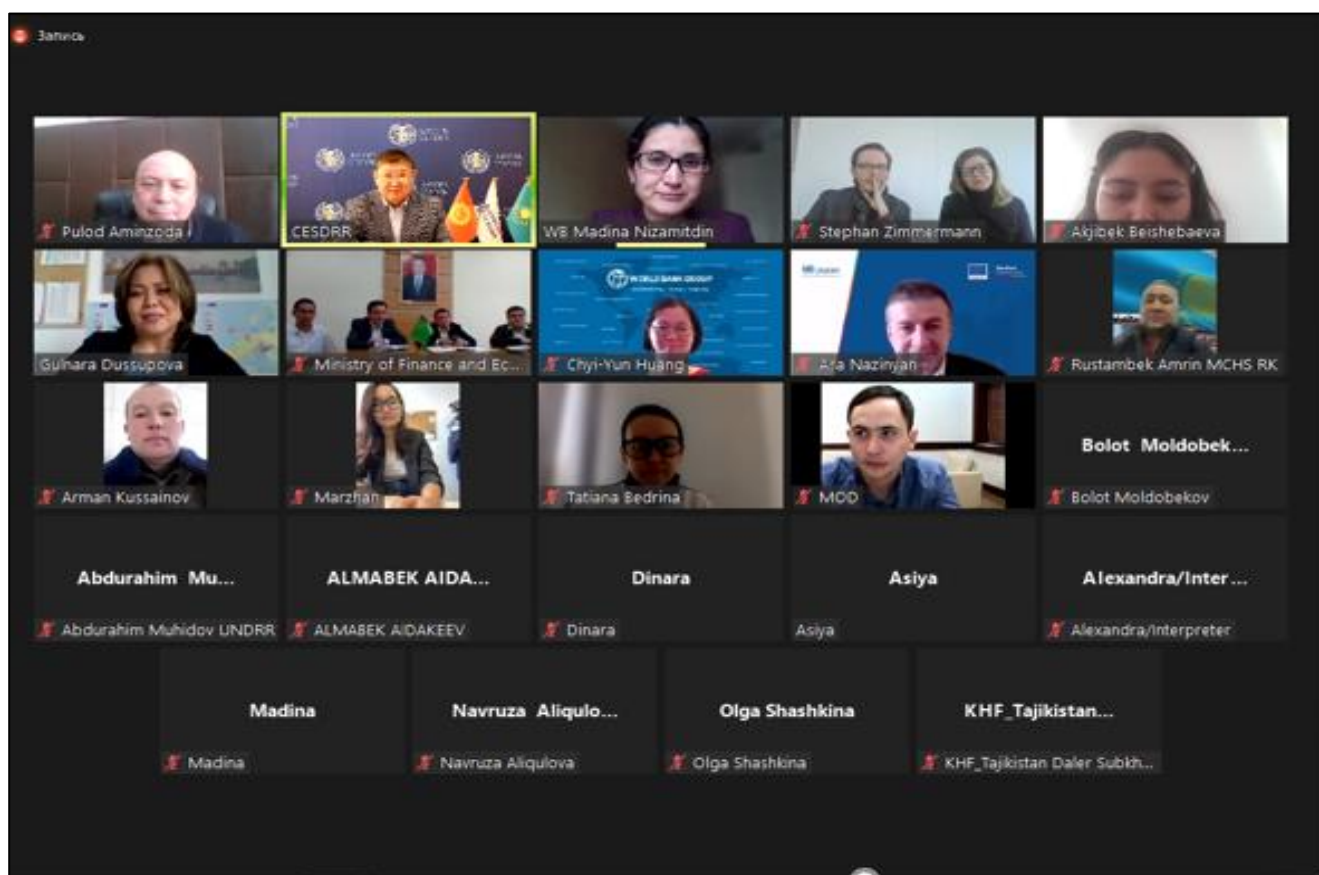

MAY 04: A bilateral meeting was held at the Center for Emergency Situations and Disaster Risk Reduction with representatives of the World Bank Regional Office for Europe and Central Asia.

The World Bank Senior Specialist for Urban Development and Disaster Risk Management, Ms. Chi Yun Huang, was introduced to the activities of the Center, strategic directions and priorities for the current year, the results achieved over the years of the Center's existence.

During the meeting, an exchange of views took place on the most pressing issues of bilateral cooperation between the Center and the World Bank. Ms. Chi Yun Huang confirmed the readiness of the World Bank to continue expanding dialogue and interaction with the Center, including in terms of the practical implementation of joint projects in the field of DRR and emergency situations. As a result of the meeting, the parties reached a complete understanding on all issues.

The Center, together with a partner, the British non-governmental organization MapAction, conducted trainings on the use of GIS technologies and mapping in emergency situations in a hybrid mode:

- From 25 to 29 April - training for specialists of the Ministry of Emergency Situations of the Republic of Uzbekistan. 23 employees of the central office and territorial divisions of the Ministry of Emergency Situations of the Republic of Uzbekistan took part.

- From May 16 to May 20 - training of specialists of the Ministry of Emergency Situations of the Republic of Kazakhstan. 25 employees of the central office and territorial divisions of the Ministry of Emergency Situations of the Republic of Kazakhstan took part.
- From May 23 to May 27, 2022 - training for representatives of the Ministry of Emergency Situations of the Kyrgyz Republic. Employees of the Ministry of Emergency Situations of the Kyrgyz Republic took part.

MapAction specialists have prepared a training course with presentation materials and video tutorials on using all the features and tools of the QGIS geoinformation program. Based on the results of daily tests and the completion of simulation tasks, participants were awarded certificates of successful completion of the mapping training.



2022 year

24 to 27 MAY: Delegation of the Central Chechen Republic of Belarus consisting of Deputy Director Aubakirov S.G. and chief expert Ospanov B.M. took part in the Seventh Session of the Global Platform for Disaster Risk Reduction, organized by the United Nations Office for Disaster Risk Reduction and the Government of the Republic of Indonesia on the island. Bali (Indonesia).

The Official Opening Ceremony of the event was attended by President of Indonesia Mr. Joko Widodo, Under-Secretary-General of the UN Ms. Amina Mahhamed and Special Representative of the UN Secretary-General for DRR Ms. Mami Mizutori.

As part of the work of the 7th Session of the Global Platform, the delegation of the Center took part in a trilateral meeting with the Head of the Regional Office for Europe and Central Asia, UNISDR, Mr. Octavian Bivol, the head of the delegation of the Ministry of Health of the Republic of Kazakhstan, Mr. Grigoryan A.S.

and National Coordinator of the Republic of Kazakhstan for the implementation of the Sendai Framework Program Mr. Amrin R.

On May 26, a bilateral meeting was held between the Deputy Director Aubakirov Serik Gabdullovich and the Secretary General Ms. Nzhupuo Yap Mariatu.

The participants of the meeting highly appreciated the joint project for the training of rescue divers of the Ministry of Emergency Situations of the Republic of Kazakhstan, outlined and discussed a plan for further work on the training of canine services of emergency departments of the Central Asian countries this year and expressed their readiness to continue training for rescue divers next year with the involvement of participants from African and Arab countries.

During the meeting, Ms. Nzhupuo Yap Mariatu was informed about the steps taken by the Center to integrate the early warning system for disasters at the level of the CA region. The Center invited ICDO to act as a donor for this creative and high-tech project. Ms. Nzhupuo YAP Mariatu showed a noticeable interest in this information and asked to officially send this initiative from the Center to ICDO.

The final document was signed - the protocol of the bilateral meeting.

On May 27, the chief expert of the Center Ospanov B.M. took part in the Session on the topic: "Subnational risk index of the region of South-Eastern Europe". Within the framework of this session, Ospanov B.M. made a presentation on the topic: "The experience of the Center for Emergency Situations and Disaster Risk Reduction in the implementation of the project "Subnational Risk Index of Central Asia and the Caucasus"". It should be noted that more than 7 thousand participants from 92 countries of the world registered to participate in the 7th Session of the Global Platform for Disaster Risk Reduction, 79% of which took part offline.



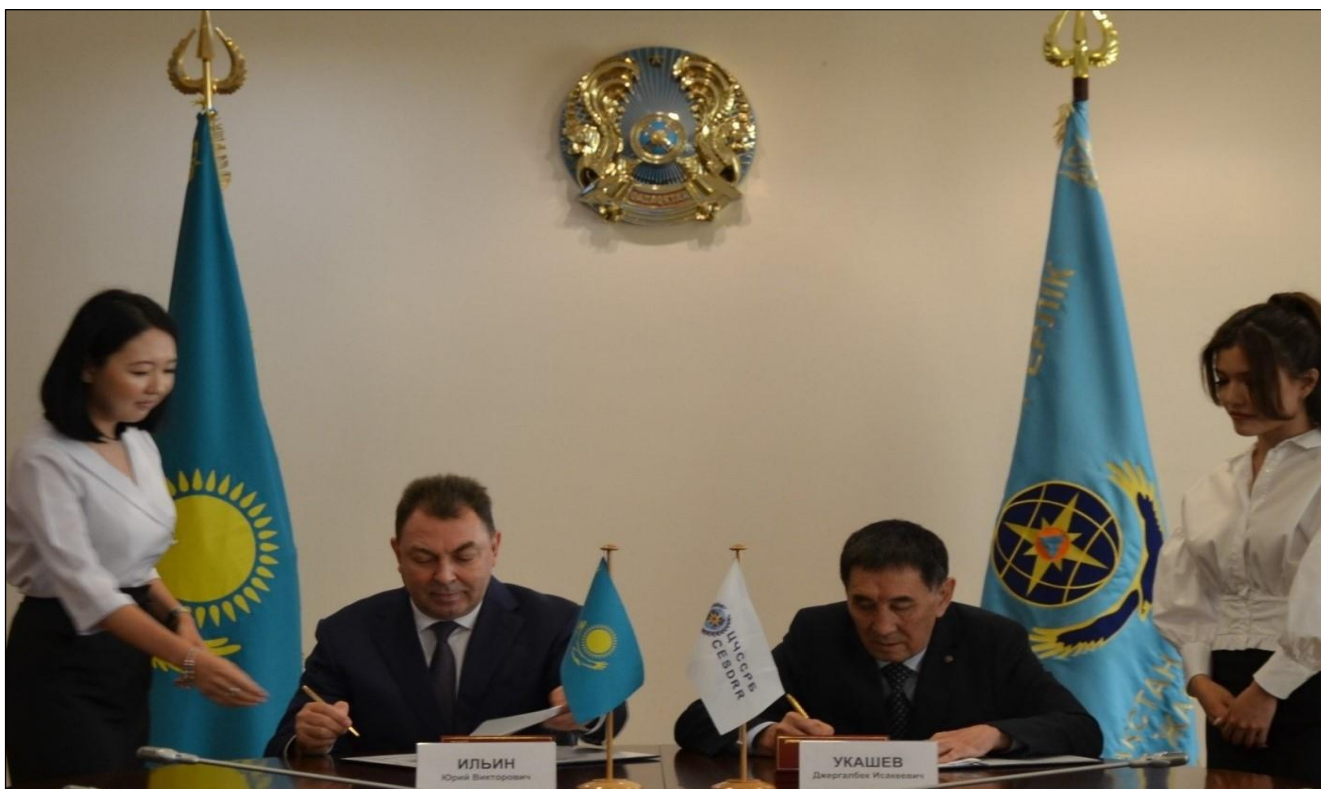

JUNE 20: A bilateral meeting of the Center with representatives of the Asian Disaster Reduction Center in Kobe, Japan (ADRC) took place online.

During the meeting, Mr. Masaki Nakagawa, ADRC Executive Director, was acquainted with the activities of the Center, strategic directions and priorities, results achieved over the years of the Center's existence. In addition, the Center's executive partner, Altair Uyzbaev, director of I2NIK LLP, demonstrated a Prototype of regional integration of emergency monitoring systems in Central Asian countries.

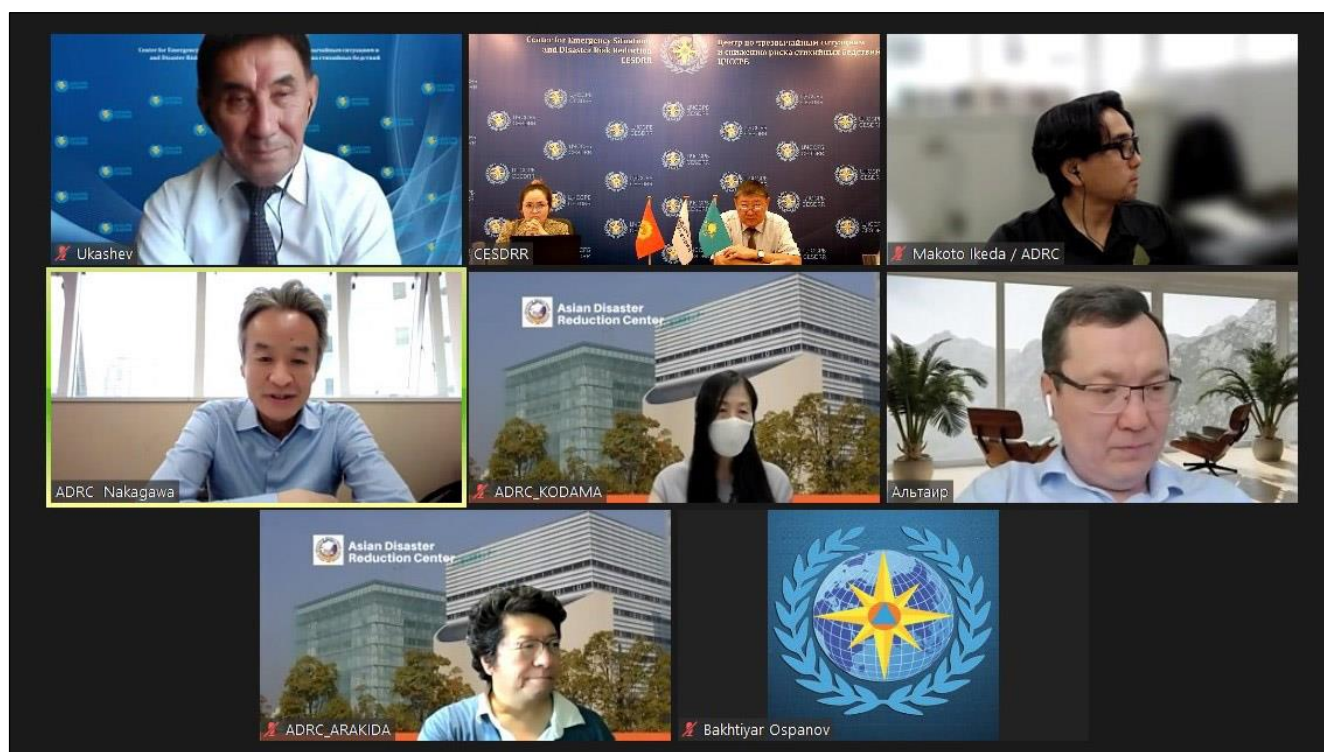
In general, it is proposed to establish interaction and cooperation between the Center and ADRC in two directions:

2022 year

From 16 to 18 JUNE: On the basis of the Center for Emergency Situations and Disaster Risk Reduction in Almaty, the Ministry of Emergency Situations of the Republic of Kazakhstan, together with the Institute of Seismology of the Ministry of Emergency Situations of the Republic of Kazakhstan, organized an international scientific and practical conference "Modern methods for assessing seismic hazard and earthquake prediction", which was attended by scientists from more than 92 countries, including the USA, Japan, China, Russia, Kyrgyzstan, Tajikistan and Uzbekistan.

During the conference, more than 60 reports and scientific articles on problematic issues in the field of seismology and early warning of a devastating earthquake were presented.

The main purpose of the conference was to assist scientists, specialists, organizations and emergency departments in establishing contacts, exchanging experience, scientific, technical and commercial information, as well as expanding and strengthening scientific ties between scientists.

The work of the conference was held in three sections, these are new methods for assessing seismic hazard, collecting, processing, analyzing seismic data and predicting earthquakes, assessing the reliability of buildings and structures (certification) and seismic amplification of objects. The event program also included a visit to the Medeo seismic station-observatory.



2022 year

JUNE 23: The UN Office for Disaster Risk Reduction, with the support of the governments of Kazakhstan, Kyrgyzstan and Tajikistan, hosted the Regional Introductory Meeting on Enhancing Urban Resilience (RSR 2030) at the Center for Emergency Situations and Disaster Risk Reduction in Almaty.

The meeting was attended by representatives of local authorities of Central Asian countries, UNISDR experts, national technical specialists. The participants of the meeting got acquainted with the concepts of DRR in cities, with the global initiative "Increasing the resilience of cities 2030", with the INFORM sub-regional index for the countries of Central Asia as a source of information on known risks in the region, with tools for assessing and analyzing resilience (Scorecard) and developing local DRR strategies.

During the event, representatives of the participating cities of Kazakhstan, Kyrgyzstan and Tajikistan exchanged best practices.

The seminar was held with the aim of involving these cities in cooperation to develop recommendations for integrating the principles of safe development.



2022 year

JULY 13-14: The OSCE Regional Consultation Seminar on Climate Change and Security in Central Asia was held in Almaty, the seminar was attended by more than 50 participants from government and civil society organizations of Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan, as well as international organizations.

The regional seminar is organized within the framework of the OSCE project “Strengthening the response to security risks associated with climate change in South-Eastern Europe, Eastern Europe, the South Caucasus and Central Asia”.

The initiative was aimed at discussing the problems of climate change and security in the region, as well as identifying opportunities for regional cooperation and joint action to address these problems.

The Center took an active part in the work of the session "Starting points for cross-border cooperation in Central Asia" in terms of presenting to the participants the Center's initiative to create a Central Asian regional emergency early warning system in order to increase the region's resilience to natural disasters..



2022 year

JULY 13-14: In Almaty, the International Federation of the Red Cross in Central Asia (IFRC) organized and hosted a workshop for the National Red Crescent Societies of Central Asia under the UNSDDR project “Increasing the resilience of vulnerable communities through community-based disaster risk reduction in Central Asia”.

During the event, 5 National Red Crescent Societies, including Turkmenistan, presented their achievements, lessons learned and challenges over the two-year period of this project.

In her opening speech, Seval Guzelkylynch, Head of the IFRC office in Central Asia, noted the role of the Center in ensuring the coordination of the potentials and resources of states and international organizations in the field of disaster risk reduction in Central Asia.

Within the framework of the seminar, the Disaster Preparedness Mechanisms and measures to mitigate the consequences (structural and non-structural) existing and operating at the community level were presented.



2022 year

JULY 29: In Bishkek, the Ministry of Emergency Situations of the Kyrgyz Republic and the Center for Emergency Situations and Disaster Risk Reduction, with the support of UNDP and WFP in Kyrgyzstan, organized an expanded meeting of the interdepartmental working group to discuss the 2nd stage (2023-2026) of the implementation plan for the Concept of Comprehensive Protection of the Population and Territory of the Kyrgyz Republic from Emergencies for 2018-2030.

This event was attended by experts from ministries and departments, members of the interdepartmental working group, representatives of international and non-governmental organizations.

The purpose of the meeting of the working group was to discuss and agree on the plan for the 2nd stage of the implementation of the Concept for 2023-2026 and to discuss the mid-term review of the implementation of the Sendai Framework for Disaster Risk Reduction for 2015-2030.

The main goal of this Concept is to establish long-term priorities for the development of the state system of Civil Protection to ensure the safety of the population and territories of the country from emergencies and disasters in order to create conditions for the sustainable development of the country.

Development of an Action Plan for the implementation of the DRR Strategy for 2023-2026. is carried out with the support of UNDP and WFP in Kyrgyzstan, within the framework of which the Ministry of

Emergency Situations of the Kyrgyz Republic and the Center for Emergency Situations and Disaster Risk Reduction conducted a detailed analysis and assessment of the implementation of the first stage of the Action Plan for the implementation of the Concept in the period from 2018 to 2022 (first stage) and developed a Plan for the second stage (2023-2026), which is subject to agreement with all stakeholders..



2022 year

AUGUST 5: A meeting of the Working Group (experts) of the Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries was held via videoconference.

The experts of the Central Asian countries discussed and agreed on the draft documents proposed for discussion at the upcoming Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries in October 2022:

1. Implementation of the Plan of Practical Measures (Roadmap) for the implementation of the Strategy for the Development of Cooperation between the Central Asian Countries in the Field of DRR in 2022 and the Plan of Practical Measures for 2023-2024. progress and plans.
2. Mid-term review of the implementation of the Sendai Framework for DRR in the countries of Central Asia.
3. Strengthening the resilience of Central Asian countries to climate change.
4. On measures to create a regional system of early warning and mutual information about the threat and the occurrence of emergency situations.
5. On measures to introduce innovative information and communication technologies in order to reduce the risk of disasters.
6. Cooperation on DRR in Central Asia in 2023: alignment of international programs with national and regional priorities.
7. Modern and innovative methods for monitoring glaciers, snow cover and outburst glacial lakes under climate change.
8. Cooperation on DRR and climate change in Central Asia in 2023: alignment of international programs with national and regional priorities. Risk of technogenic and anthropogenic disasters.

The solution of these issues in the future provides for the coordination of actions to strengthen regional cooperation in the field of DRR, combat climate change and emergency situations, implement the Sendai Program for DRR and the Strategy for the Development of Cooperation between the Central Asian Countries in the Field of DRR for 2022-2030, create early warning systems and mutual information about the threat and occurrence of emergencies.

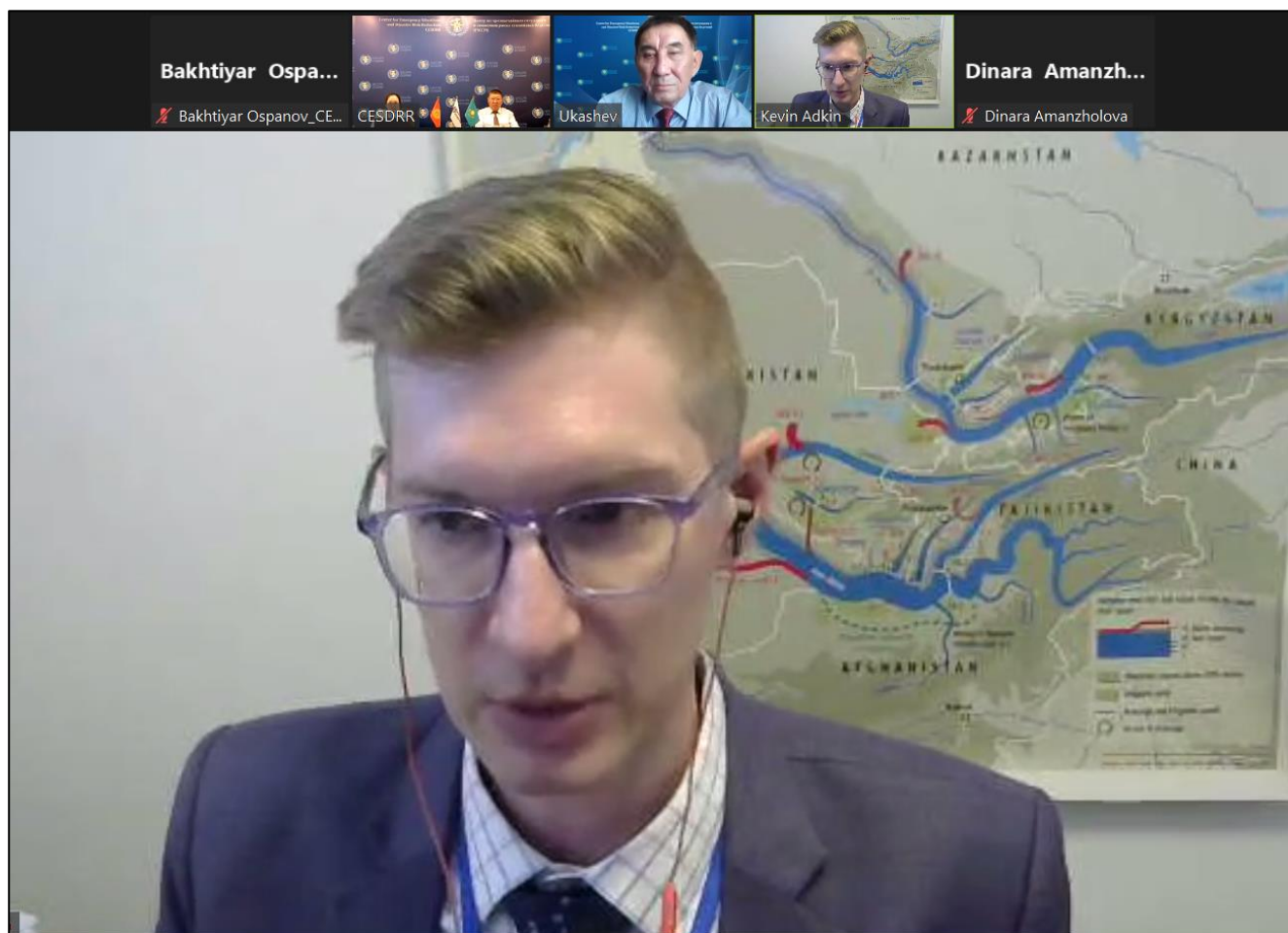
18 АВГУСТА: в онлайн режиме состоялась двусторонняя встреча Центра с Региональным офисом USAID в Центральной Азии.

In the period from **7 to 18 SEPTEMBER**: A ten-day master training was held for the canine services of the emergency departments of the Central Asian countries, organized by the Center with the technical and financial support of the ICDO. Experienced cynologists of the Ministry of Emergency Situations of the Russian Federation are invited as trainers. During the master training, 30 canine crews of the Ministry of Emergency Situations of Kazakhstan, and 2 crews each of the Ministry of Emergency Situations of Kyrgyzstan, the CoES of Tajikistan and the Ministry of Emergency Situations of Uzbekistan underwent theoretical and practical training according to a special program, improved their skills in training service dogs, confirmed their professional readiness to search and rescue people under various natural and man-made emergencies.

As a result of the training course, cynologists from the Central Asian countries received appropriate international certificates.

In addition, the Center held a lesson - a master training on demonstrating the effective use of UAVs in the prevention and elimination of the consequences of emergencies of various kinds, based on the experience of the Center gained through participation in search and rescue operations and projects with UNICEF and the OSCE.

From 5 to 9 SEPTEMBER: The Aga Khan Development Network (AKDN) in Kyrgyzstan, within the framework of the Naryn City Resilience Strengthening Program (NURP), with the technical support of the Center, organized and conducted a coordination meeting to conduct a comprehensive environmental assessment of the city of Naryn.

The event was attended by representatives of the Aga Khan Agency for Habitat (AKAH) in Tajikistan, specialists from the Naryn Resilience Strengthening Program (NURP), experts in hydrology, geology, soil science, forestry, geobotany, social sciences and GIS.

During the coordination meeting, the goals and objectives of the program, the methodology for a comprehensive environmental assessment were discussed, the timing of the implementation of activities was determined, the technical tasks and work plans of the expert groups were agreed.

8 СЕНТЯБРЯ: SEPTEMBER 8: The International Federation of the Red Cross and Red Crescent Society (IFRC) hosted an online Regional Presentation on Implementing the Legal and Public Health Emergency Preparedness and Response Guidelines.

The Director of the Center, Mr. Jergalbek Ukashev, was invited by the leadership of the IFRC as a participant in the discussion on the topic: how legal preparedness for public health emergencies will help build regional cooperation in Central Asia. The event was also attended by representatives of WHO regional and country offices in Central Asia, UNISDR Regional Office, disaster risk management and health authorities, National Red Crescent Societies, as well as humanitarian, development and public health stakeholders in region. The participants of the event exchanged views on the experience of Central Asia in the field of legal preparedness for COVID-19.

The regional presentation was held to provide Central Asian governments, National Red Crescent Societies, and humanitarian, health and development partners with guidance on how to improve legal preparedness for public health emergencies.

19 SEPTEMBER: Head of the OSCE Program Office in Astana, Mr. Volker Frobart visited the Center and met with the management of the Center. During the working meeting, Mr. Frobart was briefly informed about the work done within the framework of the joint project of the OSCE and the Center.

Taking into account the results obtained during the implementation of the joint project, the prospects for further cooperation for 2023 were discussed.

In addition, the Center submitted 3 project proposals in the field of disaster risk reduction and adaptation to climate change for consideration by the leadership of the OSCE Office in Astana.



SEPTEMBER 21: 2022, a working meeting was held at the Center for Emergency Situations and Disaster Risk Reduction by the Deputy Resident Representative of the United Nations Development Program (UNDP) in Kazakhstan, Mr. Sukhrob Khodjimatov, with the leadership of the Center.

During the working meeting, Mr. Khodzhimatov got acquainted with the activities of the Center, strategic directions and priorities, the results achieved over the years of the Center's operation. In addition, the prospects for further cooperation for 2023-2024 were discussed.

In addition, during the meeting, project proposals of the Center in the field of disaster risk reduction and adaptation to climate change were presented.

UNDP Deputy Resident Representative in Kazakhstan Mr. Khodzhimatov praised the results of the Center's activities in the field of disaster risk reduction and the comprehensive approach of the Center to various disaster risks..



4 ОКТЯБРЯ: OCTOBER 4: Within the framework of the Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries in Dushanbe (Republic of Tajikistan), an expanded meeting of the Regional Scientific and Technical Council for Emergency Situations (RSTC) was held with the participation of the national coordinators of the Sendai Framework Program for DRR, the countries of Central Asia and representatives of international organizations.

The extended meeting of the RNTS is organized by the Government of the Republic of Tajikistan with the support of the United Nations Office for Disaster Risk Reduction, the World Bank and the Center.

During the meeting, the results of a new regional risk assessment for Central Asia were presented, as well as reports on individual countries on improving the social protection system in them. Also, round tables were held where members of the RNTS - representatives of Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan discussed issues of preparedness for emergencies and mitigation of their consequences through disaster risk financing.

In addition, the role of the RNTS in strengthening the disaster risk management system in the region was discussed.

In addition, participants were introduced to additional disaster risk assessment models initiated by other development partners in the region (ADB.).



OCTOBER 5: In Dushanbe, under the chairmanship of the Tajik side, a meeting of the Working Group (experts) of the Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries was held.

The event was organized by the Center for Emergency Situations and Disaster Risk Reduction, with the support of the CoES under the Government of the Republic of Tajikistan.

The experts of the Central Asian countries discussed and agreed on the draft documents proposed for discussion at the upcoming Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries:

1. Review of the implementation of the Action Plan (Roadmap) for the implementation of the Strategy for the development of cooperation between the Central Asian countries in the field of DRR in 2022.
2. Draft Action Plan (Roadmap) for the implementation of the Strategy for the development of cooperation between the Central Asian countries in the field of DRR for 2023–2024.
3. Draft Regulations on the Regional System of Early Warning and Mutual Information on the Threat and Emergency Situations.
4. Draft Action Plan for the introduction of innovative information and communication technologies (GIS, UAVs, mapping) in the countries of Central Asia for the purpose of monitoring, forecasting, assessing and analyzing disaster risk.

These documents have been developed taking into account the proposals of international organizations and are aimed at implementing practical measures to develop and deepen regional cooperation in the field of disaster risk reduction and strengthening preparedness to respond to emergencies, especially of a transboundary nature, and also provide for issues of improving information exchange, joint assessment of factors disaster risk reduction, implementation of programs and projects in the field of disaster risk reduction and adaptation to climate change, improving awareness of existing and emerging risks, further development, transition to a new, better level of regional cooperation of the CA countries in the field of DRR and emergencies..



OCTOBER 6: The Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries was held in Dushanbe. More than 70 people took part in the work of the Regional Forum - delegations headed by the heads of emergency departments of the Republic of Kazakhstan, the Republic of Tajikistan, Turkmenistan and the Republic of Uzbekistan, representatives of UN agencies, donor, international and non-governmental organizations.

Opening the Regional Forum, the Chairman of the CoES under the Government of the Republic of Tajikistan, Colonel-General Nazarzoda Rustam Urmanovich noted that the results of the Forum will give a new impetus to the dynamic and harmonious development of joint cooperation between the countries of the region in the field of disaster risk reduction.

"Involving such a wide range of stakeholders in the field of disaster risk reduction contributes to the further development of a constructive dialogue, the exchange of information and experience, and the strengthening of regional cooperation in the field of disaster risk reduction," he stressed.

In his speech, Deputy Prime Minister of the Republic of Tajikistan Sulaimon Ziyozoda noted the importance of holding this event. "The organization and holding of this Forum, with the participation of high-level representatives and experts, is a continuation of the efforts of our countries to mitigate the negative effects of climate change and, in particular, natural disasters, which will allow us to intensify our efforts in this area," the Deputy Prime Minister emphasized.

The heads of emergency departments of the Central Asian countries noted the relevance of the issues submitted for consideration by the Regional Forum, the need to use innovative information and communication technologies in the field of disaster risk reduction.

In his speech, the Minister of Emergency Situations of the Republic of Kazakhstan, Lieutenant-General Ilyin Yuri Vitasovic, noted that the Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries is a very important and significant event for the region in terms of strengthening cooperation in the field of disaster risk reduction and emergency management.

Lieutenant General Ilyin Yu.V. noted that "... One of the important directions in the implementation of the Strategy for the Development of Cooperation between the Countries of Central Asia in the Field of Disaster Risk Reduction for 2022-2030 is the implementation of measures to integrate early warning systems and alerts about the threat of emergency situations ..." and called for the approval of the submitted for consideration by the heads of delegations emergency departments Regulations on the Regional System of Early Warning and Mutual Information on the Threat and Emergencies and the Protocol of Intentions on the Integration of Earthquake Early Warning Systems, developed at the initiative of the Ministry of Emergency Situations of the Republic of Kazakhstan. He emphasized that "... This step would be evidence of our aspirations to achieve the global objectives of the Sendai DRR Program and a response to the call of the seventh session of the UN Global Platform for Disaster Risk Reduction in Indonesia, voiced by Ms. Mami Mizutori, about the need to ensure accessibility for the entire population of the Earth to the early warning system..."

The Minister of Emergency Situations of the Republic of Uzbekistan, Major General Kuldashv Abdulla Khamidullaevich drew the attention of the participants of the Regional Forum to the environmental problems of the Aral Sea region and measures to mitigate the consequences of the drying up of the Aral Sea. He noted that "... the Republic of Uzbekistan is taking a set of measures to improve the environmental situation in the Aral Sea zone. In particular, forest reclamation activities are being carried out on an area of 1 million 679 thousand hectares...". Major General Kuldashv A.Kh. drew the attention of the participants of the Regional Forum to the disasters associated with climate change: the melting of glaciers, the threat of outburst of high mountain lakes, low water and others. He also noted the importance of seismic safety and informed the participants of the Regional Forum about the measures taken in the Republic of Uzbekistan on this issue.

The head of the Department of Civil Defense of the Ministry of Defense of Turkmenistan, Mr. Annagurdov Merdan, noted the importance of coordinating the activities of the emergency departments of the countries of the region, international and non-governmental organizations, and other interested parties in the implementation of disaster risk reduction measures..

The head of the Office for Europe and Central Asia of the UN Office for Disaster Risk Reduction, Mr. Octavian Bivol, thanking the Government of the Republic of Tajikistan for the organized meeting, stressed that the

UN will continue to pay special attention to addressing issues related to the risk of natural disasters. In particular, Mr. Bivol said: "... the UN Office for Disaster Risk Reduction will provide further support to build resilience to natural disasters and climate change in Central Asia."

Speaking to the Forum participants, the EU Special Representative for Central Asia, Ms. Terry Hakala, noted the importance of the problem related to the risks of natural disasters, which must be addressed together. During the Regional Forum, special attention was paid to the issues of international cooperation in the field of disaster risk reduction. In particular, a number of events took place within the framework of the forum - breakout sessions, reports of the heads of foreign delegations. The participants discussed issues of further implementation of the Sendai Framework Program in the countries of the region, studying the experience of countries in the aftermath of major natural disasters and the recovery process, an inclusive approach, cross-border cooperation and attraction of investments in the field of disaster risk reduction within the framework of the implementation of the Sendai Framework Program in the countries of the region.



2022 year

27 OCTOBER: within the framework of a working trip to Almaty, the Center was visited by the First Deputy Minister of Foreign Affairs of the Republic of Kazakhstan Umarov Kairat Ermekovich.

During the visit, Mr. Umarov K.E. got acquainted with the activities of the Center, listened to a report on implemented and ongoing projects, as well as on the planned activities of the Center in the field of disaster risk reduction in Kazakhstan and the Central Asian region.

The First Deputy Minister of Foreign Affairs of the Republic of Kazakhstan emphasized the relevance of further development of regional and international cooperation in the field of disaster risk reduction, taking into account active climate change.

He approved the course towards the coordination of joint efforts aimed at strengthening resilience and preparedness for an effective and timely response to emergencies, using the resource of the Forum of the Ministers of Emergency Situations of the Central Asian countries as the main coordination mechanism.

The Center received a number of recommendations for further work, including the development of the use of innovative information and communication technologies for the tasks of preventing and responding to emergencies, and also noted the relevance of creating a regional coordination hub for emergency response in the Central Asian countries on the basis of the Center to coordinate international humanitarian and technical assistance.

Realizing the status of the Secretariat of the Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian countries, the Center should continue to accumulate and raise problems of a transboundary nature, the joint solution of which is mutually beneficial for the countries of the region.

The participants of the meeting also recognized the need to intensify joint and coordinated efforts to further expand the membership of the Center.



2022 year

NOVEMBER 2 - 4: in Astana, the specialists of the Center conducted a training for employees of the Department of Emergency Situations in Astana, the State Institution "Fire Fighting and Rescue Operations" and the Training Center of Astana of the Academy of Civil Protection of the Ministry of Emergency Situations of the Republic of Kazakhstan on the skills of using UAVs to implement prevention tasks and liquidation of emergency situations.

The training program included theoretical and practical parts, as well as exercises on post-flight processing of data obtained using UAVs using special software that allows processing the results of aerial photography from a drone.

In the course of practical training, a study tour was carried out to the territory of the Astana counter-regulator, where the specialists of the Center demonstrated how to build a 3D model of the facility, making for example a three-dimensional model of the head gateway of the counter-regulator. In addition, as part

of the practical exercises, a simulation of a search for people in a forest area near the settlement of Malaya Timofeevka was performed using an optical camera and a thermal imaging sensor. Using various color modes of the thermal imager and the capabilities of the optical camera, the participants were able to independently determine the location of the missing in the shortest possible time, thereby making sure that the use of UAVs with specialized sensors was effective when searching for people in hard-to-reach places.

Based on the results of the training, 23 employees of the Department of Emergency Situations of Astana and the Training Center of the city of Astana AGZ of the Ministry of Emergency Situations of the Republic of Kazakhstan were awarded certificates of completion of the above course.

NOVEMBER 15: A delegation from the International Federation of the Red Cross and Red Crescent Societies, headed by the head of the regional office for Central Asia Seval Guzelkilinch, visited the Center for Emergency Situations and Disaster Risk Reduction, the delegation also included the delegate for Humanitarian Diplomacy Ms. Joy Muller and the delegate Disaster Law Program Ms. Pauline Caspellan. During the meeting, the participants got acquainted with the mission, strategic and priority areas of the Center's activities, with information on the implementation of joint projects with partners in the field of civil protection, adaptation to climate change and emergency situations in the countries of Central Asia. In addition, the prospects for further cooperation for 2023-2024 were discussed.

In addition, during the meeting, project proposals of the Center in the field of disaster risk reduction and adaptation to climate change were presented.

The head of the IFRC Regional Office for Central Asia, Seval Guzelkilinch, positively assessed the results of the Center's activities in the field of disaster risk reduction and expressed interest in further cooperation and implementation of joint projects.



2022 year

24 November 2022: During the 25th Session of the General Assembly of the International Civil Defense Organization in Abu Dhabi, 48 Member States supported the proposal to make the Center an Affiliate Member of ICDO.

The transition to a new format of cooperation will significantly strengthen the interaction between the ICDO and the Center in the field of civil defense in order to reduce the risk of disasters, strengthen preparedness and ensure an effective response to emergencies.

In addition, this will allow further work and interaction with ICDOs to build in a planned manner and on a systematic basis to increase the potential of emergency response services of the countries of Central Asia..

NOVEMBER 28: Center officials attended a high-level event on building resilience to disasters and climate change in Central Asia, held in Brussels. The event was held under the auspices of His Excellency Mr. Baimukhan Margulan - Ambassador of Kazakhstan to Belgium, Her Excellency Ms. Teri Hakala - Special Representative of the European Union for Central Asia and Her Excellency Ms. Mami Mizutori - Special Representative of the United Nations Secretary-General for Reducing disaster risk.

A report was presented by the Deputy Director of the Center Aubakirov Serik Gabdullovich on the progress made in increasing resilience to disasters and climate change in Central Asia within the framework of the EU-funded project "Increasing Disaster Resilience and Accelerating the Implementation of the Sendai Framework for Disaster Risk Reduction in Central Asia", implemented by United Nations Office for Disaster Risk Reduction (UNDRR).

A number of working and technical meetings took place on the sidelines of this event.

Thus, within the framework of the panel session, a bilateral meeting was held between the Special Representative of the European Union for Central Asia, Ms. Teri Hakala, and the Deputy Director of the Center Aubakirov S.G.

On November 28, a meeting was held with the Special Representative of the UN Secretary-General for Disaster Risk Reduction, Ms. Mami Mizutori, and the UNISDR team, led by the head of the UNISDR Regional Office for Europe and Central Asia, Octavian Bivol.

On November 29, a delegation of the Center visited the EU Emergency Response Coordination Center (ERCC), where a technical meeting was held with its representatives. The participants of the meeting got acquainted with the position, structure and main activities of this center.

At all levels, the Center initiated a dialogue and started a discussion about the urgent need to create a similar European Coordination Center for Emergency Response in Central Asia on the basis of the Center for Emergency Situations and DRR in Almaty.



2022 year

From 29 NOVEMBER to 1 DECEMBER in Geneva, Switzerland, the Director of the Center attended the twelfth meeting of the Conference of the Parties to the United Nations Economic Commission for Europe (ECE) Convention on the Transboundary Effects of Industrial Accidents.

The Center and UNECE reached an agreement to strengthen interaction and cooperation in reducing the risks of man-made and industrial accidents in the Central Asian region within the framework of the Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries.

As part of the Roadmap for the implementation of the Strategy for the Development of Cooperation between the Countries of Central Asia in the field of DRR for 2023-2024, it is planned to combine efforts in the implementation of the following activities:

- integration of the risks of threats of technological and industrial (industrial) disasters into strategies, plans and programs for DRR;
- development of a joint contingency plan between riparian countries with harmonized standard operating procedures for emergency notification, response and mutual assistance in the Syrdarya river basin;
- development of a concept and implementation of a systematic approach for managing the risks of transboundary disasters, taking into account climate change;
- development of the Regional Digital Catalog of Potentially Hazardous Objects of the Central Asian Countries Possessing a Threat of Emergencies of a Transboundary Nature;
- implementation of measures to create a regional system of early warning about the threat of emergencies based on the development of partnerships between authorities, the private sector and other interested parties;
- implementation of measures to strengthen local and national capacities for emergency preparedness and response in the countries of Central Asia.

NOVEMBER 30: The Center, at the invitation of the Red Crescent of Kazakhstan, took part in the seminar "International law in emergency situations and adaptation to climate change", which took place in Shymkent. The head of the IFRC office for Central Asia, Seval Guzelkilinch, welcomed the participants of the seminar. Paulina Caspellan, IFRC Delegate for Emergency Law in Central Asia, shared with the participants of the seminar the existing legislation on emergency situations in Central Asia, introduced into the international law of disaster response. Also, she demonstrated to the workshop participants the Regional Emergency Response Coordination Mechanism, developed by the Center, as one of the available emergency response documents in Central Asia. After that, the Center was given the floor to explain the existing platform of the Regional Forum-Meeting of the Heads of Emergency Departments, as one of the platforms for adopting documents at the regional level.

The Center and the IFRC reached an agreement to strengthen interaction and cooperation in disaster risk management in Central Asia within the framework of the Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries.



2022 year

NOVEMBER 29-30: Chief expert of the Center Ospanov B.M. took part in the Technical Expert Forum on the topic: "Tracking hazards and assessing damage from disasters", organized by the United Nations Office for Disaster Risk Reduction (UNDRR) together with the United Nations Development Program (UNDP) and the World Meteorological Organization (WMO) in Bonn (Germany). The purpose of the Forum is to strengthen existing standards and processes for data collection, cooperation and interaction between responsible organizations, as well as ensuring the transparency of disaster data.

In accordance with the program of the event, the main focus was on studying the existing achievements in the field of damage and loss assessment, obtaining data on disasters, developing international cooperation and partnerships, as well as identifying existing problems and gaps in this area.

The chief expert of the Center provided information on the results achieved in the development of regional and international cooperation in the field of disaster risk reduction in the Central Asian region through the creation of a permanent high-level consultative platform in the format of the Regional Forum - the Meeting of the Heads of Emergency Departments of the Central Asian countries.

During the Technical Forum, international organizations presented new disaster data collection and analysis systems, such as Risk Information Exchange - RiX (UNDRR), Geohub (UNDP) and others. Desintentar Sendai.

In the final session of the Technical Forum, as a tool to solve existing problems in the field of disaster data collection, a team of representatives from UNDP, UNDRR and MWO presented a model of a completely new disaster data recording and analysis system, which is planned to be created by integrating most of the existing systems into a single system, including meteorological databases.

In total, the event was attended by 83 representatives of government agencies, regional international organizations and the private sector from more than 40 countries.



2022 year

DECEMBER 2: The Center took part in a high-level conference on climate change on the topic: “From global knowledge to local solutions: climate-resilient institutions in Central Asia”, which was held in Tashkent. The event was initiated with the support of Uzhydromet, the Ministry of Foreign Affairs of Uzbekistan and organized by UNDP in Uzbekistan within the framework of the project "Climate Change and Resilience in Central Asia" with the support of the EU in close cooperation with the GIZ project "Green Central Asia", funded by the Ministry of Foreign Affairs of Germany.

More than 140 delegates took part in an active dialogue on climate threats and called on all Central Asian states to join forces to achieve a reasonable balance between climate change mitigation and adaptation to it.

Participants focused on developing regional dialogue and raising awareness of vulnerable sectors of the economy about climate change and resilience. They stressed the importance of strengthening early warning and climate change mitigation measures at the community level in neighboring areas of Central Asia..



DECEMBER 08: The Regional Meeting on Enhancing Urban Resilience (RSR 2030) was held on the basis of the Center for Emergency Situations and Disaster Risk Reduction in Almaty with the support of UNDP and UNISDR, the governments of the countries of Central Asia.

The meeting was attended by representatives of local authorities and emergency departments of the Central Asian countries, experts from the UNISDR, UNDP, the Center. The participants of the meeting got acquainted with the concepts of DRR in cities, with the global initiative "Increasing the resilience of cities to disasters 2030", with the UNDP approach to urban resilience, with an overview of the local process for developing a DRR strategy, with the main principles of increasing urban resilience, with the INFORM sub-regional index for countries of Central Asia, with tools for assessing and analyzing sustainability (Scorecard).

During the event, representatives of the participating cities of Kazakhstan, Kyrgyzstan, Tajikistan, Uzbekistan exchanged best practices.

The training was conducted to develop a better understanding of urban resilience needs and priorities, systems thinking and an approach to advancing urban resilience action..



2022 year

DECEMBER 26: The twelfth meeting of the Council of the Center for Emergency Situations and Disaster Risk Reduction chaired by the Kyrgyz side was held via videoconference.

The meeting was attended by the Minister for Emergency Situations of the Republic of Kazakhstan Ilyin Yu.V. and Minister of Emergency Situations of the Kyrgyz Republic Azhikeev B.E.

At the meeting, the results of the work of the Center for 2022 and priority areas of activity for 2023 were presented to the members of the Council.

The Council adopted a report on the execution of the budget for 2022 and approved the budget for 2023, and considered personnel issues.

The heads of emergency departments noted the effectiveness of work in Central Asia through the Center's platform. At the suggestion of the Kyrgyz side, on the basis of the results of the VIII Summit of Ministers for Emergency Situations of the Member States of the Organization of Turkic States, it was decided to initiate each side in the Foreign Ministry of their states with a proposal to give the status of the Secretariat of Emergency Departments of the Turkic-Speaking States on the basis of the Center in Almaty.



2022 - MAIN RESULTS OF THE CENTER

- ◆ Organizational support continues for the work of the Working Group of Experts of the CoES of the Ministry of Internal Affairs of the Republic of Kazakhstan and the Ministry of Emergency Situations of the Kyrgyz Republic on the implementation of joint coordinated measures to integrate early warning systems for earthquakes in the Republic of Kazakhstan and the Kyrgyz Republic. In addition, a technical working group has been established to create a regional system for early warning and mutual information about the threat and the occurrence of emergencies.
- ◆ Work continues on the collection, compilation, analysis and exchange of operational information in the field of emergencies through the development and communication to stakeholders of the daily "Operational information on emergency situations in the Republic of Kazakhstan and the Kyrgyz Republic".

- ◆ At the initiative of the Center and ICDO, since 2018, organizational support has been provided to establish cooperation and interaction between the diving services of Kazakhstan and Kyrgyzstan. In 2022, on the basis of the training ground "Rock City - Astana", a ten-day master training was held for the canine services of the emergency departments of the countries of Central Asia.
- ◆ The Centre, together with the UN Office for Disaster Risk Reduction to contribute to the achievement of the Global Targets set by the Sendai Agenda for Disaster Risk Reduction 2015-2030 and within the framework of the project "Strengthening regional cooperation and facilitation of the implementation of the Sendai Agenda for Disaster Risk Reduction in Central Asia" held this year 6 instructional and methodological sessions on monitoring the implementation of the Sendai Framework Program for Disaster Risk Reduction for 2015-2030 for representatives of government agencies of Central Asian countries.
- ◆ The Center, together with UNICEF in the Republic of Kazakhstan, carried out a number of activities to develop unmanned aircraft in order to ensure the safety of territories and the population, taking into account the interests of vulnerable groups. Established zonal emergency response teams using UAV capabilities.

Within the framework of the UNICEF project, a unique product was created in Central Asia - UAV Online School - is the only remote tool in the region for training specialists in the use of UAVs for civil protection tasks.

- ◆ Within the framework of the UNDRR Initiative "Increasing resilience to disasters and accelerating the implementation of the Sendai Framework for Disaster Risk Reduction in Central Asia", funded by the European Union, on October 06 in Dushanbe, under the chairmanship of the Tajik side, a high-level event was held - Regional Forum-Meeting heads of emergency departments of Central Asian countries.
- ◆ At the initiative of the Center, with the technical and financial support of international organizations, two meetings of the Working Group (experts) of the Regional Forum - Meeting of the Heads of Emergency Departments of the Central Asian countries were organized and held:

- *In August 2022 online, chaired by the Tajik side.*

- *In October 2022 in the city of Dushanbe, under the chairmanship of the Tajik side.*

The Center, by attracting investments in the form of grant funds from donor agencies and international organizations, as an executing agency, in 2022 implemented the following projects in the field of strengthening regional cooperation, disaster risk reduction and emergency prevention:

1. UNDRR Project "Strengthening Regional Cooperation and Facilitating the Implementation of the Sendai Program in Central Asia", implementation period: 2019-2022;
2. ICDO project "Strengthening the capacity of canine services of emergency departments of the countries of Central Asia", implementation period: 2022;
3. Project of UNDP in the Kyrgyz Republic and WFP in the Kyrgyz Republic "Conducting a Mid-Term Review of the Implementation of the Sendai Framework for DRR in the Kyrgyz Republic", implementation period: 2022;
4. OSCE project "Improving the methodology and practice of monitoring and assessing disaster risk using innovative ICT", implementation period: 2022;

5. Project MapAction "Geoinformation systems, mapping and work with data", implementation period: 2022;
6. FAO project in the Kyrgyz Republic "Institutionalization of the methodology for assessing damage and losses for the agricultural sector in Kyrgyzstan", implementation period: 2022;
7. UNISDR Project "City Sustainability Assessment", implementation period: 2022;
8. UNDP project in the Kyrgyz Republic "Improving the level of fire safety of the population by strengthening the capacity of the fire and rescue service in the Kyrgyz Republic", implementation period: 2022;
9. CESDRR together with an international expert "Development of recommendations / proposals for amendments and additions to the Law of the Republic of Kazakhstan "On Civil Protection", implementation period: 2022.
10. UNICEF project "Development of unmanned aircraft in order to prevent and eliminate the consequences of emergencies with a focus on vulnerable groups of the population.", implementation period: 2018-2022.

The Center, together with international and non-governmental organizations, scientific institutions, with their technical and financial support, prepared and held 26 international events (conferences, forums, seminars, trainings, meetings, meetings) in the field of disaster risk reduction and emergency situations.

884 people took part in these events, exchanged experience, gained new knowledge, improved their skills in the field of disaster risk reduction and emergency situations, including:

- ◆ 148 representatives of state bodies of the Republic of Kazakhstan.
- ◆ 76 representatives of state bodies of the Kyrgyz Republic.
- ◆ 156 representatives of state bodies of the Central Asian countries and other states.
- ◆ 85 representatives of scientific institutions and independent experts.
- ◆ 419 representatives of international and non-governmental organizations.

- ◆ 1 meeting of the Council of the Center was held.
- ◆ 5 meetings of the Regional Scientific and Technical Council were held.

On November 24, 2022, during the 25th Session of the General Assembly of the International Civil Defense Organization in Abu Dhabi, 48 Member States supported the proposal to give the Center the status of an Affiliate Member of ICDO.

The transition to a new format of cooperation will significantly strengthen the interaction between the ICDO and the Center in the field of civil defense in order to reduce the risk of disasters, strengthen preparedness and ensure an effective response to emergencies.

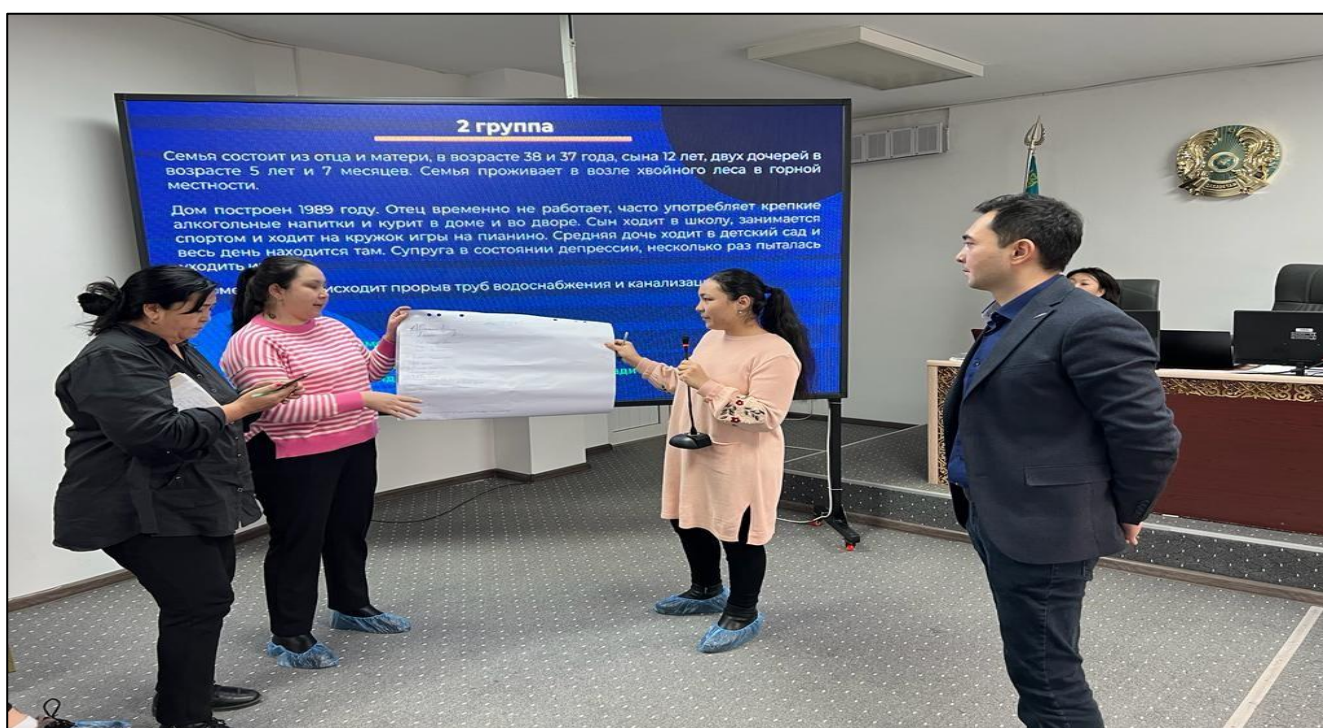
In addition, this will allow further work and interaction with ICDOs to build in a planned manner and on a systematic basis to increase the potential of emergency response services of the countries of Central Asia..

From JANUARY 30 to FEBRUARY 3: within the framework of the UNICEF project "Strengthening the system of the Universal Progressive Model of Nursing Care for Pregnant Women and Young Children, Increasing the Potential of Adults in the Development of Children with Developmental Disabilities, including Increasing the Preparedness of Families Under Patronage Supervision for Emergencies" in the city of St. Turkestan conducted a 5-day training on the topic: "The development of young children in the framework of the Universal Progressive Patronage Model with a focus on preparedness for crises and emergencies."

Within the framework of the UNICEF project, the chief expert of the Center Ospanov B.M. was recruited as an expert trainer in emergency situations. During the training Ospanov B.M. presented the developed training module on emergency situations for patronage nurses, as well as the Checklist for assessing the risk of an emergency and the Algorithm for actions of patronage workers and family members to ensure safety in an emergency.

Taking into account the presented material, the Center's expert organized a number of group practical exercises on the application of the acquired knowledge, and also tested the participants on the topics presented.

The training was attended by 42 patronage nurses from 13 districts and 3 cities of the Turkestan region. The materials developed within the framework of the UNICEF project made it possible to equip visiting nurses with a tool for assessing the existing risks of emergencies, as well as to provide nurses with information cards with recommendations for family members on actions in emergency situations and taking early measures to ensure their own safety and the safety of a newborn child.

FEBRUARY 15: The United Nations Office for Disaster Risk Reduction (UNISDR) and the Center for Emergency Management and Disaster Risk Reduction (CESSRR) held a final meeting to showcase the achievements of the European Union-funded project "Building Disaster Resilience and Accelerating Implementation of the Sendai Framework for Disaster Reduction Disaster Risk Management in Central Asia", which supports the countries of the region in the implementation of the priorities of the Sendai Framework.

The event brought together representatives of national governments, implementing partners, as well as donors and other stakeholders in the field of disaster risk reduction, to review the achievements of the program, assess challenges and opportunities for future cooperation, including raising awareness of risks,

emergency preparedness situations and adaptation to climate change at the regional, national and local levels, and to accelerate the overall implementation of the regional strategy for disaster risk reduction.

Key achievements of the project include the strengthening of the role of the CERR in Almaty as a regional secretariat for coordination and source of experience, information and capacity building in the field of disaster risk reduction. The Regional Disaster Risk Profile of the countries of Central Asia was developed within the framework of the ESDR project, on the basis of which the Regional Strategy for the development of cooperation between the countries of Central Asia in the field of disaster risk reduction for 2022-2030 was developed, approved at the Regional Forum-Meeting of the heads of emergency departments of the countries of Central Asia in 2021 with the subsequent annual action plans (Roadmaps) for its implementation, as well as the experts of the Center for Emergency Resources and Rescue, conducted instructional and methodological sessions with national coordinators and specialists from the emergency departments of the Central Asian countries on the preparation of reports on the implementation of the Sendai Framework for Disaster Risk Reduction for 2015-2030.

At the end of the meeting, the Center announced a number of project proposals, the interest of which is in all countries of Central Asia according to the Comparative analysis of the compliance of the Plan for the implementation of the Strategy for the development of cooperation between the Central Asian countries in the field of DRR for 2023-204 with the strategic action plans of five countries of the region.



2023 year

MARCH 01: in the city of Kokshetau, Akmola region on the basis of the Academy of Civil Protection. M. Gabdullina of the Ministry of Emergency Situations of the Republic of Kazakhstan As part of a joint project with the United Nations Development Program (UNDP) in the Republic of Kazakhstan, the Center for Emergency Situations and Disaster Risk Reduction, a training was held to teach and develop skills in the development and use of drought response plans in the Republic of Kazakhstan at the national and local levels.

The training was attended by representatives of the Akimat of Akmola region and district akimats, departments of the Department of Emergency Situations, Departments of Agriculture and Land Relations, departments of Kazhydromet and other interested parties. The number of participants in the training was 42 people.

The participants of the training discussed the drafts of the presented documents in the field of response to droughts in the Republic of Kazakhstan, developed by the experts of the Center during the implementation of the project.

The event was held in an interactive form, which made it possible to listen and take into account the constructive opinion of the training participants.

At the end of the training, group practical exercises were held to develop drought response skills using the example of the developed draft territorial drought response plan for the Akmola region.

The conducted training and presented materials will enhance the capacity of the Republic of Kazakhstan in forecasting and responding to droughts at the national and local levels.



2023 year

MARCH 14: As part of a joint project with the United Nations Development Program (UNDP) in the Republic of Kazakhstan, the Center for Emergency Situations and Disaster Risk Reduction, a series of trainings on developing skills in monitoring, forecasting, mitigating and responding to droughts in the Republic of Kazakhstan continues at the national and local levels, another training was held in Astana.

The training was attended by representatives of the Ministry of Emergency Situations of the Republic of Kazakhstan, the Ministry of Agriculture of the Republic of Kazakhstan, the Ministry of Ecology and Natural Resources of the Republic of Kazakhstan, RSE "Kazhydromet", RSE "Kazvodkhoz", the National Chamber of Entrepreneurs of the Republic of Kazakhstan "Atameken" and other interested parties. The number of participants in the training was 50 people.

The participants of the training were presented with:

- agrometeorological monitoring of droughts, drought forecasting methods used in RSE “Kazgidromet”;
- analysis of the needs for agrometeorological information from consumers, taking into account their specifics, the layout of the drought monitoring bulletin, taking into account the needs of the consumer;
- international experience and practice in drought monitoring;
- hydrometeorological model for early warning of droughts based on hydrodynamic modeling of the regime of extreme temperatures and indices of atmospheric aridity;
- evaluation of the quality of forecasts of parameters of atmospheric aridity;
- basics of satellite data application for drought monitoring;
- key recommendations for drought mitigation and drought response preparedness in the Republic of Kazakhstan based on best experience and practice;
- the result of the analysis and collection of data on the socio-economic impacts and dynamics of droughts.

The event was held in an interactive form, which allowed the exchange of opinions, experience and aroused interest among the participants of the training.

The conducted training will increase the capacity of authorized officials of interested state bodies in forecasting, mitigating and responding to droughts at the national and local levels.



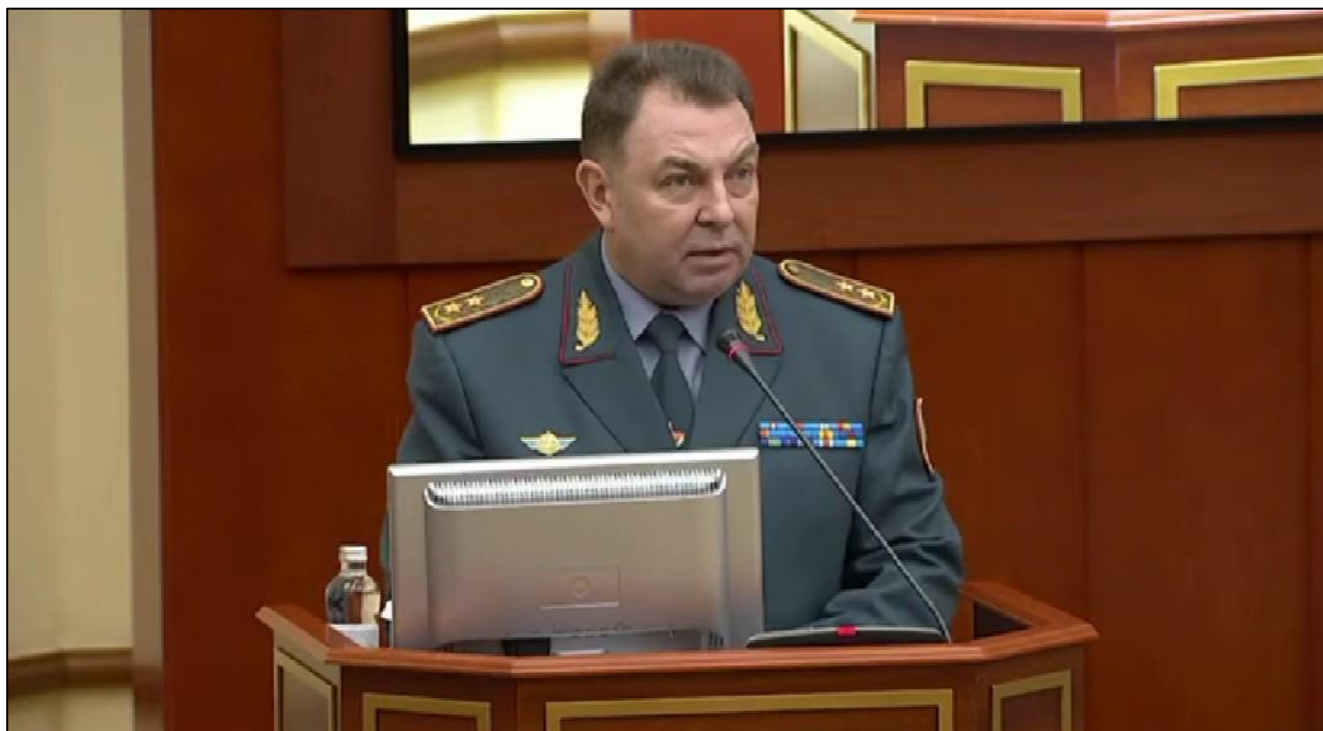
2023 year

Following the extraordinary summit of the Organization of Turkic States, held on March 16, 2023 in Ankara on the topic "Emergency Management and Humanitarian Aid", the Head of State made a number of proposals, including the issue of giving the Center the status of the Secretariat of the civil protection mechanism of the Organization of Turkic States.

In turn, on April 5 this year. Minister for Emergency Situations of the Republic of Kazakhstan, Lieutenant General Ilyin Yu.V. at the plenary session of the Mazhilis of the Parliament of the Republic of Kazakhstan, information was announced on the ongoing work of the Ministry in order to expand the circle of participating countries for joining the Center for Emergency Situations and Reducing the Risk of Natural

Disasters. Thus, proposals on joining the Center have been sent through diplomatic channels to all countries of Central Asia and the South Caucasus.

At the same time, the Minister emphasized that in this way the Center will acquire broader powers in the implementation of projects and programs in the field of disaster risk reduction and response to them.



2023 year

MARCH 27: The Center for Emergency Situations and Disaster Risk Reduction (hereinafter referred to as the Center), within the framework of a joint project with the United Nations Development Program (UNDP) in the Republic of Kazakhstan, conducted a final training on creating a drought response system based on drought monitoring and forecasting, based on Center.

The training was attended by representatives of the Ministry of Emergency Situations of the Republic of Kazakhstan, the Ministry of Agriculture of the Republic of Kazakhstan, the Ministry of Ecology and Natural Resources of the Republic of Kazakhstan, the Akimat of cities and regions, the Department of Emergency Situations of cities and regions, RSE "Kazhydromet" and branches of cities and regions, RSE "Kazvodkhoz", the National Chamber of Entrepreneurs RK "Atameken" and other interested parties. The number of participants in the training exceeded 50 people.

The training participants were presented with the final developed documents on the creation of a drought response system based on drought monitoring and forecasting, finalized taking into account the proposals received from stakeholders during the previous two trainings held in Kokshetau and Astana.

The conducted training and developed draft documents will strengthen the country's capacity in forecasting and responding to droughts.

The work provides for strengthening the capabilities of the RSE "Kazhydromet" to improve the efficiency of agrometeorological monitoring and forecasting based on the development of integrated forecasting, the new design of the drought forecast bulletin, taking into account the needs and specifics of the main consumers, will not only provide information, but also understand and easily interpret for taking appropriate measures. In terms of drought response, a coordination mechanism for drought response at

the national level and a Drought Response Plan based on a pilot region were developed with the development of model recommendations for dissemination and use by other regions of Kazakhstan.





2023 year

APRIL 23, 2023: As part of a working trip to Almaty, the Center was visited by the First Deputy Minister of Emergency Situations of the People's Republic of China, Mr. Xu Qiaiai, with a delegation of the Ministry of Emergency Situations of the People's Republic of China, consisting of: Head of the Emergency Coordination Department, Mr. Guo Jiwu, Head of the International Cooperation and Humanitarian Aid Department Mr. Liu Weiming, Head of the Multilateral Cooperation Section of the International Cooperation and Humanitarian Aid Department Ms. Gao Kun, Deputy Head of the Multilateral Cooperation Section of the International Cooperation and Humanitarian Aid Department Ms. Zhou Hongfan, Secretary to the Deputy Minister Mr. Zhang Jain, the official representative of the Ministry of Public Security of the People's Republic of China in Almaty, Mr. Zhang Yang, and his assistant, Mr. An Weijia.

During the visit, Mr. Xu Qiaiai got acquainted with the activities of the Center, listened to a presentation on implemented and ongoing projects, as well as on the planned activities of the Center in the field of disaster risk reduction in Kazakhstan and the Central Asian region. He shared information about the activities of his Ministry and the results achieved. He noted that this year marks the tenth anniversary of China's One Belt, One Road initiative and invited employees of the Center and the Ministry of Emergency Situations of Kazakhstan to the Forum dedicated to this event.

Mr. Xu Qiaiai stressed the importance of bilateral cooperation between Kazakhstan and China in the field of disaster risk reduction, coordination of joint efforts aimed at creating a mechanism with the participation of Central Asian countries and China for effective and timely response to emergency situations..





2023 год

С 14 по 18 МАЯ: на базе учебно-тренировочного полигона «Скальный город - Астана» в рамках первого этапа международного сбор-семинара «Казқұтқару – 2023» Центром при технической и финансовой поддержке МОГО успешно проведен мастер-тренинг по применению беспилотной авиации для задач ЧС.

В рамках мастер-тренинга инструкторами МОГО и Центра проведены теоретические и практические занятия, основное внимание было уделено послеполетной обработке данных, подготовке ортофотоплана местности и 3D модели рельефа местности, а также проведению расчетов, измерений, и использованию полученных данных в других программных обеспечениях.

Помимо теоретической и практической части обучения, проведены соревнования среди участников тренинга по трем дисциплинам: «Прохождение трассы с препятствиями за минимальное время», «Доставка малогабаритного груза пострадавшему» и «Ночной поиск».

По результатам мастер-тренинга, 51 оператору беспилотных аппаратов из Казахстана, Кыргызстана, Таджикистана и Узбекистана вручены сертификаты международного образца, при этом, двум тренерам Центра вручены сертификаты МОГО «Профессиональный тренер курса «Применение БПЛА для задач ЧС»».



2023 год

From MAY 14 to 22: on the basis of the training ground "Rock City - Astana" as part of the first stage of the international gathering-seminar "Kazkutkaru - 2023", the Center, with the technical and financial support of the IGO, successfully conducted a master training for cynological services of the countries of Central Asia with attraction of trainers from the Russian Federation.

As part of the training, cynologists from the Central Asian countries worked out the technique of using search dogs in search and rescue operations on a man-made blockage and in the natural environment.

The main attention of the trainers was directed to working out the interaction of the cynologist with the dog during the search operation, as well as working out the quality of the signal behavior of the service dog.

According to the results of the master training, 41 rescue dog handlers from Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan were awarded certificates of the International Civil Defense Organization.



2023 год

MAY 17-18: in Astana, within the framework of the UNICEF project with the support of the Bureau for Humanitarian Aid USAID, the Center conducted a two-day training in a hybrid format. The training was attended by representatives of the Ministry of Emergency Situations, the Ministry of Internal Affairs, the Ministry of Health, the Ministry of Finance, the Ministry of Science and Higher Education, the Ministry of Labor and Social Protection, the Ministry of Information and Social Development, L.N. Gumilyov, faculty of the NARKHOZ University, representatives of UNICEF, USAID.

The total number of participants in the training was more than 60 people.

The training provided will strengthen the capacity of representatives of national and local government authorities in the field of basic obligations for children in humanitarian action in accordance with their sectoral mandate, in order to improve coordination of actions in emergencies and planning of emergency services, including the use of developed or updated tools assessing and monitoring the needs and principles of protection from sexual exploitation and abuse.



2023 year

MAY 30-31: in Almaty, on the basis of the Center, within the framework of the UNICEF project with the support of the Bureau for Humanitarian Aid USAID, the Center conducted a two-day training in a hybrid format.

The training was attended by representatives of Public Associations, Social Funds, Department of Employment and Social Programs, volunteers, international organizations.

The total number of participants in the training was more than 50 people.

The conducted training will strengthen the capacity of the non-governmental sector of the Republic of Kazakhstan in the field of basic obligations towards children during humanitarian actions, coordination of actions in emergencies and planning the provision of services in emergencies.



From 5 to 9 June: in Tashkent, the Center, together with a partner, the British non-governmental organization MapAction, conducted another training for specialists from the Ministry of Emergency Situations of the Republic of Uzbekistan on the use of GIS technologies and mapping in emergency situations.

Experienced GIS experts from Great Britain and Germany were invited as trainers.

The event was attended by 16 employees of the central office and territorial divisions of the Ministry of Emergency Situations of the Republic of Uzbekistan.



From 12 to 16 JUNE: on the basis of the Center for Emergency Situations and Disaster Risk Reduction, together with a partner, the British non-governmental organization MapAction, a master training was held for specialists from the Ministry of Emergency Situations of the Republic of Kazakhstan and the Ministry of Emergency Situations of the Kyrgyz Republic on the use of GIS technologies and mapping in emergency situations.

Experienced GIS experts from Great Britain, Poland and Colombia were invited as trainers.

The main objective of this training is to increase the level of knowledge of employees of the Ministry of Emergency Situations in the use of GIS technologies and mapping for further use in emergency situations, as well as in order to reduce disaster risk.



JUNE 20: on the basis of the Center, within the framework of the implementation of the joint project with UNICEF "Improving the capacity of the emergency, health, education, social protection, and internal affairs sectors on the Core Commitments for Children in Emergencies for 2022-2023." with the support of the USAID Bureau of Humanitarian Assistance, the Center conducted a training on capacity building of stakeholders on issues of access to water, sanitation and hygiene (WASH) in emergency situations.

The training was held in a hybrid format. The training was attended by representatives of the Ministry of Emergency Situations of the Republic of Kazakhstan and territorial divisions, Akimats of cities and regions, the Department of Health, the Department of Education, the Departments of Sanitary and Epidemiological Control, the Department of Energy and Water Supply, the Department for the Development of Communal Infrastructure, the Department of Employment and Social Programs, the Rescue Service for Almaty, Utilities of the city, Branches of the Red Crescent Society, UNICEF in the Republic of Kazakhstan.

The total number of participants in the training was 191 people, of which 36 were offline and 155 online.

The training was held in an interactive form, which made it possible to listen and take into account the opinions and recommendations of the training participants, who noted the need to amend the current legislation of the Republic of Kazakhstan, which regulates the minimum life support standards for the population located in the emergency zone in terms of WASH in accordance with international standards.

The participants of the training noted the relevance of the training, an interesting format and expressed their intention to disseminate the knowledge gained in their teams.



2023 year

FROM JULY 19 TO 21: The Center for Emergency Situations and Disaster Reduction, together with the UNICEF Regional Office for Europe and Central Asia, the Regional Office of the International Federation of Red Cross and Red Crescent Societies in Central Asia, held a Regional Workshop on Lessons Learned as part of the implementation of the program funded by the UNICEF USAID Humanitarian Assistance: “Strengthening Local and National Capacity for Emergency Preparedness and Response in Central Asian Countries Highly at Risk of Earthquakes and Natural Disasters.” During the seminar, the results of the implementation of the above project in each of the five countries of Central Asia were summed up, with an emphasis on achievements, problems and challenges. The Center made a number of presentations on the results of the joint project with UNICEF and lessons learned, with a focus on vulnerable populations.

During the implementation of its component, the Center strengthened the capacity of representatives of state bodies at the national and local levels in their commitment to children in the course of humanitarian action, strengthened the capacity on issues of access to water, sanitation and hygiene (WASH) in an emergency guidelines on Basic Commitments for Children in Disasters, and worked with non-governmental organizations to support local governments in reducing risk and advancing a holistic approach to humanitarian action during emergencies.

Within the framework of the event, bilateral meetings were held between the Director of the Center Aubakirov Serik Gabdullovich and the Deputy Director of the UNICEF Regional Office for Europe and Central Asia, Mr. Octavian Bivol, and the head of the IFRC delegation in Central Asia, Ms. Seval Guzelkylynch.



FROM AUGUST 21 TO 24: Delegation of the Center consisting of Director Aubakirov S.G. and chief expert Ospanov B.M. took part in the ASEAN (Association of Southeast Asian Nations) Interregional Dialogue on Disaster Resilience, as well as the ASEAN Forum on Disaster Resilience, which were held in Singapore and organized by the ASEAN Secretariat with the support of the Asian Development Bank.

During the Interregional Dialogue, the Director of the Center, Aubakirov S.G. A report was presented on existing transboundary disaster risks in Central Asia and measures taken to reduce their risk, as well as planned initiatives to apply innovative technologies to improve transboundary disaster risk management approaches.

The greatest interest among regional partners was generated by the planned measures to create a Regional Early Warning System for multiple emergencies, as well as the creation of a Regional Coordination Center for Emergency Response in the countries of Central Asia for coordination and technical support of humanitarian operations based on the Center.

At the end of the first day, the Chairman of the ASEAN Emergency Committee, Mr. Pham Duc Luan, thanked the Director of the Center and expressed interest and readiness in establishing interregional cooperation between the region of Southeast Asia and Central Asia.

In the following days, on the sidelines of the ASEAN Forum, the Center's staff held a series of meetings and conversations with disaster specialists from the Asian Development Bank, headquartered in Manila (Philippines), and submitted for consideration the Center's project proposal for the creation of a Central Asian early warning system for multiple emergencies



SEPTEMBER 5: The Center, in pursuance of paragraph 2 of the Protocol of the Regional Forum - Meeting of the Heads of Emergency Departments of the Countries of Central Asia (signed on October 6, 2022 in Dushanbe, Republic of Tajikistan), with the support of UNISDR, UNDP and GIZ, held the First meeting of the Technical Working Group on the creation of a Regional early warning and mutual information systems about threats and emergencies (TRG).

During the introductory session, Director of the Center Aubakirov S.G. presented a presentation on the history of the origin of the idea of creating a Regional Early Warning and Mutual Information System about threats and emergencies (RSRO), and also identified the main goals and objectives for the TWG.

In accordance with the agenda, members of the TWG - representatives of Central Asian countries - informed about the state of national monitoring systems for emergencies of various types and early warning systems, outlined approaches and principles of operation of the systems, and also identified problematic issues.

The members of the TWG also reviewed the draft terms of reference for the creation of the RSRO.

Following the First Meeting, members of the TWG supported the Center's initiative to prepare a collective appeal from the heads of emergency departments of the Central Asian countries to the leadership of the UN and the World Meteorological Organization on the need to create a Regional Early Warning System for various transboundary emergencies, and also recommended the Center to analyze and evaluate existing monitoring systems and national early warning systems of Central Asian countries based on the submitted country reports and responses of TWG members in the online questionnaire.



FROM SEPTEMBER 21 to 22: Delegation of the Center consisting of Director Aubakirov S.G. and chief expert Ospanov B.M. took part in the Second High-Level Dialogue on Climate Change and Resilience in the Central Asian Region on the topic: “Early warning systems for climate change resilience”, organized by the UN Development Program in Kyrgyzstan, with the support of the UNDP Istanbul Regional Center within the framework of the project, EU-funded “Climate Change and Resilience in Central Asia”.

The event was attended by heads and representatives of emergency departments, hydrometeorological services, environmental and hydrological organizations of Central Asian countries, as well as international organizations and development partners.

The high-level conference provided an opportunity for stakeholders to discuss existing issues and establish cooperation in addressing pressing environmental issues facing the region. In addition, during the conference, representatives of Central Asian countries and international experts informed about available innovative solutions and best practices related to climate change resilience and early warning systems, and also demonstrated successful examples of adaptation that have been implemented in Central Asia and other subregions facing with climate change issues.

During the conference, the Director of the Center, Mr. Aubakirov S.G. gave an interview to the Khabar 24 TV channel, in which he noted that the Central Asian region unites countries with common natural conditions, the consequences of climate change and transboundary threats, so the most pressing issue is the adoption of comprehensive, synchronized measures to adapt to climate change and reduce disaster risk. An effective tool for achieving these goals can be the implementation of the initiative to create a Regional Early Warning System and mutual information about the threat and occurrence of transboundary emergencies, supported by all heads of emergency departments of the Central Asian countries.



SEPTEMBER 27: The Center for Emergency Situations and Disaster Risk Reduction was visited by representatives of the European Commission Directorate for Civil Protection and Humanitarian Aid (DG ECHO) in Brussels and Bangkok, as well as a delegation from the Regional Office of the International Federation of Red Cross and Red Crescent Societies for Central Asia.

During the working meeting, participants got acquainted with the activities of the Center, its main tasks and the possibility of interaction and participation in the work of the Center.

The Director of the Center, Mr. S. Aubakirov, provided information on measures taken to improve the Regional Coordination Mechanism for emergency response, as well as to create a Central Asian regional early warning system for emergency situations.

In addition, the delegation of DG ECHO was informed about the visit of the CESDR to the European Coordination Center for Emergency Response in Brussels, during which the principles and methods of work of this center were studied in order to apply its best practices in the CESDR in Almaty when coordinating the liquidation of large-scale and cross-border emergency situations in Central Asia.

In addition, the Center submitted for consideration of the participants a project proposal on the creation of a Regional Coordination Center for Emergency Response in Central Asian countries for coordination and technical support of humanitarian operations on the basis of the Central Emergency Response Center.

As a result of the exchange of views and discussions, the parties agreed to strengthen mutual cooperation and identified directions for future joint work in the field of disaster risk reduction and capacity building and the use of advanced information technologies, such as the EU Copernicus surveillance progra



FROM SEPTEMBER 27 to 28: Delegation of the Center consisting of Director Aubakirov S.G. and Senior expert Esniyazova Z.S. took part in a high-level event on the results of the Regional Study “Climate Resilient and Low-Carbon Cities of Central Asia”, organized by the World Bank, the Global Fund for Disaster Risk Reduction and Recovery's Cities Resilience Program, and the Urban Forum Kazakhstan Community Foundation.

The event was attended by leaders and representatives of emergency departments, government agencies, experts, practitioners and development partners involved in urban development, climate change mitigation and adaptation to climate change.

Workshop participants were presented with a year-long study that used quantitative, qualitative and spatial analysis to develop evidence-based recommendations and evaluate policy options for developing sustainable and low-carbon cities.

During the seminar, the Director of the Center, Mr. Aubakirov S.G. in his welcoming speech, he noted the role of the Center in interaction with partners on the issues of sustainable development of the urban environment and disaster risk management in the region within the framework of the Central Asian Initiative and the “Increasing Cities Resilience by 2030” (MCR2030) initiative.

In his welcoming speech, the Chairman of the Committee for Emergency Situations and Civil Defense under the Government of the Republic of Tajikistan, Colonel General of Militia R.U. Nazarzoda, thanked representatives of the World Bank for the work carried out in Tajikistan, and spoke about the aspects and approaches used for urban development and mitigating the impact of change climate.

The relevance of the work being carried out and the importance of sharing experience were noted in their welcoming speech by the Deputy Head of the Foreign Ministry Representative in Almaty Islambek Raimov, Deputy Akim of the Almaty Region Almas Botanov, and World Bank Resident Representative Andrey Mikhnev.

Group discussions and sessions held during the workshop allowed for the exchange of knowledge on aspects of the state of urban development and the promotion of innovative approaches for climate mitigation at the regional and national levels.

A number of bilateral meetings were held on the sidelines of this event.

Thus, a meeting was held with representatives of the World Bank, the head of the practice of the World Bank office in Austria, Christoph Pusch, the senior specialist in urban development and disaster risk management Chi-Yun-Huang, the representative of the World Bank in Kyrgyzstan Tolkyn Dzhukusheva, the consultant on operational issues Madina Nizamitdin and the director Center by Aubakirov S.G.

Representatives of the World Bank gave a positive assessment of the Center's role in interaction with partners in the field of DRR and adaptation to climate change in the Central Asian region and discussed further steps towards cooperation.

On September 28, a meeting was held with representatives of UNDRR with the national coordinator in Kazakhstan Bekmagambetova Samal and the national coordinator in Tajikistan Kodirov Dilshod on the issues of holding a meeting of the Working Group of Experts of the Regional Forum-Meeting of Heads of Emergency Authorities of Central Asian Countries and the Forum itself.



SEPTEMBER 28: As part of the World Bank seminar on regional research “Climate change-resilient and low-carbon cities of Central Asia” in Almaty, the Center for Emergency Situations and Disaster Risk Reduction was visited by the Chairman of the Committee for Emergency Situations and Civil Defense under the Government of the Republic of Tajikistan, Colonel General Nazarzoda RU.

During the visit, the meeting participants got acquainted with the activities of the Center, heard a brief report on the implemented and ongoing projects, as well as on the planned activities of the Center in Kazakhstan and the Central Asian region, including the progress of preparations for the Regional Forum-Meeting of the Heads of Emergency Departments of the Central Asian Countries with presentation of the agenda.

Thus, the Concept of strengthening the capacity of Central Asian countries in adaptation and resilience to climate change and disaster risk reduction by creating interactive maps and digital safety passports of Central Asian countries was presented.

The head of the emergency department of the Republic of Tajikistan emphasized the strengthened role of the Center in stimulating regional cooperation in the field of DRR, noting the importance of coordinating joint efforts aimed at creating a Regional Emergency Response Coordination Mechanism with the participation of Central Asian countries for effective and timely response to emergency situations.

The parties discussed the idea of placing humanitarian aid (UNICEF sanitary and hygiene kits) in warehouses of Central Asian countries in order to bring readiness closer and promptly provide timely humanitarian assistance to the population affected by disasters of various types.

At the end of the meeting, Mr. Nazarzoda personally invited the Director of the Center, Mr. Aubakirov, to the Asian Conference on Disaster Reduction, which this year will be held in Dushanbe on October 20, 2023 with the opportunity to present the potential and development priorities of the Center to representatives of 28 participating countries Asian Center for Disaster Preparedness in Kobe, Japan.



OCTOBER 4: In the city of Almaty, in preparation for the Regional Forum - the Meeting of the Heads of Emergency Authorities of the Central Asian Countries with the support of UNDRR, UNDP, Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), a meeting of the Working Group (experts) of the Regional Forum was held at the Center - Meetings of Heads of Emergency Authorities of Central Asian countries.

Experts from Central Asian countries discussed the agenda of the Regional Forum proposed by the Center regarding the relevance of the issues raised in it for the Central Asian region, reviewed and agreed on a number of draft documents proposed for discussion at the upcoming Regional Forum on November 10 of this year.

The presented materials are aimed at implementing practical measures to develop and deepen regional cooperation in the field of disaster risk reduction and strengthening preparedness to respond to emergency situations, and also provide for the introduction of modern approaches to disaster risk management using innovative technologies, support for the Regional Initiative for the creation of the Central Asian early warning systems and mutual information about the threat and occurrence of emergency situations, increasing the resilience of cities in the region and promoting innovative approaches to mitigate climate impacts at the regional level.

Experts from Central Asian countries expressed their intention to intensify joint efforts in taking further regionally coordinated measures to achieve a higher quality level of regional cooperation among Central Asian countries that meets the vital interests of the countries of the region in ensuring sustainable development



OCTOBER 20: The Center for Emergency Situations and Disaster Risk Reduction took part in the Asian Conference on Disaster Reduction, which took place in Dushanbe as part of the implementation of the Sendai Framework for Disaster Risk Reduction 2015-2030.

The conference was attended by representatives of ministries and emergency departments of 30 Asian countries (Armenia, Bhutan, Malaysia, Maldives, Mongolia, Papua New Guinea, Philippines, Singapore, Sri Lanka, Tajikistan, Thailand, Turkey, Vietnam, Korea, Japan and others), representatives of diplomatic missions, donor organizations and UN agencies. A welcoming speech was made by the Deputy Prime Minister of Tajikistan, Ms. Sattoriyon M., as well as the Special Representative of the UN Secretary-General for Disaster Risk Reduction, Ms. Mami Mizutori, in an online format.

During the conference, special attention was paid to issues of cooperation in the field of disaster risk reduction. In particular, the participants discussed the progress of implementation of the Sendai Framework in the member countries of the Asian Center for Disaster Reduction.

The event found ways to address recurring large-scale disasters on land and increasing disasters related to the climate crisis in Asia from a perspective that promotes digital transformation (DX).

During the event, representatives of foreign countries became interested in the activities of the Center and expressed their readiness to cooperate more closely with the Center.



NOVEMBER 09: The fourteenth meeting of the Council of the Center for Emergency Situations and Disaster Risk Reduction, chaired by the Kazakh side, was held at the Center. The meeting was attended by the Minister of Emergency Situations of the Republic of Kazakhstan Shariphanov S.D., First Deputy Minister of Emergency Situations of the Kyrgyz Republic Mambetov A.M.

At the meeting, members of the Council were presented with the results of the Center's work for 2023 and priority areas of activity for 2024, and information was provided on the progress of the Center's implementation of projects in the field of civil protection, adaptation to climate change and emergency situations in the countries of Central Asia. The Council adopted a report on the execution of the budget for 2023 and approved the budget for 2024, and considered personnel issues.

The heads of emergency departments noted the effectiveness of the Center in Central Asia in the field of disaster risk reduction.

On the same day, a meeting of the Working Group (experts) of the Regional Forum-Meeting of the Heads of Emergency Authorities of Central Asian Countries was held at the Center.

Experts from Central Asian countries discussed and agreed on draft documents proposed for discussion at the upcoming Regional Forum-Meeting of Heads of Emergency Authorities of Central Asian Countries.

Also, on November 9 of this year, within the framework of the UN ISDR project "Subregional Implementation of the Sendai Framework in Central Asia" to achieve the Global Targets defined by the Sendai Program for DRR for 2015-2030, instructional and methodological classes were held on monitoring the implementation of the Sendai Framework on DRR for 2015-2030 for representatives of government agencies of Central Asian countries.



NOVEMBER 10: In the city of Almaty, under the chairmanship of the Kazakh side, a high-level event took place - the next Regional Forum - Meeting of the Heads of Emergency Authorities of Central Asian Countries.

Delegations led by heads of emergency departments of the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan, Turkmenistan and the Republic of Uzbekistan, representatives of UN agencies, donors, international and non-governmental organizations took part in the work of the Regional Forum.

During the event, attention was paid to issues of international cooperation in the field of disaster risk reduction, as evidenced by speeches on regional programs and projects in the field of disaster risk reduction from such partners as UNDRR, UNDP, GIZ, the World Bank, the Swiss Agency for Development Cooperation, the Economic Commission for Europe, UNICEF, IFRC, MapAction. In addition, issues of further cooperation within the framework of the implementation of the Sendai Framework Program in the countries of the region were discussed.

The issue of ensuring public access to early warning systems for various disasters has become particularly significant. The heads of Emergency Authorities, having discussed this issue, signed an Appeal to UN Secretary-General Antonio Guterres on the issue of creating a Regional Early Warning System and mutual information about the threat and occurrence of transboundary emergencies.

On the sidelines of the Regional Forum, a number of bilateral meetings were held between the heads of emergency departments of the Central Asian countries with the Head of the regional office of the UN Office for Disaster Risk Reduction for Europe and Central Asia, Natalia Alonso Cano, with the Regional Technical Advisor on Climate and Disaster Resilience of the UNDP Regional Center in Istanbul Stanislav Kim, with the Head of the GIZ project "Climate Risk Management in Central Asia" Sergei Makarov, with the Head of the IFRC Delegation for Central Asia Ms. Seval Guzelkilinch.



NOVEMBER 10: as part of the Regional Forum - Meeting of the Heads of Emergency Authorities of Central Asian Countries, the Center for Emergency Situations and Disaster Risk Reduction was visited by the Minister of Emergency Situations of the Republic of Uzbekistan, Major General A.Kh. Kuldashhev.

During the visit, Abdulla Khamidullayevich got acquainted with the resource and technical potential, the history of the creation and activities of the Center, as well as planned events in the Central Asian region.

The Head of the Emergency Authorities of the Republic of Uzbekistan thanked the Center for the work being done to strengthen cooperation between emergency departments in the region and the ongoing projects aimed at reducing disaster risk in the countries of Central Asia, and noted the importance of holding the Regional Forum as a constructive dialogue to discuss the situation in the region and identify the main tasks.



DECEMBER 5: The Center, together with the International Federation of Red Cross and Red Crescent Societies, organized and held a Regional Consultative Seminar on International Disaster Response Law (IDLR) as part of the implementation of the Regulations on the Regional Coordination Mechanism for Emergency Response in Central Asia, approved by the decision of the Regional forum-Meeting of Heads of Emergency Authorities of Central Asian countries on November 5, 2021 in Tashkent, Republic of Uzbekistan.

The event was attended by representatives of emergency departments of Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan, as well as international organizations involved in humanitarian activities, such as UN agencies (UNICEF, UNDRR, UNDP, UNHCR, OCHA, WFP, WHO), World Bank, CAREC, and also represented the national Red Crescent Societies of the Republic of Kazakhstan, Kyrgyzstan, Tajikistan, Germany, Turkmenistan, Uzbekistan.

During the seminar, representatives of the emergency authorities of the Central Asian countries and humanitarian organizations discussed the preliminary recommendations of the international expert Dr. Carlo de Stefano based on the results of the study regarding the effective implementation of the Regional Coordination Mechanism for Emergency Response in Central Asia based on the contents of the Regulations and Guidelines for the MHRD and emphasized the relevance of the study to develop the necessary steps to achieve this goal.

In addition, the participants of the seminar noted the importance of creating, on the basis of the Central Black Sea Disaster Resistance Center, a Regional Coordination Center for the coordination of humanitarian activities for the states of Central Asia, capable of coordinating the activities of key participants in responding to emergency situations and providing international humanitarian assistance, operating around the clock and capable of monitoring and providing minimal timing information about the threat or occurrence of emergency situations in the Central Asian states.



DECEMBER 8: Director of the Center Aubakirov S.G. at the invitation of the Senate of Parliament, spoke at Parliamentary hearings on improving the civil protection system, organized by the Committee on International Relations, Defense and Security of the Senate of Parliament. The meeting participants discussed amendments to the relevant law and voiced their proposals.

Opening parliamentary hearings, the Senate Speaker noted that improving the civil protection system is of strategic importance for the country. The increasing frequency of fires of a natural and man-made nature, according to Maulen Ashimbaev, indicates the need to revise legislative acts relating to emergency situations.

During the meeting, reports were made by the Minister of Emergency Situations Syrym Shariphanov, the Minister of Ecology and Natural Resources Yerlan Nysanbaev, the akim of the West Kazakhstan region Nariman Turegaliev in an online format, the representative of the International Academy of Engineering and the director of the Center for Emergency Situations and Disaster Risk Reduction Serik Aubakirov.

Director of the Center Serik Aubakirov spoke about the research conducted by the Center in order to harmonize national legislation in the field of civil protection, by bringing together national standards, including the UN glossary. Thus, the director voiced the key terms “disaster”, “disaster risk”, “disaster risk profile”, “resilience”, “risk reduction”, “climate change”, “risk management”, used in the current edition of the Law on Civil Protection, but due to their absence in the conceptual apparatus of the current law and in the draft, during the hearings the director proposed to add to the glossary of the bill.

The result of the parliamentary hearings was a draft Recommendation on improving the civil protection system of the Republic of Kazakhstan, which took into account the proposals of the Director of the Center.





DECEMBER 7-8: Deputy Director of the Center Chekirbaev M.A. took part in the Eighth Meeting of the Regional Expert Group of the Asia-Pacific Center for the Development of Disaster Information Management, which took place in Dushanbe, Republic of Tajikistan.

This event was organized by the Committee for Emergency Situations and Civil Defense under the Government of the Republic of Tajikistan together with the Asia-Pacific Center for the Development of Disaster Information Management (APDIM).

The meeting was attended by representatives of the emergency departments of Bangladesh, India, Iran, Cambodia, Kazakhstan, Kyrgyzstan, Macau, Micronesia, Mongolia, Turkey and Tajikistan, and representatives of international organizations.

The main objective of the Regional Expert Group meeting was to promote knowledge sharing, innovative solutions and best practices in disaster management, with a focus on integrating data, technology and policy to improve preparedness, and response capabilities in the Asia-Pacific region.

During the meeting, a presentation was made on the activities of the Center for Emergency Situations and Disaster Risk Reduction in the field of using innovative information and communication technologies in monitoring possible disasters, assessing, analyzing and reducing disaster risk, preventing and responding to emergencies.

The Asia-Pacific Center for the Development of Disaster Information Management (APDIM) expressed interest in further cooperation with the Center for Emergency Situations and Disaster Risk Reduction.



DECEMBER 3-8: Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH (German Society for International Cooperation) within the framework of the project “Climate Risk Management in Central Asia” organized a working visit to Bonn (Germany), in which took part the Senior expert of the Center Ospanov B.M. The main purpose of the trip is to obtain information and engage in constructive dialogue to explore approaches, best practices and technologies related to climate risk management and transboundary early warning systems for hydrometeorological disasters in Germany and Europe.

The event was attended by representatives of hydrometeorological services, water resource management organizations and emergency departments of Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan.

During the first day, participants visited the German Committee for Disaster Risk Reduction, an association based in Bonn that aims to promote disaster risk reduction. Committee staff provided information on the current national early warning system in Germany, which includes 359 receiving and transmitting stations of federal and regional significance.

The following days were devoted to studying the catastrophic flood in Germany that occurred in July 2021, which killed 136 people in West Germany and caused material damage of more than 30 billion euros. Participants visited affected communities in the Ar Valley of North Rhine-Westphalia and spoke with local government officials.

During the summing up of the trip, the participants noted the importance of the measures taken by the Center to create a regional early warning system for transboundary disasters, the need to develop volunteer activities in the field of disaster risk reduction using the example of Germany, and also emphasized its high efficiency.



2023 YEAR – MAIN RESULTS OF THE CENTER’S ACTIVITIES

- ◆ Work continues on the implementation of joint coordinated measures to integrate early warning systems for earthquakes in the Republic of Kazakhstan and the Kyrgyz Republic. In addition, a technical working group has been created to create a Regional Early Warning System and mutual information about threats and emergencies. On 09/05/2023, the first meeting of the technical working group on the creation of the REWS was held on the basis of the Central Emergency Service of Russia.
- ◆ On the initiative of the Center and ICDO, since 2018, organizational support has been provided to establish cooperation and interaction between diving and canine services of Kazakhstan and Kyrgyzstan. In 2023, on the basis of the training ground “Rock City - Astana”, as part of the first stage of the international training seminar “Kazkutkaru - 2023”, the Center, with the technical and financial support of ICDO, successfully conducted a master training for canine services of the countries of Central Asia. Based on the results of the master training, the 41st rescue dog handler from Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan were awarded certificates from the International Civil Defense Organization. In addition, in 2023, on the basis of the training ground “Rock City - Astana”, as part of the first stage of the international training seminar “Kazkutkaru - 2023”, the Center, with the technical and financial support of ICDO, successfully conducted a master training on the use of unmanned aircraft for emergency situations. Based on the results of the master training, 51 operators of unmanned aerial vehicles from Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan were awarded international certificates, while two trainers of the Center were awarded ICDO certificates “Professional trainer of the course “Using UAVs for emergency situations”.
- ◆ The Center, together with the UN Office for Disaster Risk Reduction, in order to contribute to the achievement of the Global Targets defined by the Sendai Agenda for Disaster Risk Reduction for 2015-2030 and within the framework of the project “Strengthening regional cooperation and facilitating the implementation of the Sendai Agenda for Disaster Risk Reduction in Central Asia » conducted 6 instructional and methodological sessions this year on monitoring the implementation of the Sendai Framework Program for Disaster Risk Reduction for 2015-2030 for representatives of government agencies of Central Asian countries.
- ◆ The Center, together with UNICEF in the Republic of Kazakhstan, carried out a number of activities in 2023 to strengthen the capacity of the non-governmental sector of the Republic of Kazakhstan in the field of basic obligations towards children during humanitarian actions, coordination of actions in emergencies and planning the provision of services in emergencies.
- ◆ With the support of the UN Office for Disaster Risk Reduction, the UN Development Program, Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), on November 10, in Almaty, under the chairmanship of the Kazakh side, a high-level event was held - Regional Forum - Meeting of the Heads of Emergency authorities of Central Asian Countries.
- ◆ On the initiative of the Center, by the decisions of the Regional Forum - Meeting of the Heads of Emergency Authorities of the countries of Central Asia:
 - ✓ The Initiative to create a Digital Atlas of Transboundary Hazards in Central Asian Countries was approved.
 - ✓ Signed an Appeal from the heads of emergency authorities of the Central Asian countries to the UN Secretary-General Antonio Guterres on the issue of creating a Regional Early Warning System and mutual information about the threat and occurrence of transboundary emergencies.
- ◆ At the initiative of the Center, with technical and financial support from the United Nations Office for Disaster Risk Reduction, the United Nations Development Program, Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), two meetings of the Working Group (experts) of the Regional Forum - Meeting of the Heads of Emergency authorities of Central Asian Countries were held:
 - ✓ In October 2023 in Almaty, under the chairmanship of the Kazakh side.
 - ✓ In November 2023 in Almaty, under the chairmanship of the Kazakh side.
- ◆ The Center, by attracting investments in the form of grant funds from donor agencies and international organizations, as an executive agency, in 2023 implemented the following projects in the field of strengthening regional cooperation, disaster risk reduction and emergency prevention:

- ◆ The Center, together with international and non-governmental organizations, scientific institutions, with their technical and financial support, prepared and conducted 27 international events (conferences, forums, seminars, trainings, meetings, conferences) in the field of disaster risk reduction and emergency situations.

1,325 people took part in these events, exchanged experience, gained new knowledge, and improved their skills in the field of disaster risk reduction and emergency situations, including:

- ◆ 851 representatives of government bodies of the Republic of Kazakhstan.
- ◆ 48 representatives of government bodies of the Kyrgyz Republic.
- ◆ 106 representatives of government bodies of Central Asian countries and other states.
- ◆ 36 representatives of scientific institutions and independent experts.
- ◆ 284 representatives of international and non-governmental organizations.

- ◆ 1 meeting of the Center Council was held.
- ◆ 1 meeting of the Regional Scientific and Technical Council was held.

DECEMBER 8: Director of the Center Aubakirov S.G. at the invitation of the Senate of Parliament, spoke at Parliamentary hearings on improving the civil protection system, organized by the Committee on International Relations, Defense and Security of the Senate of Parliament. The meeting participants discussed amendments to the relevant law and voiced their proposals.

The Director of the Center spoke about the research conducted by the Center in order to harmonize national legislation in the field of civil protection, through the convergence of national standards, including the UN glossary. Thus, the director voiced the key terms “disaster”, “disaster risk”, “disaster risk profile”, “resilience”, “risk reduction”, “climate change”, “risk management”, used in the current edition of the Law on Civil Protection, but due to their absence in the conceptual apparatus of the current law and in the draft, during the hearings the director proposed to add to the glossary of the bill.

The result of the parliamentary hearings was a draft Recommendation on improving the civil protection system of the Republic of Kazakhstan, which took into account the proposals of the Director of the Center.
