## **PROTOCOL OF THE MEETING OF WORKING GROUP (EXPERTS) OF THE REGIONAL FORUM-MEETING OF THE HEADS OF EMERGENCY AUTHORITIES OF THE CENTRAL ASIAN COUNTRIES**

*29 July 2021*

*Tashkent, Uzbekistan*

**The Working Group (experts) of the Regional Forum-Meeting of the Heads of Emergency Authorities of the Central Asian countries have considered and discussed issues, submitting for consideration by the Regional Forum-Meeting:**

1. Draft “Strategy for the Development of Cooperation of the Central Asian countries in the field of disaster risk reduction for 2022-2030”.
2. Draft “Regional Disaster Profile of the Central Asian countries”.
3. Draft of the provision “of the Regional Coordination Mechanism on transboundary disaster response”.
4. Draft of the Action Plan (Road Map) for 2022-2023 on the implementation of the Strategy for the Development of Cooperation of the Central Asian countries in the field of disaster risk reduction for 2022-2030.
5. Draft “Concept of the use of unmanned aerial aviation for disaster risk reduction, disaster prevention and response in Central Asian countries”.
6. Draft of the agenda of the Regional Forum-Meeting of the Heads of Emergency Authorities of the Central Asian countries, scheduled to be held in November 2021, Tashkent, Uzbekistan.

**The Working Group (experts) proposes to:**

1. **Approve and submit for consideration to the Regional Forum-Meeting of the Heads of Emergency Authorities of the Central Asian countries:**
  - Draft “Strategy for the Development of Cooperation of the Central Asian countries in the field of disaster risk reduction for 2022-2030”.
2. **Entrust the Secretariat of the Regional Forum-Meeting of the Heads of Emergency Authorities of the Central Asian countries to finalize taking into account the comments and suggestions made and submit for reconciliation by September 5, 2021:**
  - Draft “Regional Disaster Profile of the Central Asian countries”;
  - Draft of the provision “of the Regional Coordination Mechanism on transboundary disaster response”;
  - Draft of Action Plan (Road Map) for 2022-2023 on the implementation of the Strategy for the Development of Cooperation of the Central Asian countries in the field of disaster risk reduction for 2022-2030;
  - Draft “Concept of the use of unmanned aerial aviation for disaster risk reduction, disaster prevention and response in Central Asian countries”;

- Draft of the agenda of the Regional Forum-Meeting of the heads of Emergency Authorities of the Central Asian countries, scheduled to be held in November 2021, Tashkent, Uzbekistan.
3. The Secretariat of the Regional Forum-Meeting of the Heads of Emergency Authorities of the Central Asian countries by September 20, 2021, to organize online meeting of the Working Group (Experts) in order to agree revised drafts of documents, submitted for consideration by the upcoming Regional Forum.
  4. The Emergency Authorities of Central Asian countries to work out the issue of holding the next Regional Forum - Meeting of the Heads of the Emergency Authorities of Central Asian countries in 2022 and by September 15, 2021 send proposals to the Secretariat of the Regional Forum.
