TIMELINE OF MAJOR ACTIVITIES/MEASURES OF MANAGEMENT UNITS, FORCES AND MEANS OF CITY CIVIL PROTECTION FOR ELIMINATION OF EMERGENCIES

I. MAIN GOALS AND PURPOSE OF THE TIMELINE:

Setting up regulations and algorithm of headquarters, employees and working staff of the City Administration, administrative districts, departments, municipal enterprises, organizations and City institutions for emergency situations and ensuring the uninterrupted operation of the provision of essential functions and services in accordance with the tasks assigned to them by regulatory legal acts of the Kyrgyz Republic of the functions, duties and powers by implementing the following basic tasks:

1. Timely detection of the fact of occurrence, and initial approximate determination of the nature and source of origin, nature of origin and manifestation, severity and extent, according to the current classification and criteria for evaluation.
2. Organization and carrying out emergency actions on warning, informing, collection and management staff to ensure arrival of employees and the personnel to their workplaces (offices, control centers, designated areas, emergency zones).
3. Establish a comprehensive management and control measures for the evaluation and analysis of the current situation and take a decision on emergency response and elimination of disaster consequences.
4. Organization and carrying out rescue and other emergency operations aimed at saving people's lives and health, preservation of material and cultural values, localization and suppression of the hotbeds of the damaging effects, prevention of secondary factors, reducing the size of the damage and losses.
5. Ensuring uninterrupted operation of providing essential functions and services aimed at the timely satisfaction of primary essential needs of population, as a housing, water supply, heating, electricity, food, daily necessities, health care, utilities, transportation, information, education and other services, early recovery of the normal life of the population and socio-economic facilities.

II. LEGAL FRAMEWORK OF ELIMINATION OF EMERGENCIES:

1. Heads of relevant organizations, local authorities, and local governments of the territory where disaster occurred depending on the severity, are assigned to manage the operation on elimination of disaster consequences.
2. Head of operation on elimination of disaster consequences issues a decree, which establishes the boundaries of the emergency zones, order of rescue and other emergency operations, actions in the aftermath of an emergency and, if necessary, evacuation and / or relocation of the population to safe areas.
3. Decision of the Head of the operation on elimination of disaster consequences is mandatory for all citizens and organizations in the emergency zone, unless otherwise provided by the legislation of the Kyrgyz Republic.
4. Disaster elimination, depending on the degree of severity is carried out:
 - object (I severity degree) – the forces and resources of organizations, enterprises and institutions regardless of ownership;
 - local (II severity degree) – the forces and means of the local self-government bodies, organizations, enterprises and institutions regardless of ownership;
 - district (III severity degree) - the forces and means of local state administration and local branches of the executive authorities and local self-government district as well as enterprises, organizations and institutions, regardless of ownership;
 - city (IV severity degree) – the forces and means of the City Administration and territorial subdivisions of executive bodies, as well as enterprises, organizations and institutions regardless of ownership.
5. Situation prevailing in a particular area may be recognized as an emergency situation only on the basis of the decision of the Civil Protection Commission at an appropriate level.
6. Disaster is considered as eliminated at the end of the rescue and other emergency operations, after which began a period of reconstruction.
