REGULATION

ON THE REGIONAL REGISTER OF CAPACITIES AND RESOURCES OF CENTRAL ASIAN COUNTRIES

TO CARRY OUT EMERGENCY AND RESCUE OPERATIONS IN THEIR TERRITORIES IN CASE OF AN EMERGENCY

- 1. The Regional Register of capacities and resources of the countries of Central Asia (hereinafter the Regional Register) is created on the basis of proposals received from emergency authorities of the Central Asian countries to include the national emergency response units in to the Regional Register and is formed by the Secretariat of the Regional Forum.
- 2. The regional register is approved by the Decision of the Regional Forum the Meeting with the heads of emergency authorities of the Central Asian countries.
- 3. The Regional Register reflects the number of personnel by specialty, staffing by type of technical means and other necessary data
- 4. The regional register is formed in order to:
 - a) creation at the regional level of an effective mechanism for the implementation of bilateral and multilateral interstate and intergovernmental international treaties (agreements) that have come into force;
 - b) strengthening the readiness of the emergency response units of the Central Asian countries to carry out emergency rescue operations on their territory in case of emergencies;
 - c) identification of the emergency response units to be deployed to the affected country to carry out rescue and other urgent operations in the emergency zone.
- 5. Emergency response units of the Regional Register are used for:
 - emergency response by the capacities and resources of permanent readiness or part of these capacities to emergency situations, that cannot be eliminated by the capacities and resources of one state and require coordinated actions;
 - e) Increasing efforts for liquidation of emergencies, which are carried out by the capacities and resources of one or more countries.
- 6. Organizational and technical measures to strengthen the preparedness of the emergency response units of the Central Asian countries included in the Regional Register are carried out on the basis of programs and plans approved by the decisions of the Regional Forum the Meeting with the heads of emergency departments of Central Asian countries.
- 7. The regional register is developed in tabular form, which reflects the name, location of the emergency rescue units, the number of personnel by specialty and staffing by type of technical means and other necessary data.
- 8. The involvement capacities and resources of the Regional Register is carried out in accordance with the request for assistance in the manner established by the bilateral and multilateral international treaties (agreements) that have come into force.
- 9. The original version of the Regional Register is kept at the Secretariat of the Regional Forum the Meeting with the Heads of Emergency Agencies of Central Asian Countries. Certified copies of the Regional Register are sent to Emergency Authorities of the Central Asian countries.
