#### CONCEPT

# OF THE REGIONAL REGISTRY OF EXPERTS IN THE FIELD OF CIVIL PROTECTION / DEFENSE, DISASTER RISK REDUCTION, PREVENTION AND ELIMINATION OF EMERGENCY SITUATIONS

## The Regional Registry of experts in the field of civil protection / defense, disaster risk reduction, prevention and elimination of emergency situations is developed in order to:

- strengthen organizational and practical measures to engage national and international experts for implementation of regional scientific-technical programs and projects, conducting analytical studies, developing methodological documents and materials, developing scientific and technical guidance on the application of science, technology and innovation in the field of disaster risk reduction, prevention and liquidation of emergency situations of large-scale and cross-border nature;
- improvement of the effectiveness of management decisions taken by authorized bodies, international and non-governmental organizations in the field of civil protection, disaster risk reduction, prevention and liquidation of emergency situations in Central Asian countries, through the extensive use of scientific and practical potential of leading scientists, specialists and experts during expert-analytical research;
- attraction of the leading scientists and specialists to conduct objective and competent expertanalytical research in the interests of the formation and implementation of research, development, technological and innovation projects and programs at the regional and sectoral levels;
- provision of interested authorized state bodies, international and non-governmental organizations allocating funds for the implementation of various scientific and technical programs and projects, with opportunities to involve experts of the Regional Registry to conduct expert-analytical activities;
- regulation of statistics, analysis and monitoring of the results of expert-analytical activities of experts of the Regional Registry;
- development of proposals and implementation of measures to improve the efficiency of expertanalytical activities in the interests of authorized state bodies, international and non-governmental organizations in the field of civil protection, disaster risk reduction, prevention and liquidation of emergency situations.

The formation of the Regional Registry of Experts is carried out by the Center for Emergency Situations and Disaster Risk Reduction on the basis of the recommendations of state bodies and international and non-governmental organizations, research and educational institutions in coordination with emergency authorities, as well as the analysis of the experience of scientific, practical and expert activities of experts who submitted their candidates for entry into the Regional Registry of Experts.

Organizational and practical issues of formation and use of the Registry are implemented based on the Regulation on **The Regional Registry of experts in the field of civil protection / defense, disaster risk reduction, prevention and elimination of emergency situations,** which is approved by the Regional Forum – Meeting of the Heads of Emergency Authorities of Central Asian countries.
