## REGULATION

ON THE REGIONAL REGISTRY OF EXPERTS IN THE FIELD OF CIVIL PROTECTION / DEFENSE, DISASTER RISK REDUCTION, PREVENTION AND LIQUIDATION OF EMERGENCY SITUATIONS

Formed by Decision of the Regional Forum - Meeting of Heads of Emergency Authorities of Central Asian countries. Protocol dated June 12, 2019

## REGULATION

## on Regional Registry of Experts in the field of civil protection / defense, disaster risk reduction, prevention and liquidation of emergency situations

- 1. Regional Registry of Experts in the field of civil protection / defense, disaster risk reduction, prevention and liquidation of emergency situations (*Hereinafter the Regional Registry of Experts*) is being formed in order to strengthen organizational and practical measures to engage national and international experts for implementation of regional scientific-technical programs and projects, conducting analytical studies, developing methodological documents and materials, developing scientific and technical guidance on the application of science, technology and innovation in the field of disaster risk reduction, prevention and liquidation of emergency situations of large-scale and cross-border nature.
- 2. The Regional Registry of Experts is being composed of national and international experts engaged in expert-analytical activities in the field of civil protection/defense, disaster risk reduction, prevention and liquidation of emergency situations, fire, seismic, environmental, hydrological, hydrometeorological, radiation safety and other overlapping areas related to civil protection/defense, disaster risk reduction, prevention and liquidation of emergency situations, prevention and liquidation.
- 3. The Regional Registry of Experts is designed to solve the following main tasks:
  - a) improvement of the effectiveness of management decisions taken by authorized bodies, international and non-governmental organizations in the field of civil protection, disaster risk reduction, prevention and liquidation of emergency situations in Central Asian countries, through the extensive use of scientific and practical potential of leading scientists, specialists and experts during expert-analytical research;
  - b) attraction of the leading scientists and specialists to conduct objective and competent expertanalytical research in the interests of the formation and implementation of research, development, technological and innovation projects and programs at the regional and sectoral levels;
  - c) provision of interested authorized state bodies, international and non-governmental organizations allocating funds for the implementation of various scientific and technical programs and projects, with opportunities to involve experts of the Regional Registry to conduct expert-analytical activities;
  - d) regulation of statistics, analysis and monitoring of the results of expert-analytical activities of experts of the Regional Registry;
  - e) development of proposals and implementation of measures to improve the efficiency of expert-analytical activities in the interests of authorized state bodies, international and non-governmental organizations in the field of civil protection, disaster risk reduction, prevention and liquidation of emergency situations.
- 4. The formation of the Regional Registry of Experts is carried out by the Secretariat of the Regional Forum –Meeting of Heads of Emergency Authorities of Central Asian countries on the basis of the recommendations of state bodies and international and non-governmental organizations, research and educational institutions in coordination with emergency authorities, as well as the analysis of the experience of scientific, practical and expert activities of experts who submitted their candidates for entry into the Regional Registry of Experts.
- 5. The Regional Registry of Experts is an open and accessible document for all interested parties, which contains: surnames, first names, patronymic names, specialization, contact information and other data of experts in brief, as well as their photos.
- 6. More detailed data (resume) of experts, their results and other confidential information will be requested and provided to interested parties by the Secretariat of the Regional Forum Meeting of Heads of Emergency Authorities of Central Asian countries, upon prior agreement with the experts.
