**General Provisions:**

The Regional Forum-Meeting of Heads of Emergency Management Authorities of Central Asian countries was established in accordance with the outcome documents adopted at the following regional ministerial conferences and meetings:

- the Regional Ministerial Conference “Regional Cooperation on Disaster Risk Reduction in Central Asia”, held on 16-18 October 2013 in Bishkek;
- the Second Regional Ministerial Conference of Emergency Management Authorities of Central Asian countries, held within the framework of the Central Asia + Japan Dialogue on 18-19 September 2014 in Bishkek;
- the Regional Ministerial Conference of Central Asia and the South Caucasus on Disaster Risk Reduction, held on 29-30 January 2015 in Bishkek;
- the Regional Ministerial Conference of Central Asian countries on Emergency Prevention and Response to Emergencies and Natural Disasters, held on 24-25 November 2015 in Ashgabat, Turkmenistan;
- the Regional Meeting of Heads of Emergency Management Authorities of Central Asian countries on Disaster Risk Reduction, held on 31 March 2017 in Dushanbe, Tajikistan.

**Functions:**

The Regional Forum performs the following functions:

- facilitating the implementation of key areas for the development of regional cooperation in the field of disaster risk reduction and the prevention of and response to emergencies;
- assisting in strengthening capacities for disaster risk reduction, prevention, and response to emergencies at the regional and national levels;
- cooperating with international, governmental, and non-governmental organizations of other countries for the purpose of studying best practices and exchanging experience in the field of the prevention of and response to emergencies;
- enhancing the professional qualifications of experts and specialists of emergency authorities by facilitating the organization and conduct of experience-sharing activities, trainings, training courses, exercises, and other events;
- developing proposals and recommendations for the consideration and harmonization of analytical and methodological materials, including the use of international terminology;
- supporting scientific and technical programmes aimed at the prevention of emergencies and the study of their causes and consequences.

**Composition and Rights:**

The composition of the Regional Forum includes, from each country, the head of the state authority authorized in the field of the prevention of and response to emergencies.

The Regional Forum is empowered to adopt decisions within the scope of its competence. In the event that the head of a state authority authorized in the field of the prevention of and response to emergencies is unable to participate in a meeting for valid reasons, his or her functions may be temporarily delegated to an authorized representative of the respective country, with due notification to the Chair of the Regional Forum.

**Working Bodies of the Regional Forum:**

The Secretariat of the Regional Forum shall be the Centre for Emergency Situations and Disaster Risk Reduction, located in the city of Almaty.

The working body of the Regional Forum shall be the Working Group of the Regional Forum.

**Chairmanship:**

The Chairmanship of the Regional Forum shall be exercised by the head of the state authority authorized in the field of the prevention of and response to emergencies representing the country in whose territory the next meeting of the Regional Forum is held.

**Organization of Activities:**

The Regional Forum organizes its activities on the basis of Action Plans for the implementation of the Framework for Strengthening Regional Cooperation among Central Asian countries in the field of disaster risk reduction and the prevention of and response to emergencies.

Meetings of the Regional Forum shall be held at least once every two years.

In the event that it is not possible to hold a scheduled meeting of the Regional Forum, the presiding party shall inform the participating countries through diplomatic channels.

The draft agenda and proposals regarding the dates of the meeting shall be circulated for coordination to the participating countries of the Regional Forum by the presiding party no later than three months prior to the meeting.

Extraordinary meetings of the Regional Forum may be convened at the proposal of one or more participating countries. In such cases, the initiating party shall submit a written proposal to the Chair of the Regional Forum, indicating the purpose of convening the extraordinary meeting, the proposed date and venue, as well as the proposed agenda.

Decisions of the Regional Forum shall be adopted by consensus.

Following each meeting of the Regional Forum, a Protocol shall be drawn up.

Expenses related to the participation of national delegations shall be borne by the sending party or covered through financial support from international organizations.

The host State shall ensure the necessary conditions for holding meetings of the Regional Forum.

The working language of the Regional Forum shall be Russian.

**Representatives of the government authorities of Kazakhstan, Kyrgyzstan, Tajikistan, and Uzbekistan, the Emergency Situations and Disaster Risk Reduction Centre in Almaty, and international organizations participated in the Working Group Meeting of the Regional Forum-Meeting of Heads of Emergency Management Authorities of Central Asian countries.**

1. The participants reviewed and discussed the draft documents listed below and decided that the CESDRR would revise them taking into account the comments and proposals expressed and submit them for coordination through diplomatic channels **by 15 September 2017**.
  - a) Framework for Strengthening Regional Cooperation among Central Asian countries in the field of disaster risk reduction, emergency prevention, and emergency response;
  - b) Regulations on the Regional Forum-Meeting of Heads of State Authorities Authorized in the Field of Emergency Prevention and Response of Central Asian countries;
  - c) Action Plan for the Implementation of the Framework for Strengthening Regional Cooperation in the field of disaster risk reduction, emergency prevention, and emergency response in Central Asian countries for 2018-2020;
  - d) Concept for the Establishment of a “Regional Register of National and International Specialists and Experts” in the fields of seismic, environmental, fire, radiation, industrial, hydrogeological, and other areas of safety;
  - e) Concept for the Establishment of a “Regional Scientific and Technical Council on Emergency Situations” (RSTC on ES);
  - f) Concept for the Establishment of a “Regional Register of Forces and Assets of Central Asian countries” for the purpose of conducting emergency rescue operations within their territories in the event of large-scale and transboundary emergency situations.
2. The participants proposed that the next sessions of the Regional Forum-Meeting of Heads of State Authorities Authorized in the Field of Emergency Prevention and Response of Central Asian countries, held within the framework of the Central Asia plus Japan Dialogue, be convened in **2018 in the Republic of Kazakhstan**, hosted by the Emergency Situations and Disaster Risk Reduction Centre in Almaty, and in **2019 in the Kyrgyz Republic**.
3. They also agreed to hold a Working Group Meeting in **the first half of 2018** in order to further refine the above-mentioned draft documents prior to their submission for consideration by the Regional Forum-Meeting of Heads of State Authorities Authorized in the Field of Emergency Prevention and Response of Central Asian countries within the framework of the Central Asia plus Japan Dialogue.
4. Discussed and proposed to assign:
  - to grant the Emergency Situations and Disaster Risk Reduction Centre in Almaty the status of Secretariat of the Regional Forum-Meeting of Heads of State Authorities Authorized in the Field of Emergency Prevention and Response of Central Asian countries;
  - to grant the Working Group the status of the working body of the Regional Forum-Meeting of Heads of State Authorities Authorized in the Field of Emergency Prevention and Response of Central Asian countries.
5. They request the State authorities authorized in the field of emergency prevention and response of Central Asian countries to review and submit, **by 1 December 2017**, their proposals on the draft documents prepared by the participants of the Working Group Meeting to the Emergency Situations and Disaster Risk Reduction Centre in Almaty for consolidation and subsequent submission for consideration by the next Regional Forum-Meeting of Heads of State Authorities Authorized in the Field of Emergency Prevention and Response of Central Asian countries, held within the framework of the Central Asia plus Japan Dialogue.
6. They express their appreciation and gratitude to the Government of Japan and the United Nations Development Programme in the Kyrgyz Republic for the technical and financial support provided for activities aimed at strengthening regional cooperation among emergency management authorities of Central Asian countries in the field of disaster risk reduction, emergency prevention, and emergency response within the framework of the Central Asia plus Japan Dialogue, as well as to the Emergency Situations and Disaster Risk Reduction Centre in Almaty for the organization and hosting of the Working Group Meeting held on 3-4 August 2017.

**FINAL DOCUMENT - PROTOCOL**

**We, the heads of delegations and representatives of the emergency departments of the Republic of Kazakhstan, the Republic of Kyrgyzstan, the Republic of Tajikistan, Turkmenistan, the Republic of Uzbekistan - participants of the Regional Forum - Meetings of the heads of the Emergency Departments of the Central Asian countries,**

Taking into account,

- The region, home to approximately 80 million people, is exposed to virtually all types of natural and man-made disasters, including earthquakes, floods, landslides, mudflows, debris flows, avalanches, droughts, epidemics, dam failures, and hazardous substance emissions,
- Existing trends in the countries of the region towards an increase in the scale of adverse impacts of natural disasters, accidents, and catastrophes, as well as heightened human vulnerability to natural and technological hazards, hinder the more effective implementation of the sustainable development strategies, programmes, and plans,
- The existence of risks of larger and transboundary emergencies, the consequences of which cannot always be addressed solely by the capacity and resources of a single country
- The necessity of further enhancing, at the regional level, mechanisms for the implementation of bilateral and multilateral intergovernmental agreements (treaties) in the field of disaster prevention and emergency response, as well as relevant United Nations strategic and programmatic documents on sustainable development, disaster risk reduction (DRR) and emergency management, including,
  - The Agreement between the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan, and the Republic of Uzbekistan on Cooperation in the Field of Prevention and Response to Emergencies (Cholpon-Ata, 17 July 1998);
  - the 2030 Agenda for Sustainable Development (Sustainable Development Goals - SDGs), the Sendai Framework for Disaster Risk Reduction 2015-2030.

**Determined to continue efforts to implement the outcome documents of,**

- the Regional Ministerial Conference “Regional Cooperation on Disaster Risk Reduction in Central Asia”, held on 16-18 October 2013 in Bishkek,
- the second Regional Ministerial Conference of Emergency Authorities of Central Asian countries within the framework of the “Central Asia plus Japan” Dialogue, held on 18-19 September 2014 in Bishkek,
- the Regional Ministerial Conference of Central Asian and South Caucasus countries on Disaster Risk Reduction, within the framework of the “Central Asia plus Japan” Dialogue, held on 29-30 January 2015 in Bishkek,
- the Regional Ministerial Conference of Central Asian countries on the prevention of and response to emergencies, within the framework of the “Central Asia plus Japan” Dialogue, held on 24-25 November 2015 in Ashgabat, Turkmenistan,
- of the Regional Meeting of Heads of Emergency Authorities of Central Asian countries, held on 30-31 March 2017 in Dushanbe, Tajikistan.

**With a view to undertaking further actions to develop and strengthen regional and international cooperation in the field of disaster risk reduction, as well as the prevention of and response to emergencies, particularly those of a large-scale and transboundary nature,**

**Approved:**

1. Terms of Reference of the Regional Forum - Meeting of Heads of Emergency Authorities of Central Asian countries.
2. Framework for Strengthening Regional Cooperation among Central Asian Countries in the Field of Disaster Risk Reduction and the Prevention of and Response to Emergencies.
3. Action Plan for the Implementation of the Framework for Strengthening Regional Cooperation in the Field of Disaster Risk Reduction and the Prevention of and Response to Emergencies of Central Asian Countries for 2018-2020.

The draft Joint Statement of the Heads of Emergency Authorities of Central Asian countries on strengthening regional cooperation in the field of disaster risk reduction and the prevention of and response to emergencies, to be presented by the delegation of the Republic of Kazakhstan at the Asian Ministerial Conference on Disaster Risk Reduction, 2018, Ulaanbaatar, Mongolia.

**FINAL DOCUMENT - PROTOCOL**

**The Working Group of the Regional Forum–Meeting of Heads of Emergency Management Authorities of Central Asian countries, with the participation of representatives of the Secretariat of the Regional Forum, reviewed and discussed the issues submitted for consideration by the session of the Regional Forum, including:**

1. Draft Regulations on the Regional Scientific and Technical Council on Emergency Situations.
2. Draft Regulations on the Regional Register of Experts in the field of civil protection/civil defence, disaster risk reduction, emergency prevention, and emergency response.
3. Draft Regulations on the Regional Register of Forces and Assets of Central Asian countries for the purpose of conducting emergency rescue operations within their territories in the event of emergency situations.
4. Draft Regulations on the Regional Coordination Mechanism for Emergency Response.
5. Draft Action Plan (Roadmap) for the implementation of the Framework for Strengthening Regional Cooperation among Central Asian countries in the field of disaster risk reduction, emergency prevention, and emergency response for 2019–2021.

The Working Group expressed its readiness to support and facilitate the implementation of regional programmes and projects aimed at strengthening disaster risk management in Central Asia, financed by donor agencies and international organizations.

**Having discussed the issues submitted for consideration by the session of the Regional Forum, the Working Group proposes:**

1. To establish a Regional Scientific and Technical Council on Emergency Situations as a public expert and advisory body of the Regional Forum–Meeting of Heads of Emergency Management Authorities of Central Asian countries, and to mandate the Secretariat of the Regional Forum to organize its activities in accordance with the approved Regulations.

**For this purpose:**

- Emergency management authorities of Central Asian countries are requested to submit to the Secretariat of the Regional Forum, by 1 September 2019, nominations of national specialists and experts for inclusion in the composition of the Regional Scientific and Technical Council on Emergency Situations;

- The Secretariat of the Regional Forum shall provide organizational and technical support to the activities of the Regional Scientific and Technical Council on Emergency Situations within the framework of the implementation of regional programmes and projects in the field of disaster risk reduction and emergency management, and shall facilitate the convening of the first (organizational) meeting of the Council in November 2019.

2. To establish a Regional Register of Experts in the field of civil protection/civil defence, disaster risk reduction, emergency prevention, and emergency response. The Secretariat of the Regional Forum is mandated to organize the work related to the establishment of the Regional Register of Experts on Emergency Situations and to engage national and international experts in the implementation of regional scientific and technical programmes and projects in the field of disaster risk reduction and emergency management.
3. To establish a Regional Register of Forces and Assets of Central Asian countries for the purpose of conducting emergency rescue operations within their territories in the event of emergency situations. For this purpose, the emergency management authorities of Central Asian countries are requested to submit to the Secretariat of the Regional Forum, by 1 September 2019, a list of national permanent-readiness emergency rescue units to be included in the Regional Register of Forces and Assets of Central Asian countries, in accordance with Annex 1.
4. To take as a basis the developed Draft Regulations on the Regional Coordination Mechanism for Emergency Response.

**For this purpose:**

- The Secretariat of the Regional Forum shall revise the draft Regulations, taking into account comments and proposals, and submit them for coordination to the emergency management authorities of Central Asian countries by 20 August 2019;
- The agreed draft Regulations shall be submitted for consideration by the next Regional Forum-Meeting of Heads of Emergency Management Authorities of Central Asian countries.

5. To mandate the Secretariat of the Regional Forum to submit for consideration the issue of conducting a regional exercise of the emergency management authorities of Central Asian countries on the deployment of forces and assets for emergency rescue operations in the event of transboundary emergency situations, following the approval of the Regulations on the Regional Coordination Mechanism for Emergency Response.
6. To mandate the Secretariat of the Regional Forum to develop a draft concept for the use (joint use of flight data) of unmanned aerial vehicles by the emergency management authorities of Central Asian countries.
7. To approve the Action Plan (Roadmap) for the implementation of the Framework for Strengthening Regional Cooperation among Central Asian countries in the field of disaster risk reduction, emergency prevention, and emergency response for 2019-2021.
8. To consider the organization of the next Regional Forum-Meeting of Heads of Emergency Management Authorities of Central Asian countries in 2020 (or 2021) in the Republic of Uzbekistan.
9. To encourage the emergency management authorities of Central Asian countries to support and facilitate the implementation of regional programmes and projects on disaster risk management in Central Asia, financed by donor agencies and international organizations.

**We, the Heads of Delegations of the emergency management authorities of the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan, Turkmenistan, and the Republic of Uzbekistan, participants in the Regional Forum–Meeting of Heads of Emergency Management Authorities of Central Asian countries,**

**recognizing** that the countries of the region are currently facing challenges related to the increasing scale of the adverse impacts of natural disasters, accidents, and catastrophes, as well as the growing vulnerability of populations to natural and technological hazards, which are further exacerbated by emerging challenges, including climate change,

**taking into account** the existence of risks of emergency situations that cannot always be effectively addressed by the forces and assets of a single country,

**acknowledging** that the strengthening of regional and international cooperation in the field of disaster risk reduction, emergency prevention, and emergency response will contribute to enhancing resilience, improving well-being, and strengthening the security of Central Asian countries,

**supporting** the efforts of the United Nations and other international and non-governmental organizations in the field of disaster risk reduction and the provision of international assistance in emergency situations, guided by the 2030 Agenda for Sustainable Development and the priorities and principles of the Sendai Framework for Disaster Risk Reduction 2015-2030,

**highly appreciating** the contribution of the Government of Japan and the United Nations Development Programme to the strengthening of regional cooperation among Central Asian countries within the framework of the Central Asia plus Japan Dialogue,

with a view to taking further measures to develop and strengthen regional and international cooperation, to improve the institutional foundations for the implementation of existing bilateral and multilateral intergovernmental and international treaties (agreements), and to establish sustainable mechanisms for disaster risk reduction and enhanced preparedness for potential emergency situations,

**Approved:**

1. The Regulations on the Regional Scientific and Technical Council on Emergency Situations.
2. The Regulations on the Regional Register of Experts in the field of civil protection/civil defence, disaster risk reduction, emergency prevention, and emergency response.
3. The Regulations on the Regional Register of Forces and Assets of Central Asian countries for the purpose of conducting emergency rescue operations within their territories in the event of emergency situations.
4. The Action Plan (Roadmap) for the implementation of the Framework for Strengthening Regional Cooperation among Central Asian countries in the field of disaster risk reduction, emergency prevention, and emergency response for 2019-2021.

**Decided as follows:**

1. To establish a Regional Scientific and Technical Council on Emergency Situations as a public expert and advisory body of the Regional Forum–Meeting of Heads of Emergency Management Authorities of Central Asian countries, and to mandate the Secretariat of the Regional Forum to organize its activities in accordance with the approved Regulations.

**For this purpose:**

- Emergency management authorities of Central Asian countries shall submit to the Secretariat of the Regional Forum, by 1 September 2019, nominations of national specialists and experts for inclusion in the Regional Scientific and Technical Council on Emergency Situations;
- The Secretariat of the Regional Forum shall provide organizational and technical support to the activities of the Regional Scientific and Technical Council on Emergency Situations within the framework of the implementation of regional programmes and projects in the field of disaster risk reduction and emergency management, and shall facilitate the convening of the first (organizational) meeting of the Council in November 2019.

2. To establish a Regional Register of Experts in the field of civil protection/civil defence, disaster risk reduction, emergency prevention, and emergency response.

**For this purpose**, the Secretariat of the Regional Forum shall organize the relevant work related to the establishment of the Regional Register of Experts on Emergency Situations and engage national and international experts in the implementation of regional scientific and technical programmes and projects in the field of disaster risk reduction and emergency management.

3. To establish a Regional Register of Forces and Assets of Central Asian countries for the purpose of conducting emergency rescue operations within their territories in the event of emergency situations.

**For this purpose**, the emergency management authorities of Central Asian countries shall submit to the Secretariat of the Regional Forum, by 1 September 2019, a list of national permanent-readiness emergency rescue units to be included in the Regional Register of Forces and Assets of Central Asian countries, in accordance with Annex 1.

4. To mandate the Secretariat of the Regional Forum to develop a draft concept for the use (including joint use of flight data) of unmanned aerial vehicles by the emergency management authorities of Central Asian countries.
5. To approve the Action Plan (Roadmap) for the implementation of the Framework for Strengthening Regional Cooperation among Central Asian countries in the field of disaster risk reduction, emergency prevention, and emergency response for 2019-2021.
6. To consider the organization of the next Regional Forum-Meeting of Heads of Emergency Management Authorities of Central Asian countries in 2020 (or 2021) in the Republic of Uzbekistan.
7. To encourage the emergency management authorities of Central Asian countries to support and facilitate the implementation of regional programmes and projects on disaster risk management in Central Asia, financed by donor agencies and international organizations.

7. To take note of the information presented and to provide full support and assistance in the implementation of the following regional initiatives, programmes, and projects in the field of disaster risk reduction and climate change adaptation:

- the UNDRR/EU initiative “Enhancing Disaster Resilience and Accelerating the Implementation of the Sendai Framework for Disaster Risk Reduction in Central Asia”,

**We, the Heads of Delegations of the emergency management authorities of the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan, Turkmenistan, and the Republic of Uzbekistan, participants in the Regional Forum-Meeting of Heads of Emergency Management Authorities of Central Asian countries,**

**Recognizing** that the countries of the region continue to face challenges related to the increasing adverse impacts of natural disasters, accidents, and catastrophes, as well as the growing vulnerability of populations to natural and technological hazards, exacerbated by emerging challenges, including climate change and bio-social hazards, among others,

**Taking into account** the vulnerability of the Central Asia region to the impacts of climate change, the risks of large-scale and transboundary emergency situations, the consequences of which cannot always be addressed solely by the forces and assets of a single country, and the need to introduce modern disaster risk management approaches, including the use of innovative technologies,

**Acknowledging** that the strengthening of regional and international cooperation in the field of disaster risk reduction, preparedness, prevention, and emergency response will contribute to enhancing resilience, improving well-being, and strengthening the security of Central Asian countries,

**Noting the transition** from awareness of exposure to transboundary risks to the readiness of the heads of emergency management authorities of Central Asian countries to undertake practical actions aimed at establishing sustainable mechanisms of regional cooperation in the areas of prevention, preparedness, response, and recovery from transboundary emergency situations, as well as at integrating post-emergency recovery processes into the regulatory and legal frameworks of the countries of the region,

**We, the Heads of Delegations of the emergency management authorities of the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan, Turkmenistan, and the Republic of Uzbekistan, participants in the Regional Forum-Meeting of Heads of Emergency Management Authorities of Central Asian countries,**

**Taking into account** the risks of large-scale and transboundary emergency situations, the consequences of which cannot always be addressed solely by the forces and assets of a single country,

**Acknowledging** that the strengthening of regional and international cooperation in the field of disaster risk reduction, climate change, and the prevention and mitigation of the consequences of emergency situations will contribute to enhancing resilience, improving the well-being of populations, and strengthening the security of Central Asian countries,

**Supporting** the efforts of the United Nations and other international organizations in the field of disaster risk reduction, climate change, and the provision of international assistance in emergency situations, guided by the 2030 Agenda for Sustainable Development, the Paris Agreement on Climate Change, and the priorities and principles of the Sendai Framework for Disaster Risk Reduction 2015-2030,

**Intending to continue the implementation of the previously adopted outcome documents, namely:**

- the Regional Ministerial Conference of Central Asian countries on Emergency Prevention and Response, held on 24-25 November 2015 in Ashgabat, Turkmenistan (Ashgabat Declaration);
- the Regional Meeting of Heads of Emergency Management Authorities of Central Asian countries on Disaster Risk Reduction, held on 31 March 2017 in Dushanbe, Republic of Tajikistan (Dushanbe Declaration);
- the Regional Forum-Meetings of Heads of Emergency Management Authorities of Central Asian countries, held in 2018 in the Republic of Kazakhstan, 2019 in the Kyrgyz Republic, 2021 in the Republic of Uzbekistan, 2022 in the Republic of Tajikistan, 2023 in the Republic of Kazakhstan, and 2024 in the Kyrgyz Republic,

**With a view to ensuring coordination, alignment of actions, and decision-making with regard to:**

- strengthening regional cooperation in the field of disaster risk reduction, climate change, and emergency management, and the implementation of the Sendai Framework for Disaster Risk Reduction up to 2030;
- reducing the vulnerability of Central Asian countries to disaster and climate risks through the enhancement of early warning systems and the strengthening of resilience to hazardous natural and climate-related risks, within the framework of the United Nations global initiative “Early Warnings for All”;
- enhancing the resilience of pilot major cities in Central Asian countries to disaster and climate risks, within the framework of the UNDP Regional Project “Enhancing Urban Resilience to Disaster and Climate Risks in Central Asia” and the United Nations global initiative “Making Cities Resilient 2030 (MCR2030)”;
- improving mechanisms, rules, and procedures for mutual exchange of hydrometeorological information on the threat or occurrence of transboundary emergency situations, within the framework of the GIZ Regional Programme “Climate Risk Management in Central Asia”,

**Approved:**

1. Protocol of Intent on Enhancing the Resilience of Cities of Central Asian countries to disaster risks and climate change.
2. Protocol of Intent on Improving Early Warning Systems and Information-Sharing Mechanisms on the threat or occurrence of emergency situations.
3. Concept for the Establishment of a Regional Early Warning System for Hydrological Disasters in pilot transboundary river basins of Central Asian countries.
4. Roadmap for the Establishment of a Regional Early Warning System for Hydrological Disasters in pilot transboundary river basins of Central Asian countries.

**Decided as follows:**

1. To support the initiatives of the UNECE on digital monitoring and strengthening the safety of small dams in Central Asia based on GIS technologies (RS/GIS), as well as on the development of a Joint Emergency Action Plan for the Syr Darya River Basin.
2. To consider the possibility of using the facilities of the National Rescue Training Centre of the Committee for Emergency Situations and Civil Defence under the Government of the Republic of Tajikistan for the organization of regional training exercises for rescue personnel.
3. To develop measures for the establishment of a Regional Central Asian Centre for the Coordination of Humanitarian Assistance in the event of large-scale or transboundary emergency situations.
4. To take note of the information presented and to provide full support and assistance in the implementation of the following regional initiatives, programmes, and projects in the field of:
  - development of disaster risk profiles of pilot cities in Central Asian countries and the integration of disaster risk reduction and climate change measures into the socio-economic development plans of the cities of Petropavlovsk (Republic of Kazakhstan), Osh (Kyrgyz Republic), Dushanbe (Republic of Tajikistan), Ashgabat (Turkmenistan), and Namangan (Republic of Uzbekistan);
  - strengthening cooperation, improving financing, and mobilizing investments to enhance early warning systems at the national and regional levels, as reflected in the recommendations of the Regional Partners' Meeting on Strengthening Early Warning Systems and the implementation of the "Early Warnings for All" (EW4All) initiative in Central Asia;
  - climate risk assessments conducted by the International Federation of Red Cross and Red Crescent Societies (IFRC) in Kyrgyzstan and Tajikistan;
  - establishment of a monitoring and information system for the implementation of the National Disaster Risk Reduction Strategy and the strengthening of the capacity of the National Platform for Disaster Risk Reduction in Tajikistan, within the framework of the UNDRR and Government of Switzerland project "Enhancing Disaster and Climate Resilience in Tajikistan", as a good practice for replication in other Central Asian countries;
  - improvement of the regulatory and legal framework for disaster risk management in Tajikistan in accordance with the requirements of International Disaster Response Law (IDRL);
  - further refinement of the draft articles on the "Protection of Persons in the Event of Disasters", based on recommendations prepared by the IFRC;
  - strengthening institutional capacity for disaster and crisis preparedness and response in Central Asia, based on partnerships between the IFRC, the Emergency Situations and Disaster Risk Reduction Center (CESDRR), and the National Red Crescent Societies of Central Asian countries;
  - development of regional cooperation in disaster risk reduction and climate resilience, implemented by the World Food Programme (WFP) and the Government of Switzerland, including the promotion of effective disaster risk reduction approaches, *inter alia* through enhanced cooperation between the Ministry of Emergency Situations of the Kyrgyz Republic and the Committee for Emergency Situations and Civil Defence under the Government of the Republic of Tajikistan;
  - enhancement of water and energy security, climate resilience, and economic development within the framework of the World Bank Central Asia Water and Energy Program (CAWEP).
5. To mandate the Emergency Situations and Disaster Risk Reduction Center (CESDRR), in its capacity as the Secretariat of the Regional Forum-Meeting of Heads of Emergency Management Authorities of Central Asian countries, to:
  - coordinate activities for the implementation of the UNDP Regional Project "Enhancing Urban Resilience to Disaster and Climate Risks in Central Asia", including measures to establish a "Coalition of Resilient Cities of Central Asian countries";
  - implement measures for the establishment of a regional early warning system in pilot transboundary river basins of Central Asian countries, within the framework of the GIZ Regional Programme "Climate Risk Management in Central Asia (CRM CA)";

- coordinate measures for the establishment of a regional early warning system for hydrological disasters in pilot transboundary river basins, based on the Roadmap approved by this Protocol, as well as through the initiation, development, promotion, and implementation of joint programmes and projects, with technical and financial support from donor agencies, international and non-governmental organizations, scientific and research institutions, and the private sector.

6. To propose that the Turkmen side consider hosting the next Regional Forum-Meeting of Heads of Emergency Management Authorities of Central Asian countries in 2026 in Turkmenistan, and to inform the Secretariat of the Regional Forum-Meeting of Heads of Emergency Management Authorities of Central Asian countries of the decision taken by 30 November 2025.
